



### 5.4 Measurement Procedure

1. The EUT was placed on a table, which is 0.8m above ground plane.
2. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
3. Repeat above procedures until all frequency measured was complete.

The maximised peak emissions from the EUT was scanned and measured for both the Live and Neutral Lines. Quasi-peak & average measurements were performed if peak emissions were within 6dB of the average limit line.

## 6 Periodic Operation

To calculate the actual field intensity, the duty cycle correction factor in decibel is needed for later use and can be obtained from following conversion

Duty Cycle(%)=Total On interval in a complete pulse train/ Length of a complete pulse train \* %






The test setup for emission measurement below 30MHz

#### **7.4 Test Procedure**

1. The EUT is placed on a turntable, which is 0.8m or 1.5m above ground plane.
2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna, which is moved from 1m to 4m to find out the maximum emissions. The spectrum was investigated from the lowest radio frequency signal generated in the device, without going below 9 kHz, up to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until the measurements for all frequencies are complete.
7. The radiation measurements are tested under 3-axes(X,Y,Z) position(X denotes lying on the table, Y denotes side stand and Z denotes vertical stand), After pre-test, It was found that the worse radiation emission was get at the X position. So the data shown was the X position only.
8. The test above 1GHz must be use the fully anechoic room, and the test below 1GHz use the half anechoic room



## 7.5 Summary of Test Results

### Test Frequency: Below 30MHz

The amplitude of spurious emissions from the radiator which are attenuated more than 20dB below the limit need not be reported.

### Test Frequency: 30MHz ~ 5GHz

All applicable test modes have been tested with TX mode(433.92MHz)






## 9 Antenna Requirement

From 30MHz-1000MHz








