The dinosaur is equipped with one non replaceable 3.7V rechargeable lithium battery, and the remote control uses two 1.5V AA batteries.

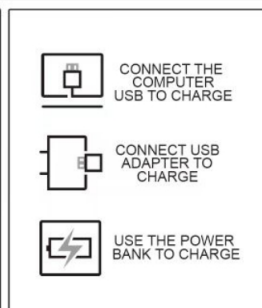
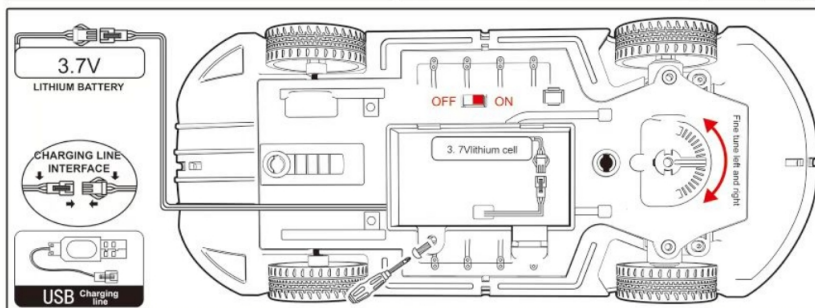
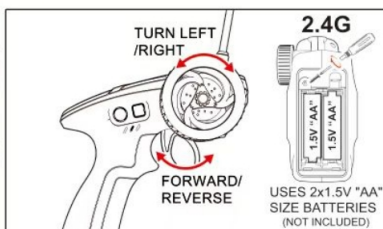
