





HOW TO CHARGE THE BATTERY

SMART BAND*



Plug the USB type C cable into the device. When fully charged, the LED displays a green light (red indicates it is still charging)



Before the first use, charge MATIV mat for at least 5 hours. For the band, charge for 1 hour.



Leaving MATIV on 0% battery or charging for too long may reduce battery life.




CONNECTING MATIV




Lay open MATIV in an area that allows the mat to be rolled out completely.



At first, the mat may not be rolled out easily. Roll it up on facing the opposite side to help flatten it.





MATIV may not function properly on an uneven or cushiony plain.





Open the App and connect MATIV with the smart band*.



Select the MATIV device that is on the App.



The mat will be connected automatically after connecting it for the first time.




press and hold the circular button for 5 seconds and check that the LED is white. Then, try connecting again.

DEVICE STATUS

Fully charged	Green
Charging	Red (Blink)
Exercise	Blue (Blink)
Calibration	Purple (Blink)
Reset	White
Update	Yellow

If MATIV is not detected in the App, press and hold the button on the side of the bar (on the mat) for 5 seconds and check that the LED is white. Then, try connecting again.



If the smart t band is not detected in the App,

WARNING



Exercising on a wet mat may cause sliding and injury. Wipe with a dry cloth before use.



Tracking may not occur properly if the mat is not completely rolled out. Roll it up on the flip-side to make it as flat as possible.



Using the mat with shoes may reduce the life of the mat. Please exercise with bare feet or wearing socks.



Spilling liquid on the case or mat may cause damage.



Soaking the mat or putting it through a washing machine may cause damage.

If there isn't enough friction on the floor beneath the mat, it may cause the mat to slip. Please check that the mat is securely placed on the floor before exercising.
