10.1. MEASUREMENT PROCEDURE

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Trace 1 Max hold, then View.

Note: The EUT was tested according to KDB 789033 for compliance to FCC 47CFR 15.407 requirements.

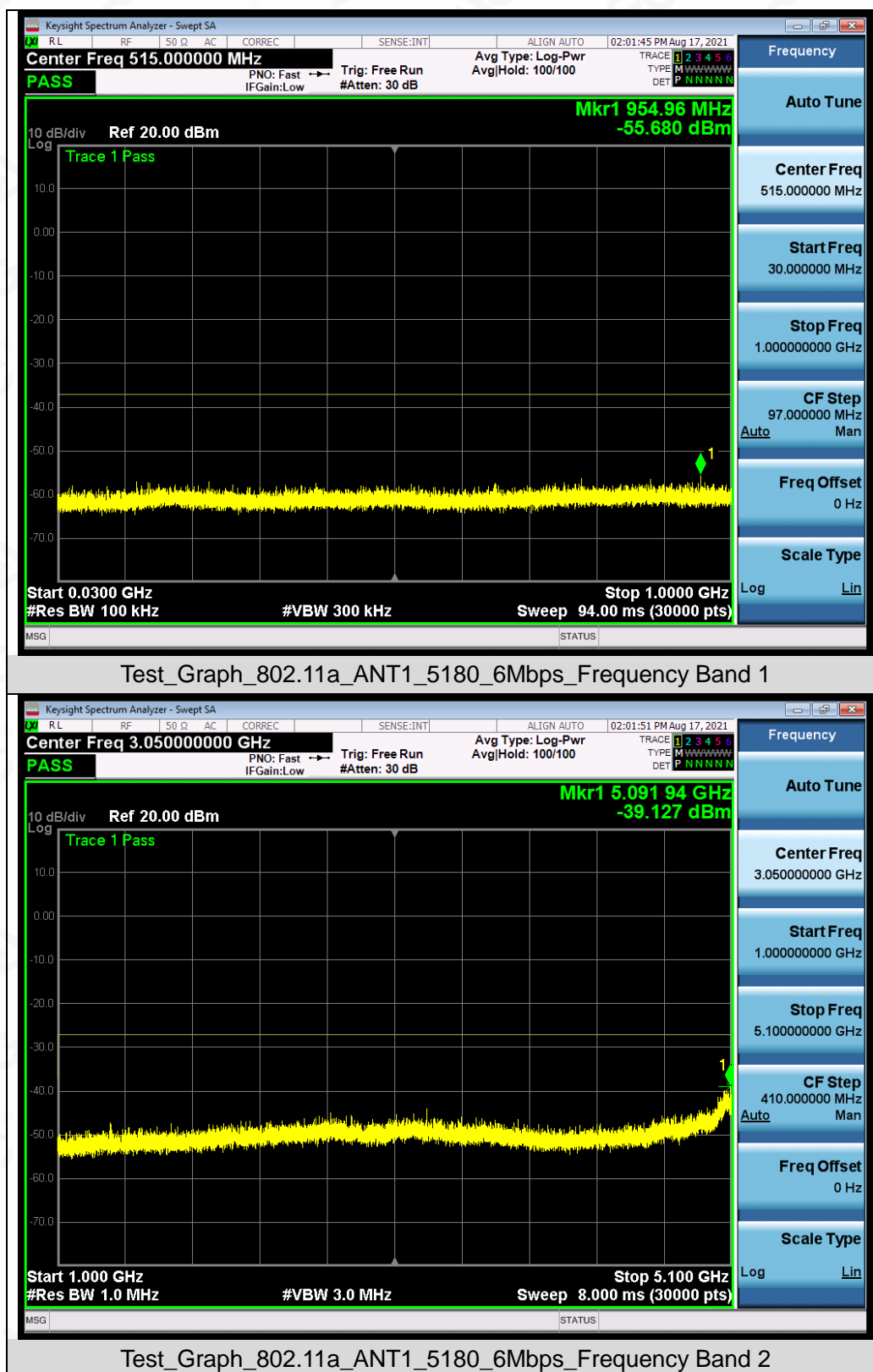

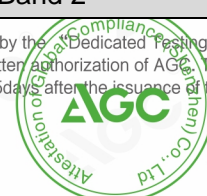

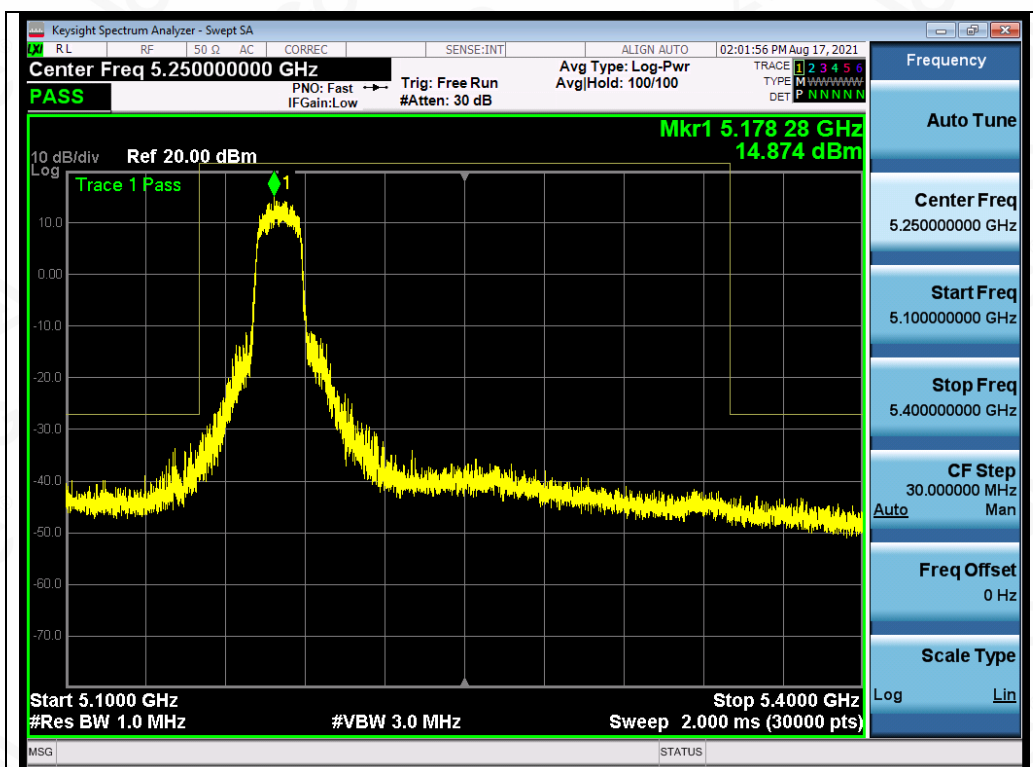

Test_Graph_802.11a_ANT1_5180_6Mbps_Frequency Band 3

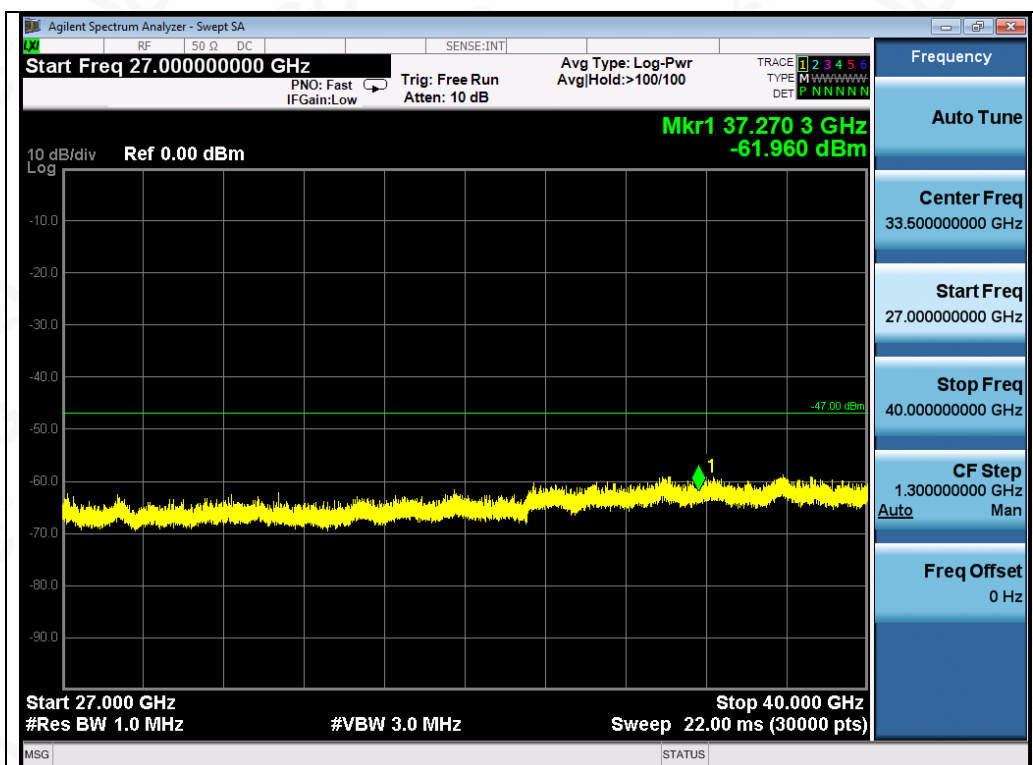

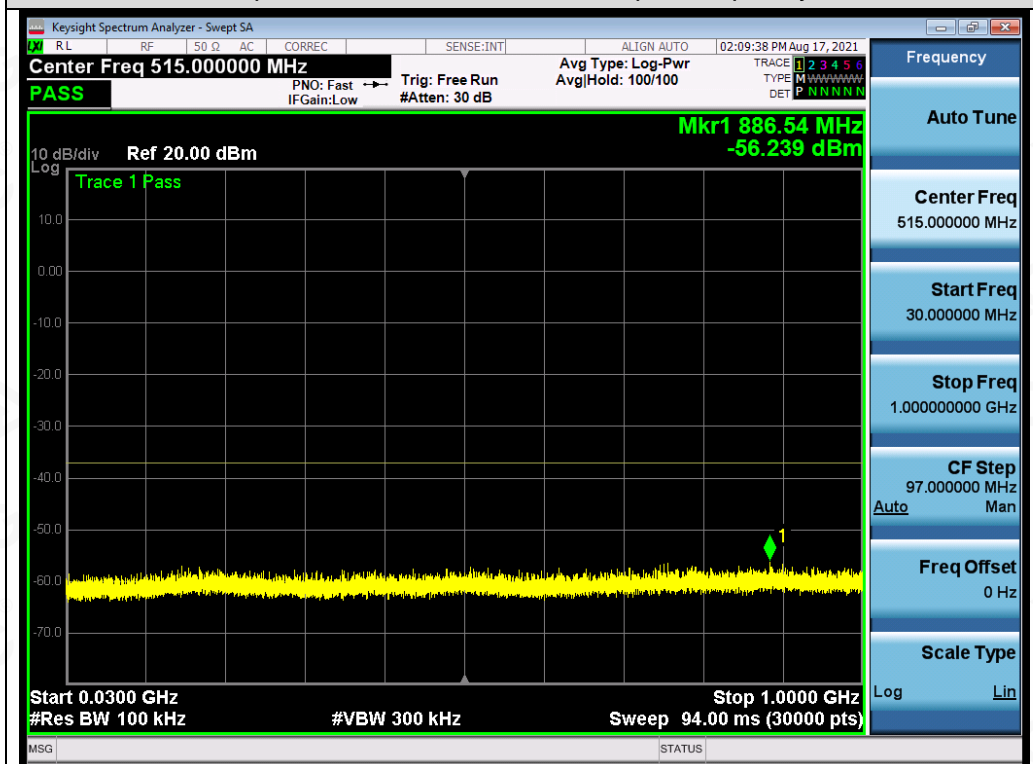

Test_Graph_802.11a_ANT1_5180_6Mbps_Frequency Band 5

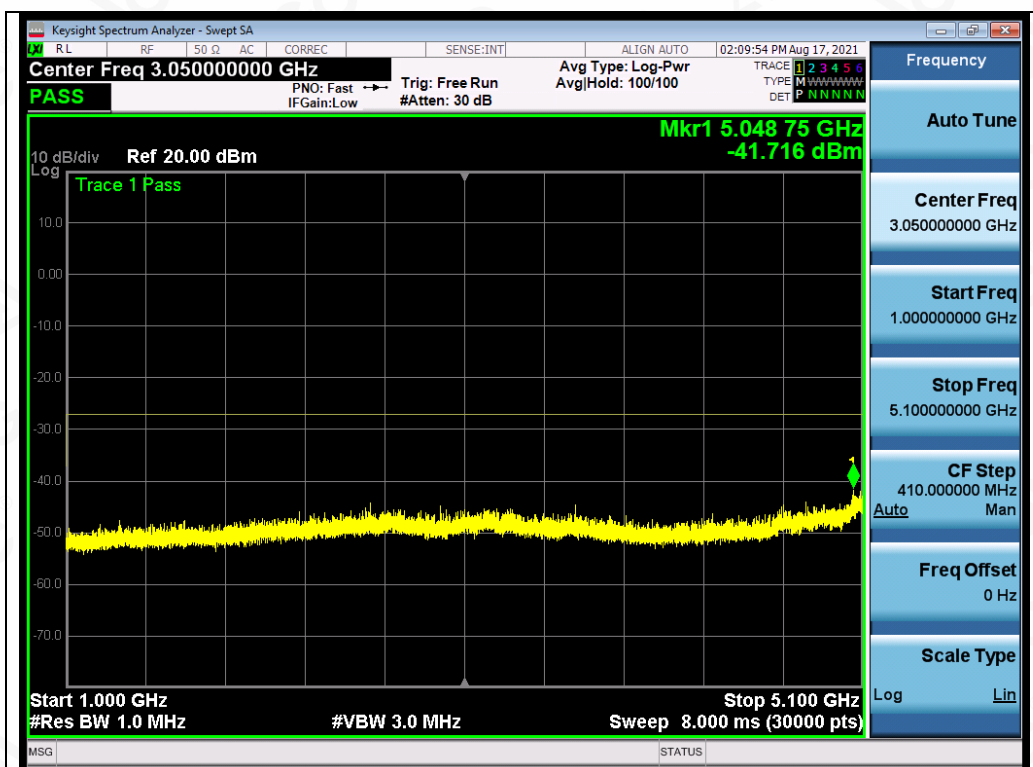

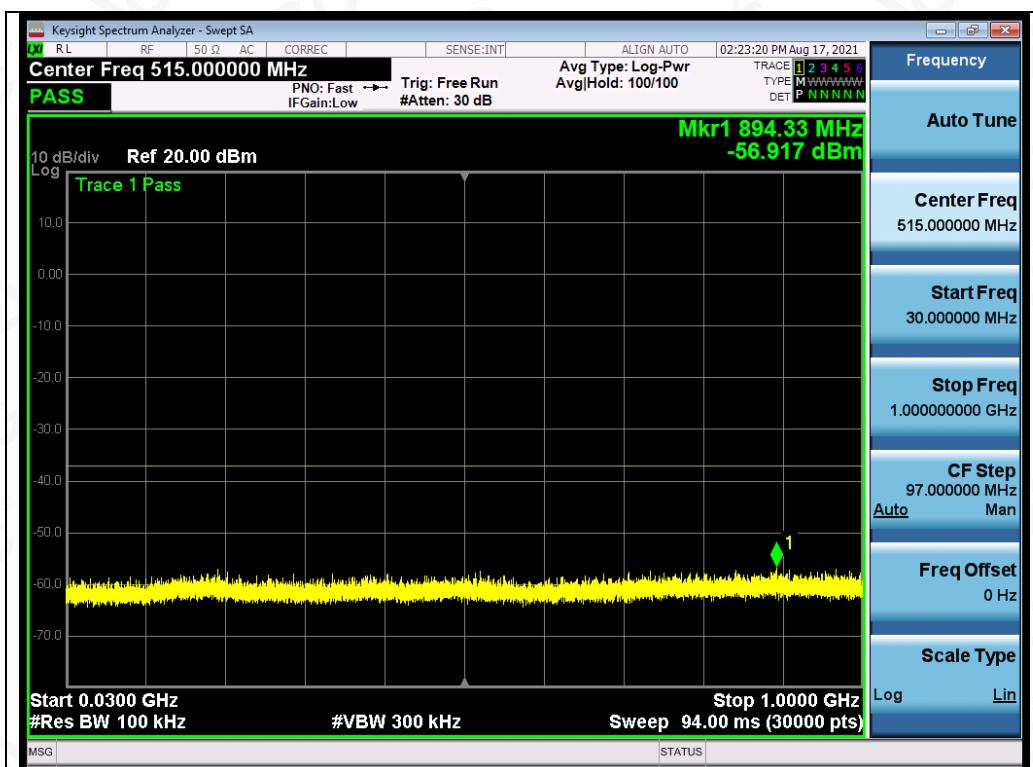

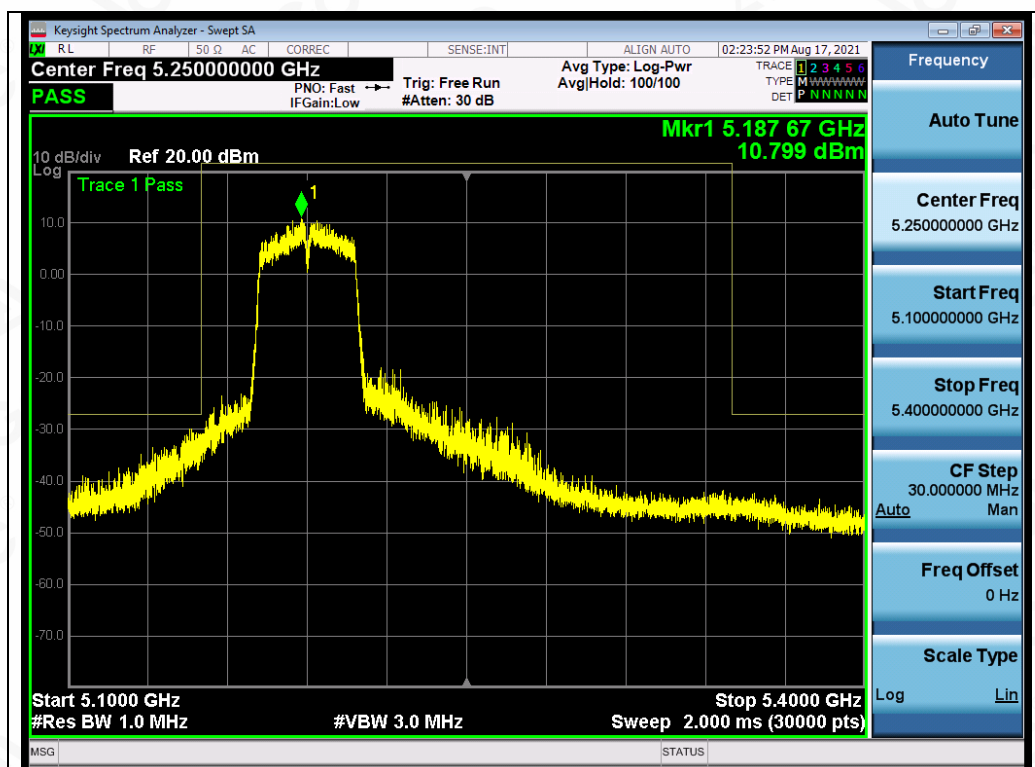

Test_Graph_802.11n40_ANT1_5190_MCS0_Frequency Band 3

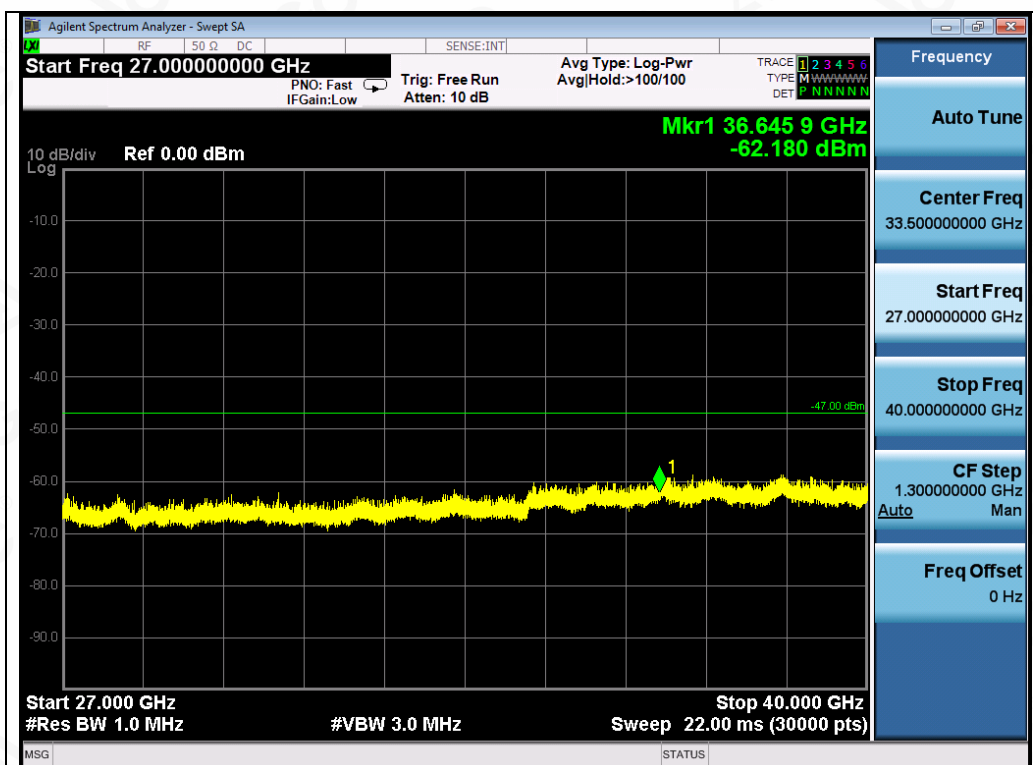

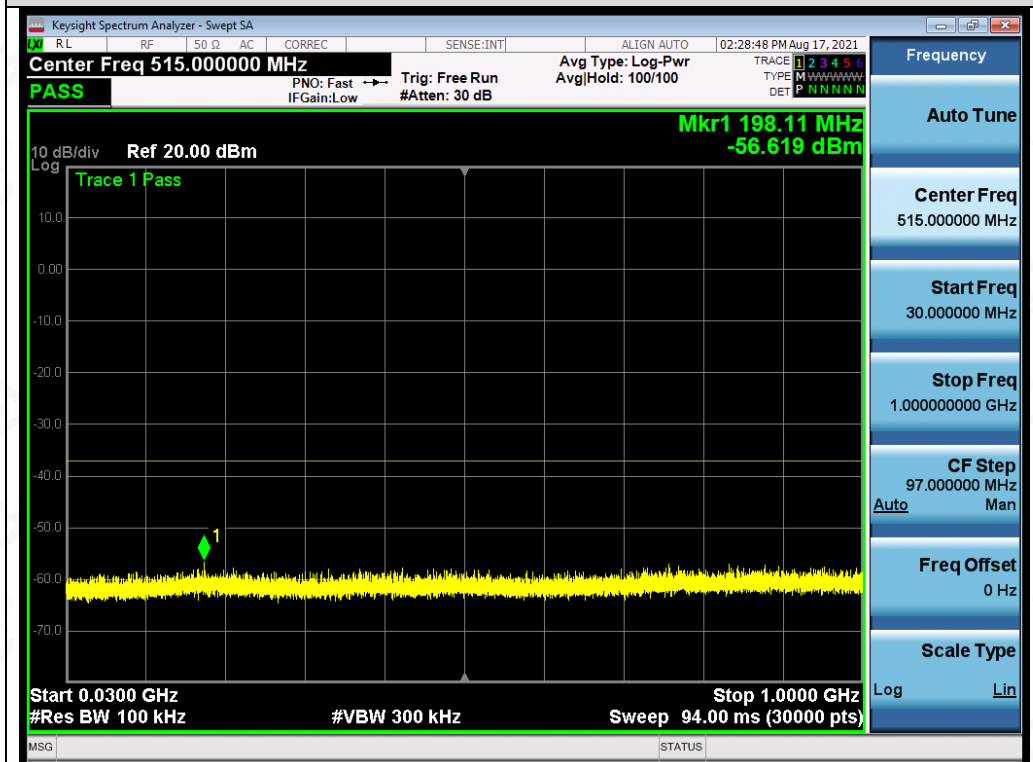
