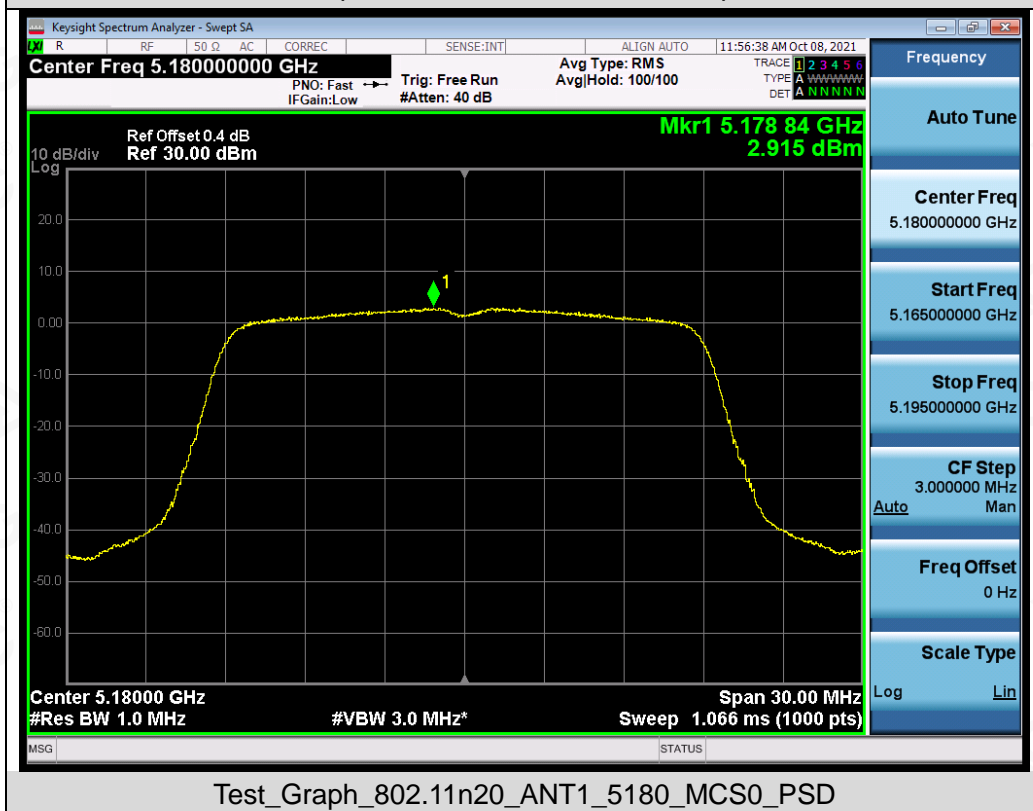

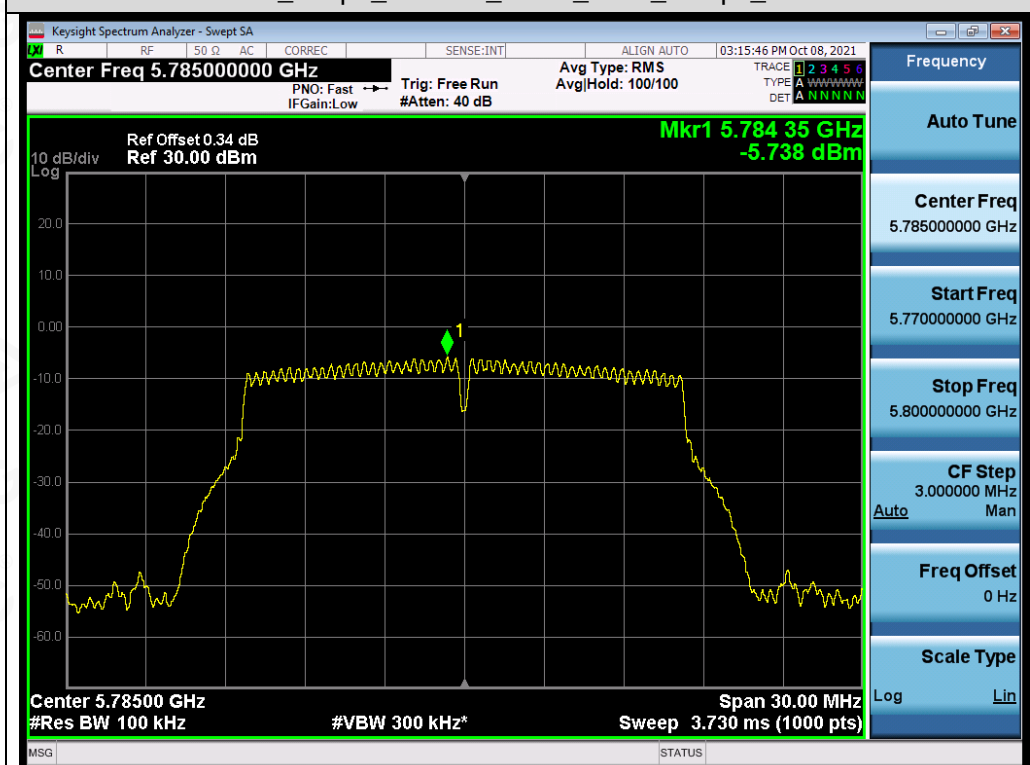




## Test Graphs of Conducted Output Power Spectral Density for band 5.725-5.85 GHz
