## 10. CONDUCTED SPURIOUS EMISSION

### 10.1. MEASUREMENT PROCEDURE

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2. Set the EUT Work on the top, the middle and the bottom operation frequency individually.
3. Set SPA Trace 1 Max hold, then View.

**Note:** The EUT was tested according to KDB 789033 for compliance to FCC 47CFR 15.407 requirements.

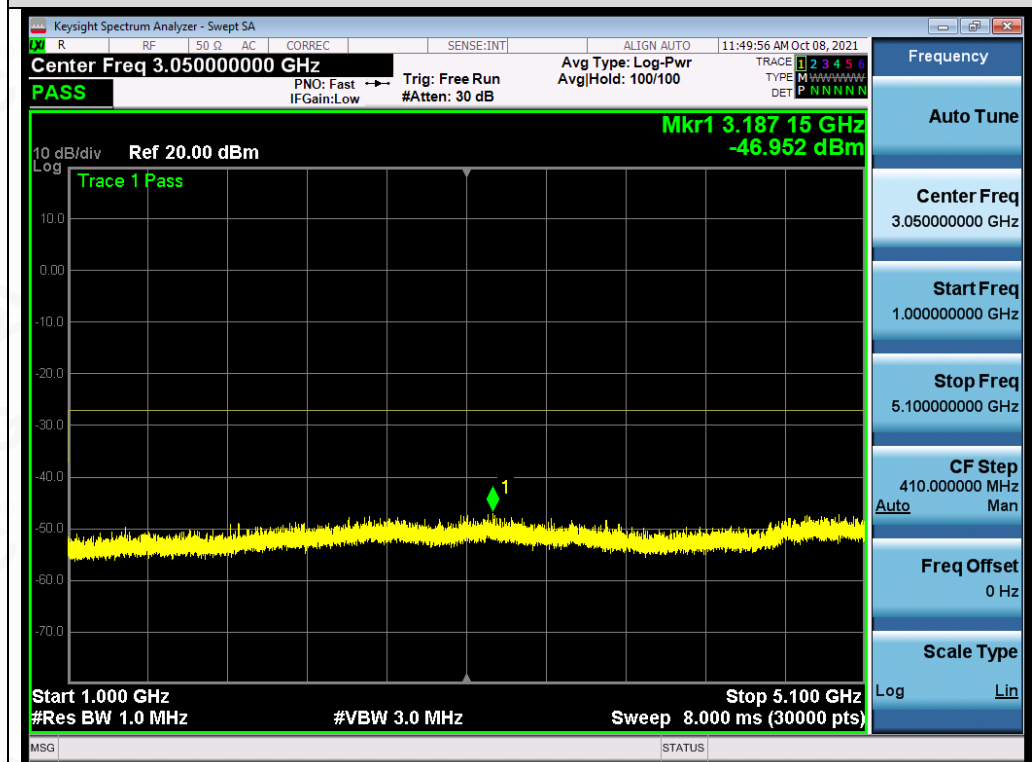

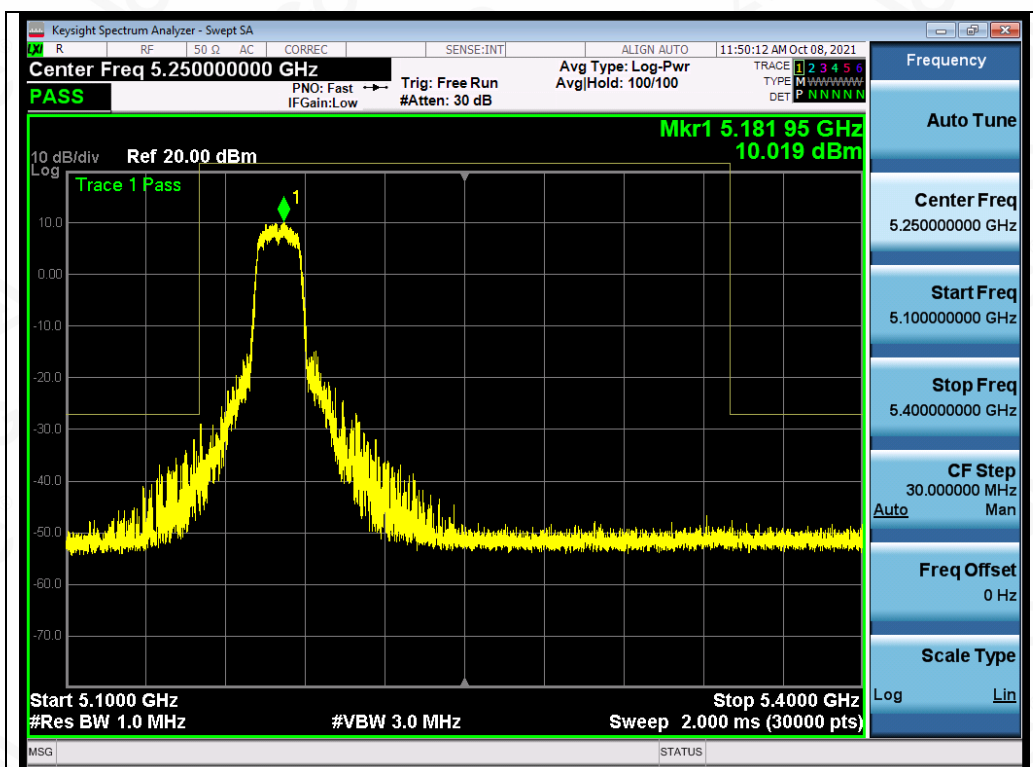

## Test Graphs of Spurious Emissions outside of the 5.725-5.85 GHz band for transmitters operating in the 5.725-5.85 GHz band

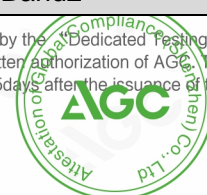


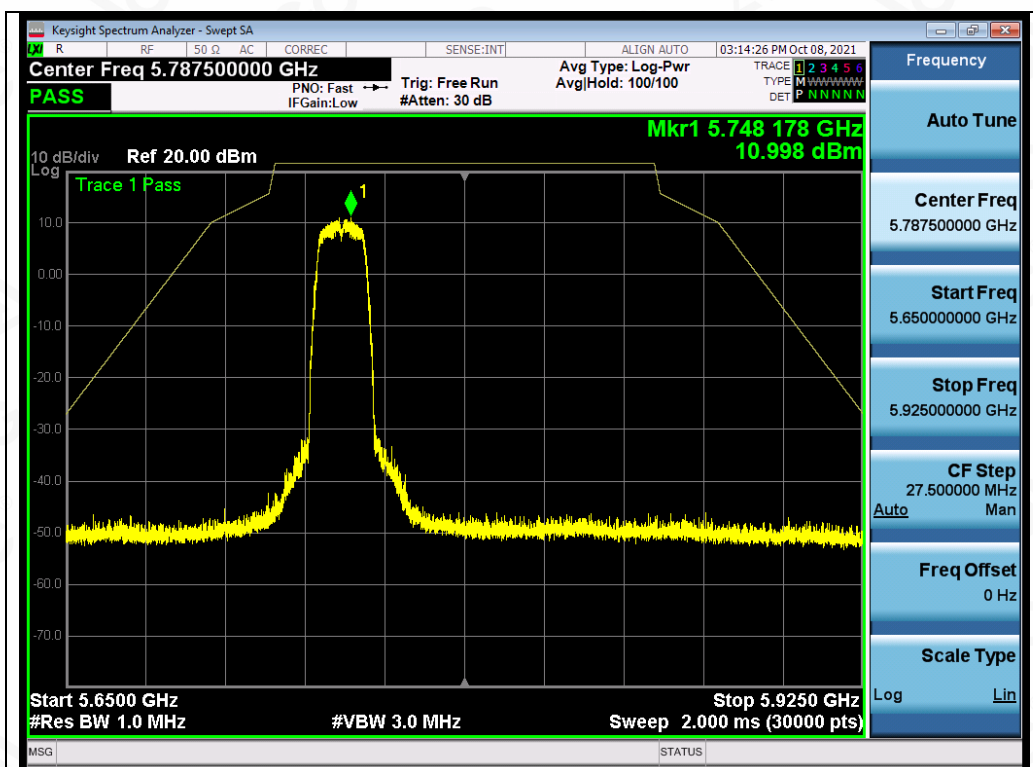
