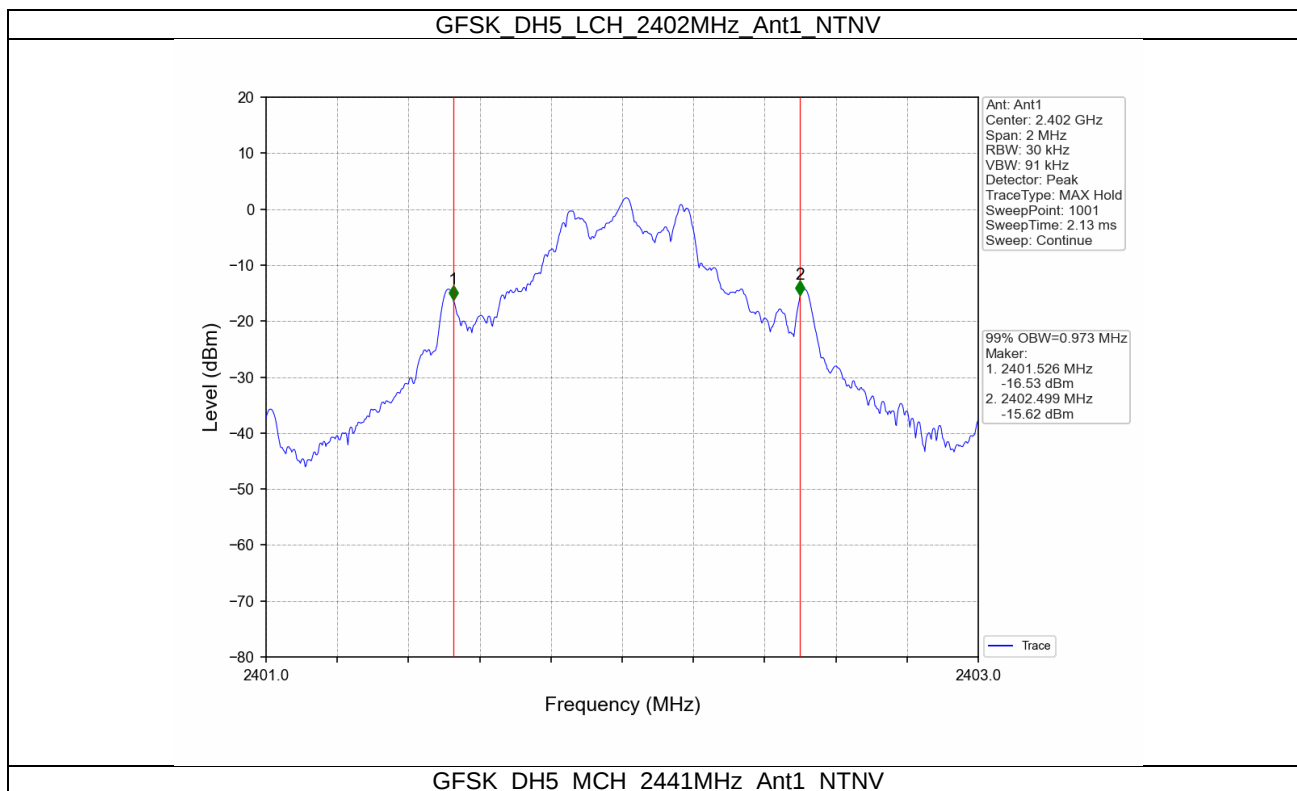

1.1.2 Test Graph



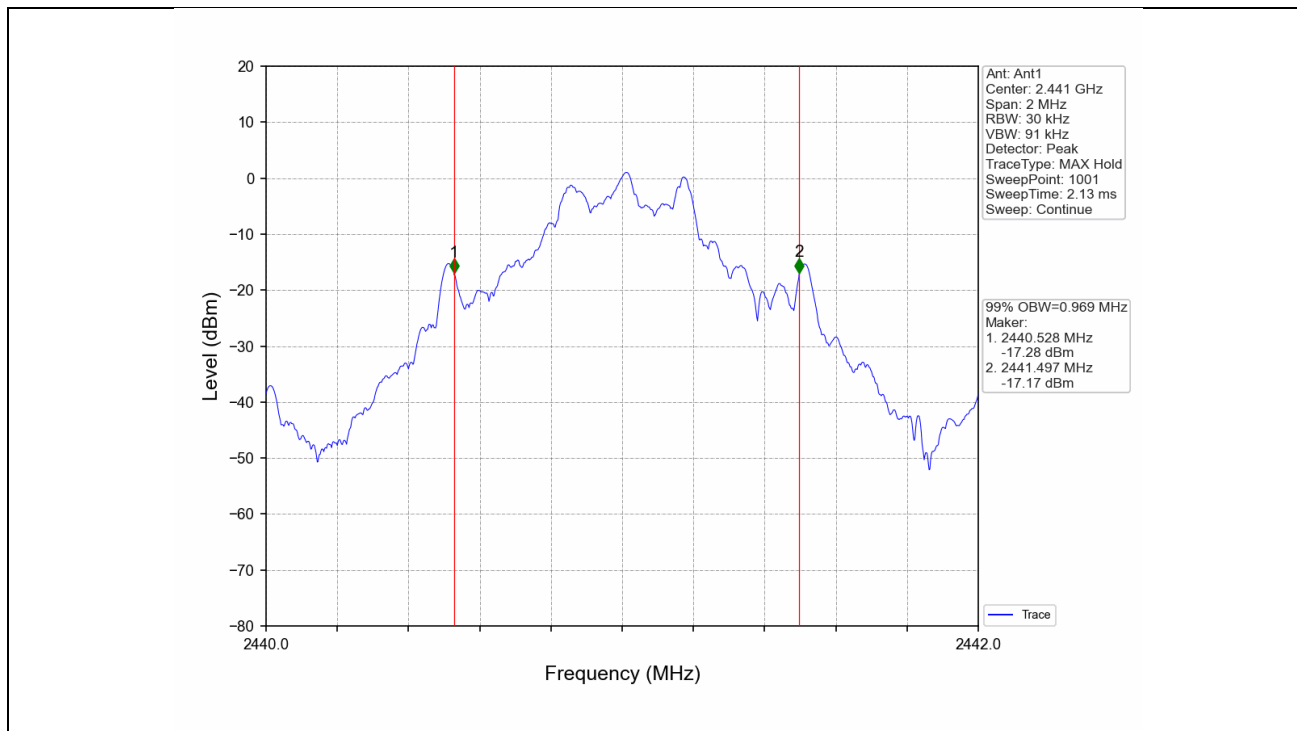

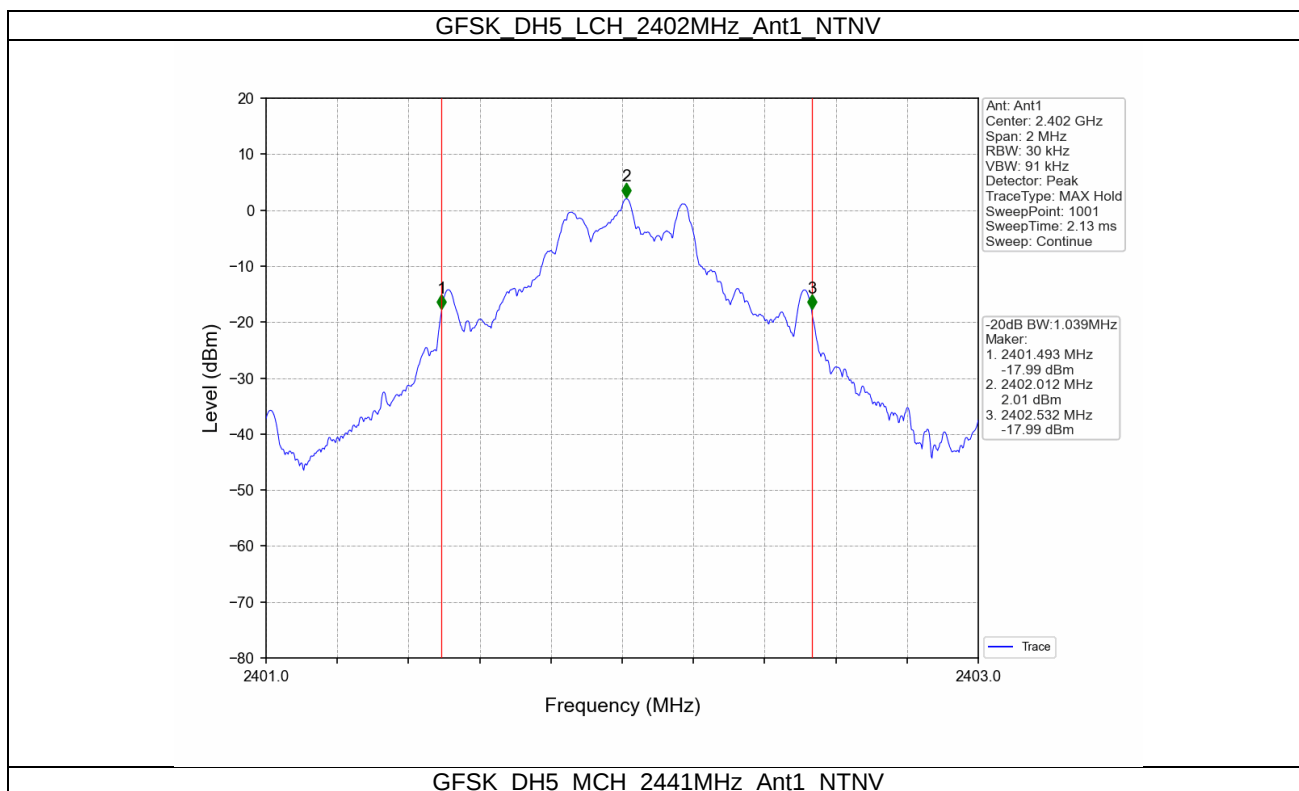

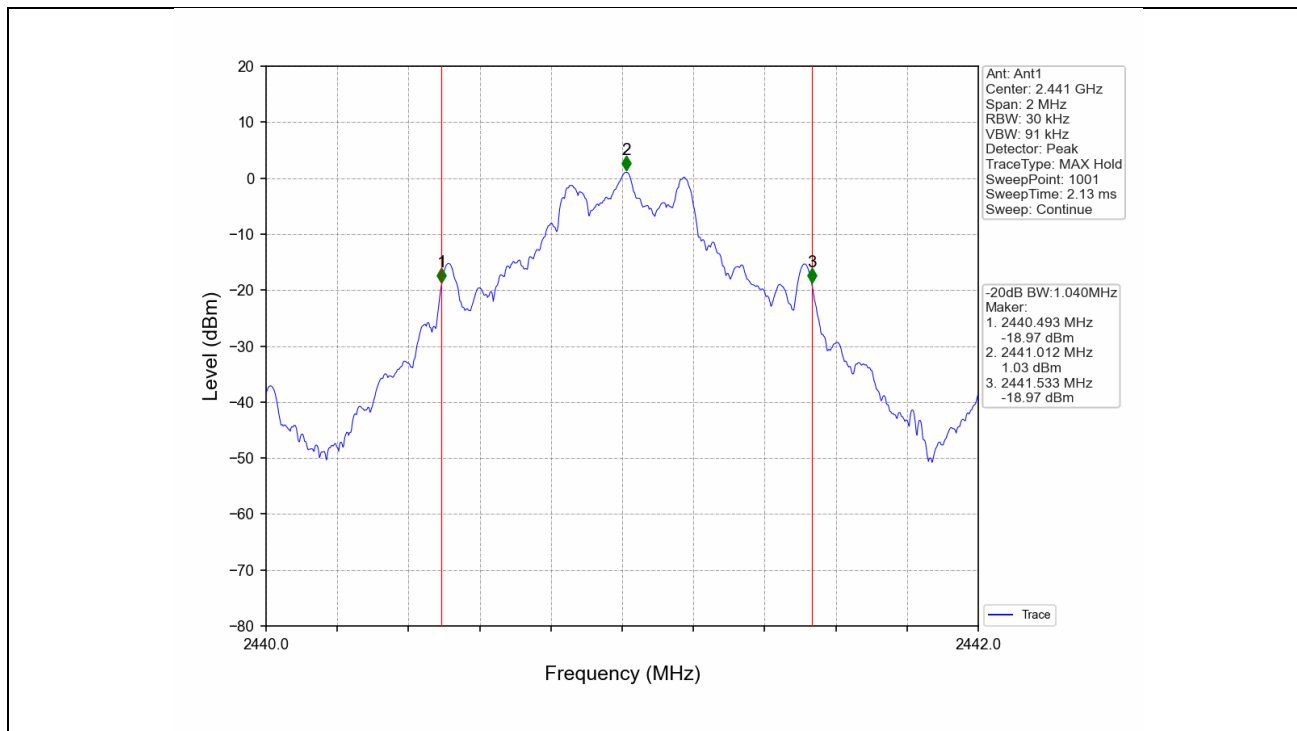
1.2.2 Test Graph

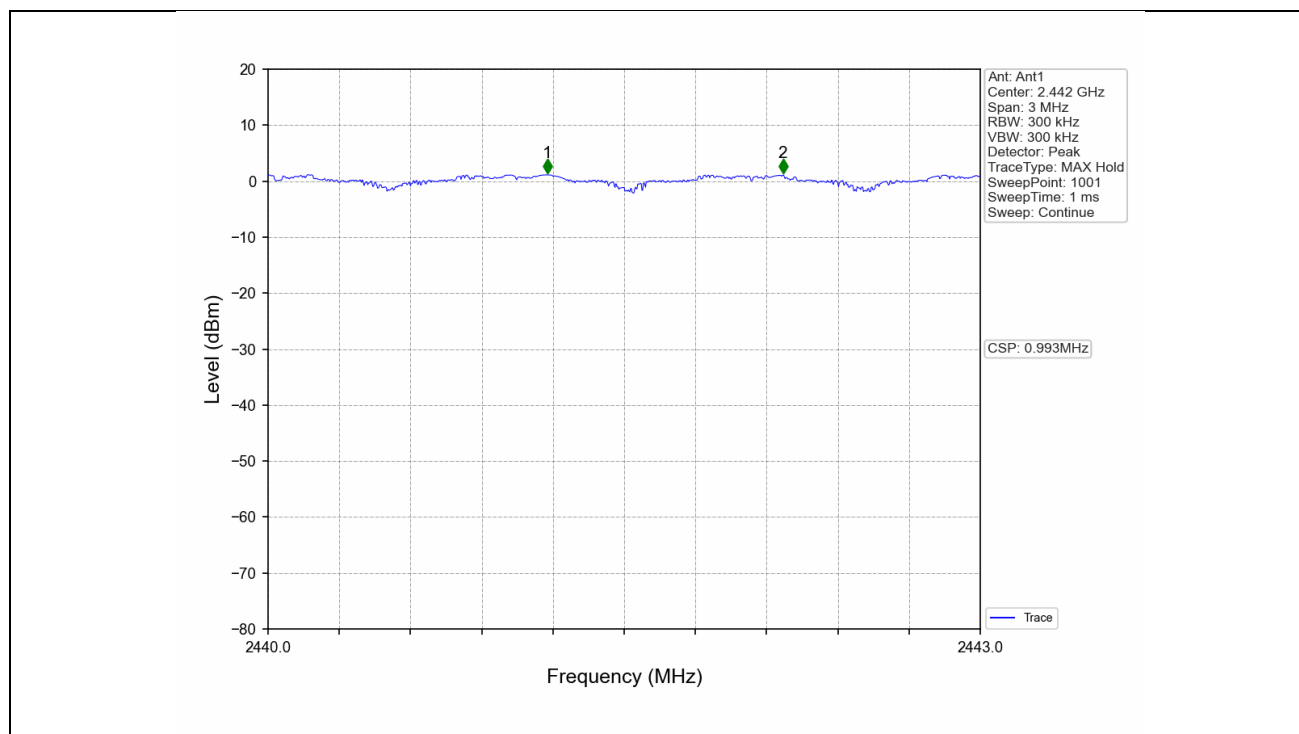
