




PROPER USAGE

Please note: Make sure the essential oil atomizer heads are installed properly before use.

- 1. Keep the unit more than 1 foot away from a wall.
- 2. Do not blow air from a fan or air conditioner directly onto the oil diffuser.
- 3. Place AromaTru at least 2 feet away from curtains or drapery.

OPERATING THE AROMATRU ESSENTIAL OIL DIFFUSER



AROMATRU CONTROL PANEL

1. POWER BUTTON

Press the power button on the front of the unit; the power button will light up. This indicates that the unit is on and ready to use.

2. LIGHT BUTTON

The light button on the front of the unit activates and controls the light ring on AromaTru. When the light button is touched, the light ring will turn on. Each additional touch of the button will change the color of the light ring. It will first start on Light Show and then go though the following colors: green, dark blue, red, orange, purple, light blue, and white. To turn the light ring off, touch the light button a final time.

3. DIFFUSE FOR BUTTON

The **Diffuse for** button controls the amount of time each oil will be diffused for. Each press will change the amount of time from 5 seconds to 10, 15, and 20 seconds.

4. DIFFUSE EVERY BUTTON

The **Diffuse every** button controls the amount of time between each cycle of oils being diffused. Each press will change the amount of time from 5 seconds to 10, 30, and 60 seconds.

5. TIMER BUTTON

The **Timer** button controls the amount of time the unit will run for. Each press of the button will change the amount of time from 10 minutes to 20, 30, and 40 minutes.

6. OIL SELECTOR BUTTONS


The oil selector button under each atomizer will be illuminated when that oil is selected to be diffused. The button will blink when that oil is currently being diffused.


INSTALLING ESSENTIAL OIL BOTTLES

Note: Although most 15ml essential oil bottles will work with your AromaTru diffuser, not all will fit properly. To ensure your bottles will fit, we recommend using our AromaTru USDA Organic and Wildcrafted essential oils.

To install essential oils, first remove Cover. Then remove Atomizer head by pulling up and out. Unscrew the oil bottle cap, remove the clear plug and screw the Atomizer Head onto the bottle.

Re-attach Atomizer Head to Atomizer Post and push down firmly.





Plug the wall adapter into an electrical outlet and plug the other end into the AromaTru device. The unit will be ready to use. Before starting to diffuse oil, please read the section, "Diffusing for the First Time."

Caution: If the oil bottle you are using has an orifice reducer, remove the reducer before installing the oil bottle. Only use oil bottles that fit the unit.

AROMATRU ESSENTIAL OIL DIFFUSER

HOW TO CONNECT YOUR AROMATRU APP

- First start by Downloading the AromaTru app on Google Play or the App Store. Next, register to create a new account.
- 2. If you plan to share app capabilities with another person's phone, select the option to create an account with the username and password, then use those credentials to log in.
- 3. Next return to the AromaTru app and hit the + sign and select Device.
- **4.** You will need to put your AromaTru in **Discovery Mode**. Press and hold the power button for 10 seconds until your AromaTru light ring turns blue.
- 5. You will now be prompted to name your AromaTru.
- **6.** Open your smart phone's Wi-Fi settings to pair your AromaTru. Connect to AromaTruXXXXXXXXXAP and enter password: aromatru. Go back to the app and press continue.
- 7. You will now need to connect your AromaTu to your home Wi-Fi.
- 8. Select your network, press Continue, enter your password and press Save.
- 9. Your AromaTru will initialize and attempt to connect to your Wi-Fi network.
- 10. The blue light will turn off after connecting. Press Continue.
- **11.** If you see a red light after connecting, the device was unable to connect to your Wi-Fi network and you should press Try Again.
- 12. Your AromaTru should now be connected. Press Get Started to explore the in-app walkthrough of your features.






MANUALLY DIFFUSING ESSENTIAL OILS

- 1 Install essential oil bottles (see previous page for how to install).
- 2. Press the power button to activate unit.
- Select the diffusing time by pressing the **Diffuse for** button. This is the time the unit will continually diffuse each selected oil.
- **4.** Select the time between diffusing by pressing the **Diffuse every** button.
- **5.** Press the **Timer** button to select for how long you want to diffuse oil.
- **6.** Select the oils you want to diffuse.
- 7. Replace the Cover.

Note: As soon as a diffusing time and 1 oil has been selected, the AromaTru will start diffusing. You can change any of the settings during diffusing.



DIFFUSING MULTIPLE OILS

It is possible to select between 1 to 4 oils to diffuse at a time. The way the AromaTru diffuses multiple oils is by diffusing them one at a time.

If, for example, the following program has been selected:

Diffuse for 10 seconds

Diffuse every 60 seconds

Timer is set to 20 minutes

Oil slots 1, 2, and 3 have been selected

AromaTru will diffuse the oils in the following way:

Slot 1 will diffuse for 10 seconds, followed by slot 2 for 10 seconds, followed by slot 3 for 10 seconds.

There will be a rest time of 60 seconds before slot 1 begins again.

This cycle will continue for 20 minutes until the end of the Timer.

Note: It is possible to change the slot number and timer setting anytime during diffusion.

MAINTENANCE

CLEANING THE ATOMIZER

To clean the AromaTru atomizers, attach the AromaTru Cleaning Solution (included with device) to the atomizer and use the control panel to set the **Diffuse for** button to 20 seconds, the **Diffuser every** button to 30 seconds, and let the Cleaning Solution run for 5 minutes. Repeat for each atomizer. Once finished, replace the Cleaning Solution with oils of your choice and use normally.

To prevent clogging due to more viscous essential oils, diffuse the Cleaning Solution every 1-3 months as needed, according to frequency of use. May also be used to clean the external surfaces of the diffuser.

AROMATRU CLEANING SOLUTION WARNINGS

Apply a small amount of the Cleaning Solution to a dry cloth. Wipe down the external surfaces of the unit as necessary.

TROUBLESHOOTING

Before contacting our customer service department, please try the following solutions:

PROBLEM: Unit won't operate.

Reason: ON/OFF button has not been pressed.

Solution: Press ON/OFF button. **Reason:** Unit is unplugged. **Solution:** Plug in unit.

PROBLEM: Reduced amount of oil being diffused.

Reason: The nozzle or pickup tube may be blocked.

Solution: Inspect pickup tube and nozzle and use cleaning solution to clean nozzle

or pickup tube.

Reason: Oil bottle is empty.

Solution: Replace empty bottle with full bottle. **Reason:** Pickup tube may not be inserted all the way.

Solution: Remove atomizer from oil bottle and make sure pickup tube is inserted correctly.

ONE-YEAR LIMITED WARRANTY

PLEASE READ THIS AGREEMENT CAREFULLY. YOU ACCEPT THE TERMS OF THIS AGREEMENT BY RETAINING THE PRODUCT(S) SHIPPED IN CONNECTION WITH THIS AGREEMENT (THE "PRODUCTS") FOR MORE THAN THIRTY (30) DAYS AFTER RECEIPT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU MAY RETURN THE PRODUCT TO COMPANY WITHIN THIRTY (30) DAYS OF RECEIPT FOR A FULL REFUND.

THIS ARBITRATION AGREEMENT ("AGREEMENT") AFFECTS YOUR LEGAL RIGHTS AND REMEDIES BY PROVIDING THAT DISPUTES BETWEEN YOU AND THE MANUFACTURER, DISTRIBUTOR AND/OR SELLER OF THIS PRODUCT (COLLECTIVELY, "COMPANY"), MUST BE RESOLVED THROUGH BINDING ARBITRATION AND NOT IN COURT. 3. ARBITRATION PROCEDURES.

- **a.** Before instituting an arbitration, if you have any dispute, we strongly encourage you to contact the Company to try to resolve the matter by calling 800-926-1709, although you are not required to do so. **b.** The arbitration of any claim or dispute under this Agreement shall be conducted in accordance with the expedited procedures set forth in the JAMS Comprehensive Arbitration Rules and Procedures as those Rules exist on the date you receive the Product, including Rules 16.1 and 16.2 of those Rules. These rules and procedures are available by calling JAMS or by visiting its web site at www.jamsadr.com. The arbitration of any claim or dispute under this Agreement shall be conducted by an arbitrator who has at least five years of experience conducting arbitrations.
- **c.** The arbitration of any claim or dispute under this Agreement shall be conducted in the State of California or the location in which you received this Agreement. For claims of \$10,000 or less, you may choose whether the arbitration proceeds in person, by telephone, or based only on submissions. **d.** The Company shall pay costs for the arbitration of claims, including any JAMS Case Management Fee and all professional fees for the arbitrator's services. The Company shall pay the fees and costs of its own counsel, experts and witnesses and shall not be able to recoup them from you even if you do not prevail in the arbitration. Unless otherwise provided by law, you acknowledge and agree that you shall pay the fees and costs of your own counsel, experts and witnesses.
