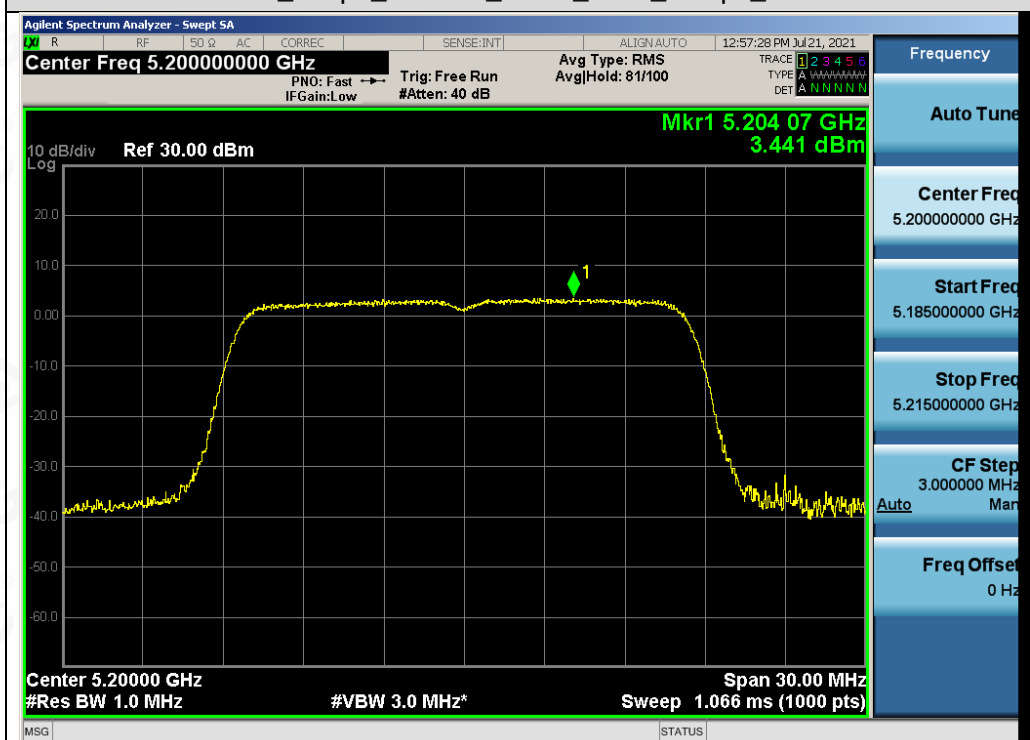

Test_Graph_802.11n20_ANT1_5200_MCS0_PSD

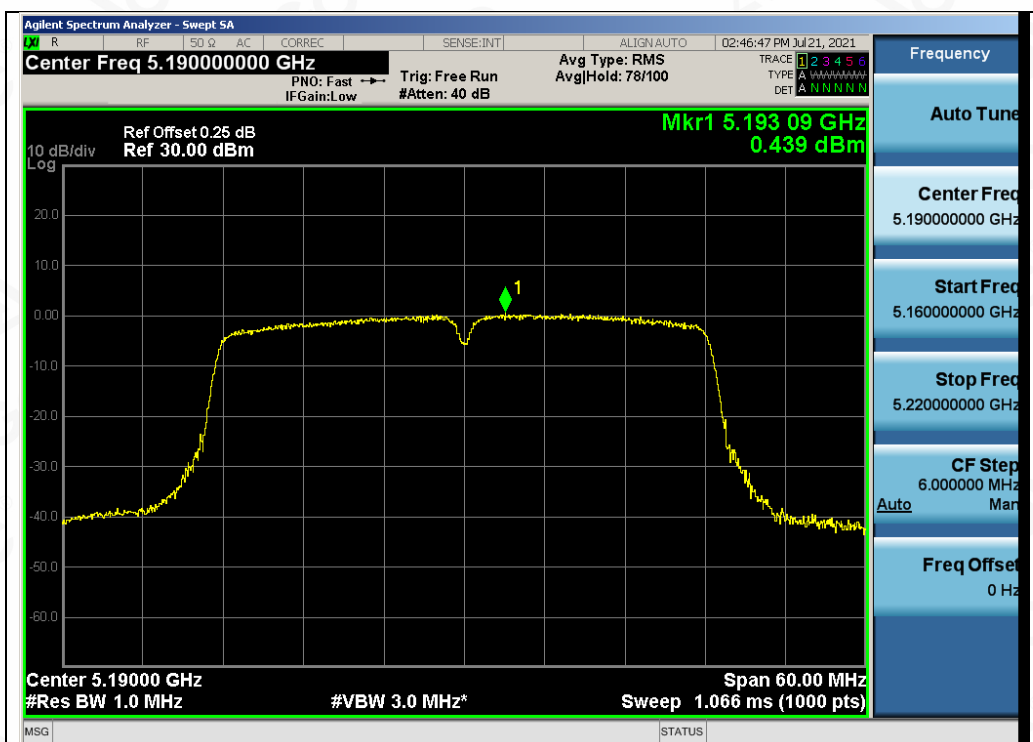

Test_Graph_802.11ac40_ANT2_5230_MCS9_PSD



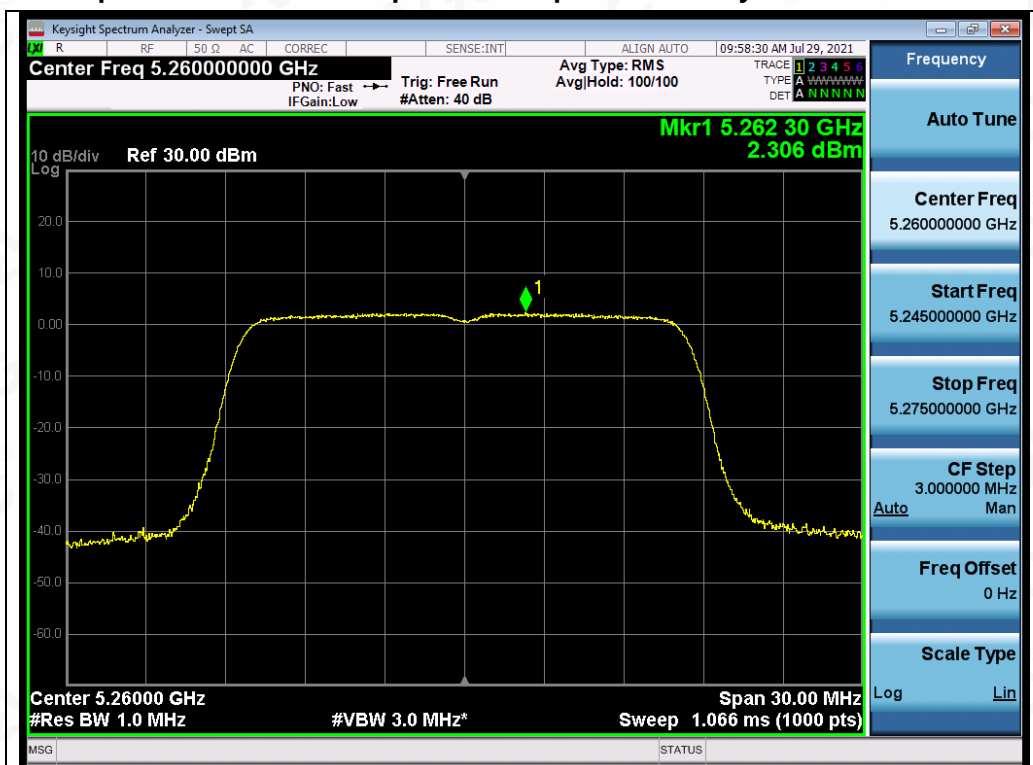

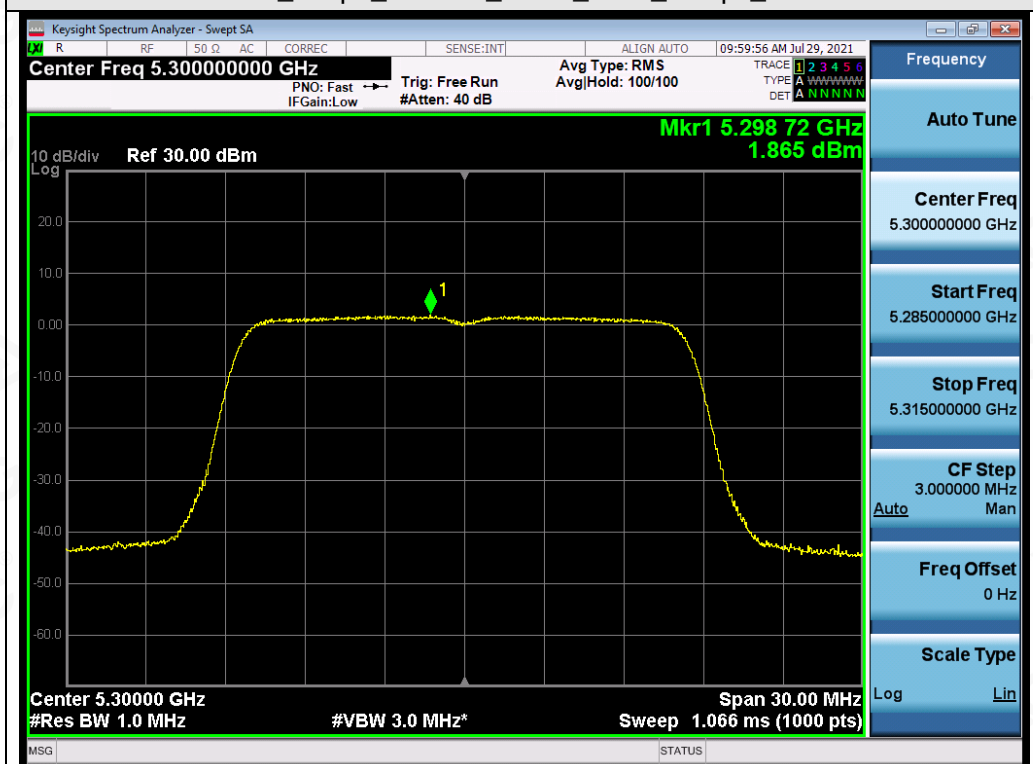

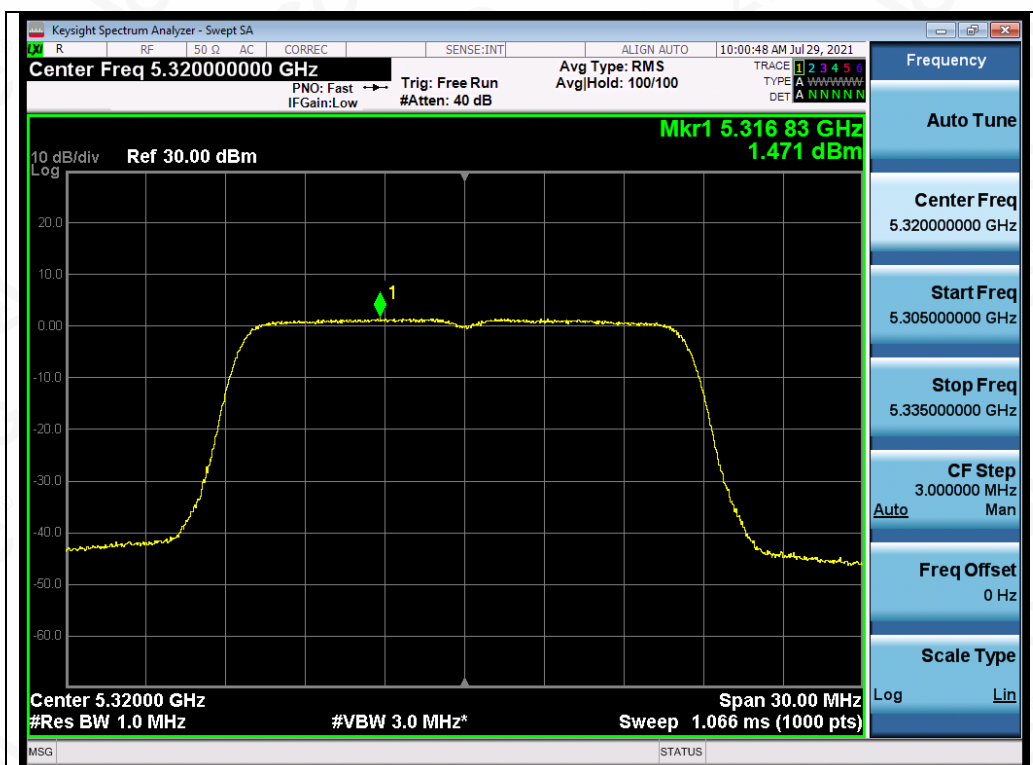


Test_Graph_802.11a_ANT1_5300_6Mbps_PSD

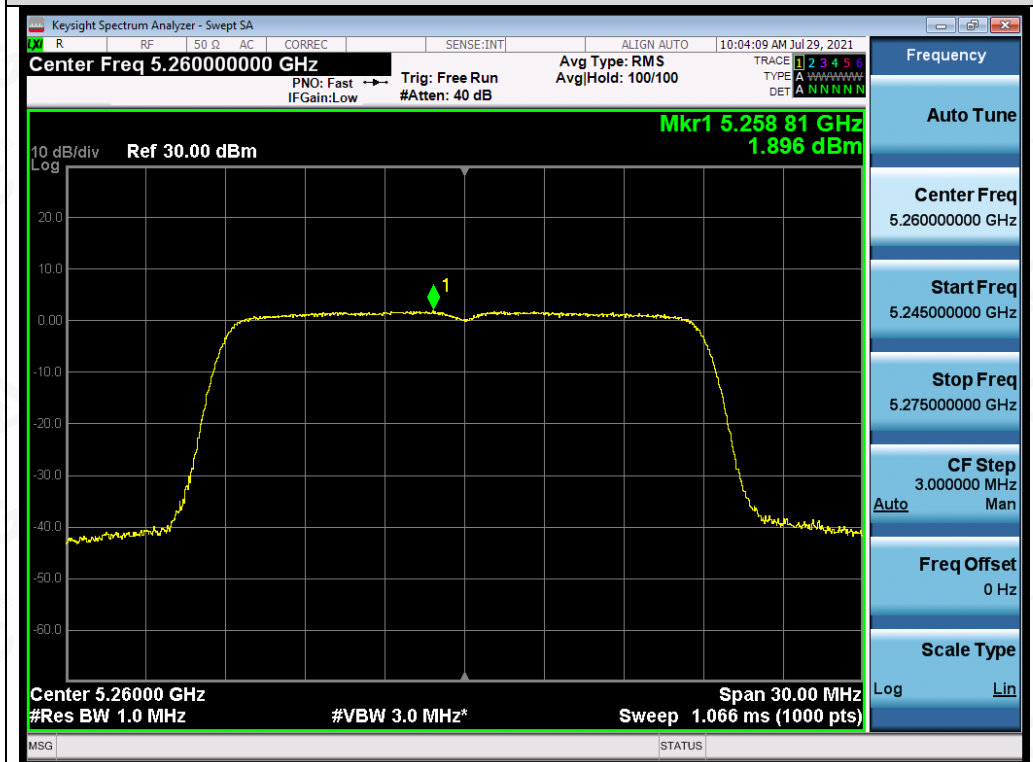
