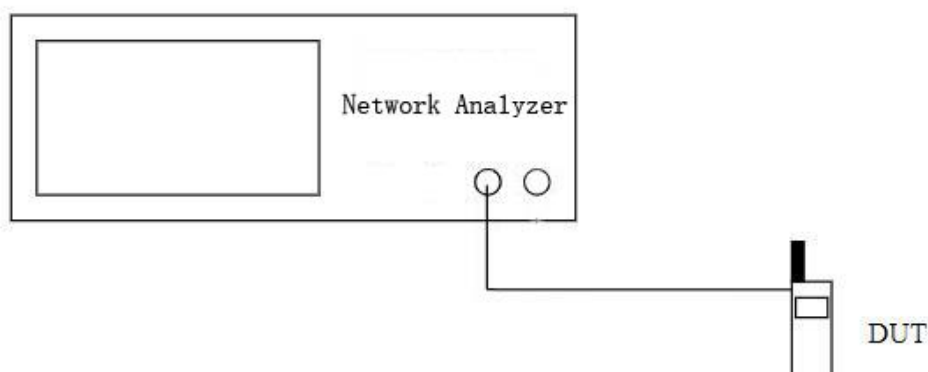

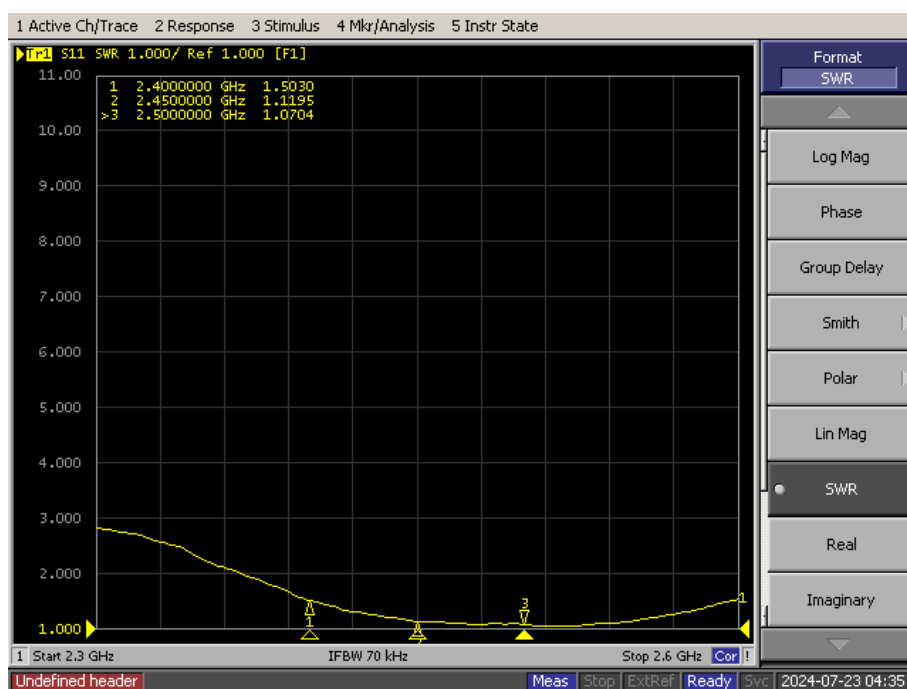

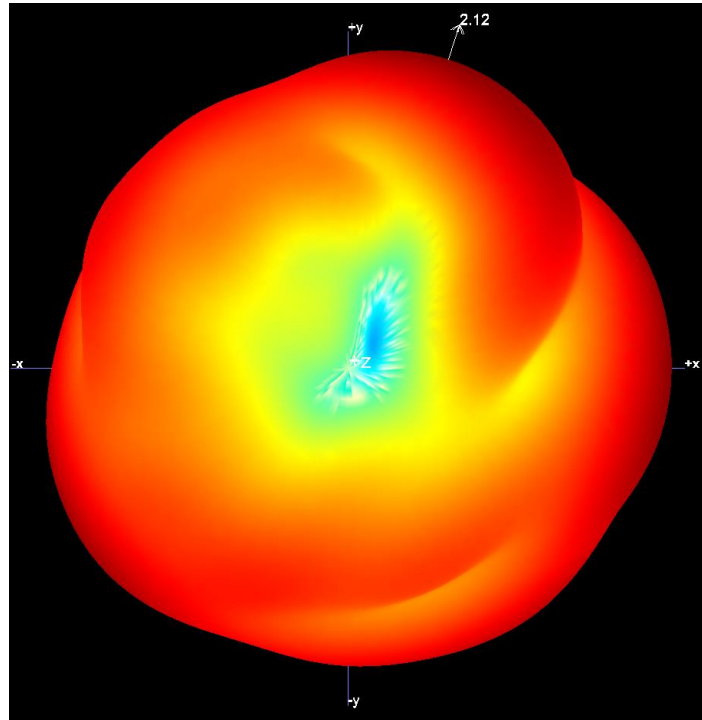

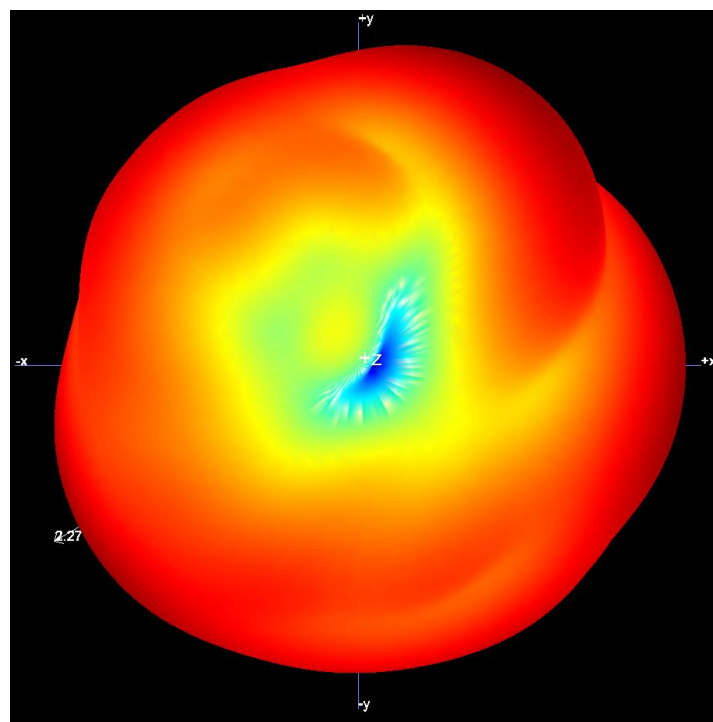

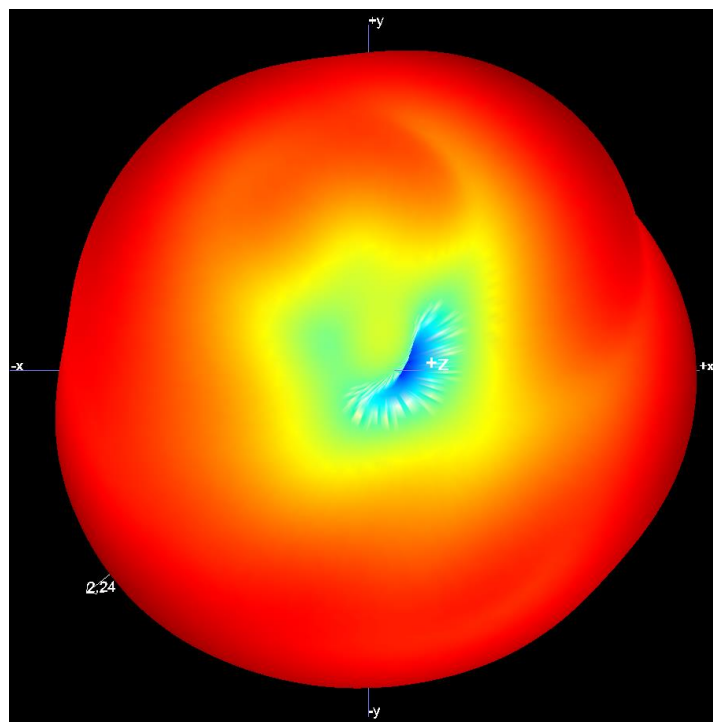
B1.1 3D Pattern for 2400MHz
