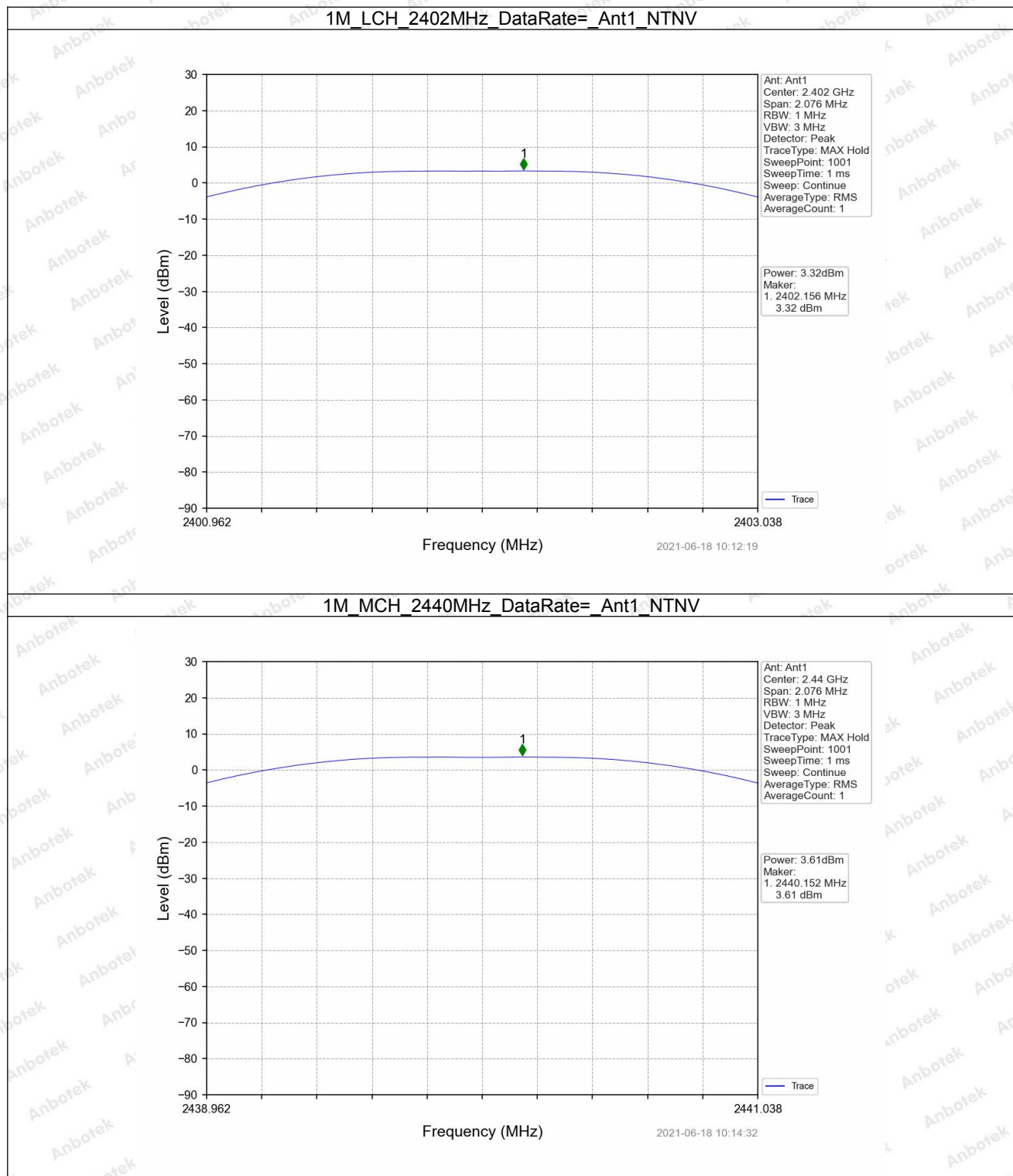

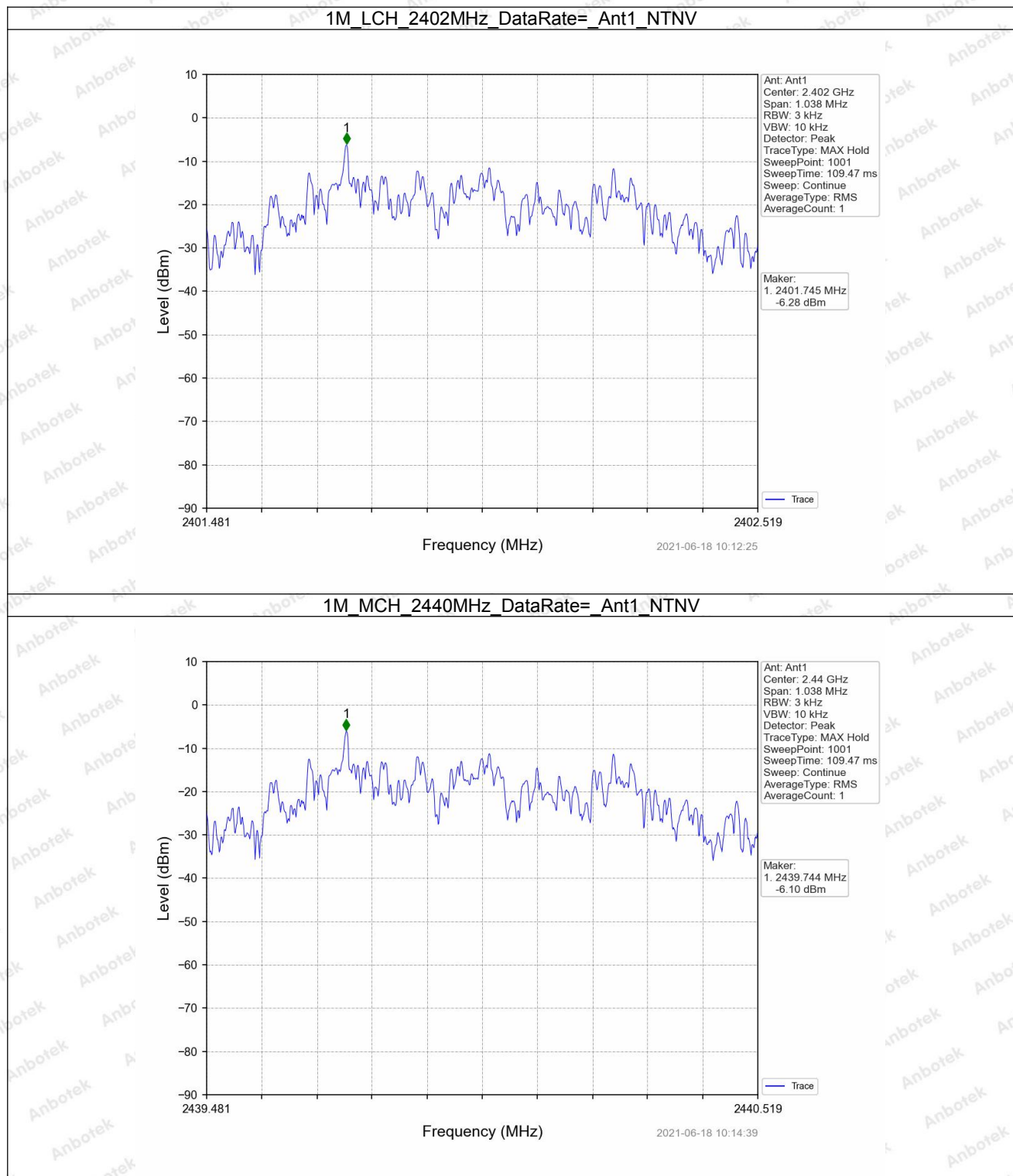

1M_HCH_2480MHz_DataRate= Ant1_NTNV

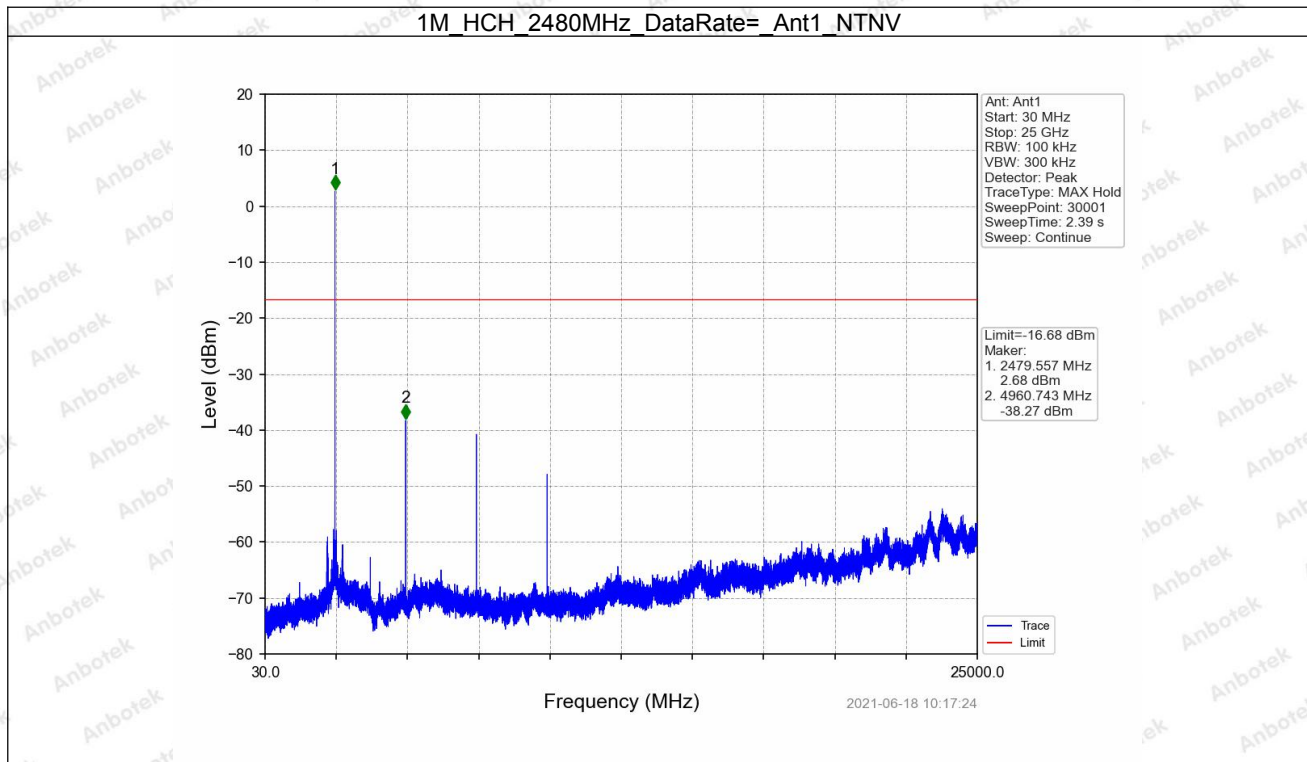
