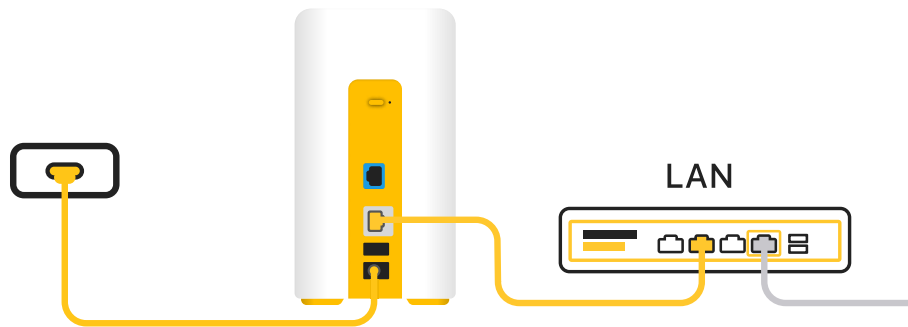
Install Guide

Step 1



Download Firewalla App from App Store or Google Play.

Step 2



Use an ethernet cable to connect the Firewalla AP7 with a Firewalla Router, and plug the AP to a power source.

The Firewalla AP7 can be used as a single node or multiple nodes in a mesh setup.

Step 3



Open the App, follow the guide on our website (<http://firewalla.com/install/>) to set up the Firewalla AP7.

Federal Communication Commission Statement

RF exposure warning
