

Product introduction



按键说明
Key description

- 1、开/关机键
点击开/关机键，产品进入待机模式。再次点击开/关机键，产品关机。
 - 2、烘干键
第一次点击烘干键，产品默认烘干+风干2.5小时；第二次点击，烘干+风干3小时；第三次点击，烘干+风干3.5小时；第四次点击，烘干+风干4小时；第五次点击，烘干+风干功能关闭，依次循环。
 - 3、消毒键
点击消毒键，产品开启紫外线消毒模式，默认30分钟。
 - 4、智能键
点击智能键，产品根据室内温度智能选定烘干+风干时长，定时结束后自动进入紫外线消毒模式。
1. On / off key
Click the on / off key to enter the standby mode. Click the on / off key again to shut down the product.
2. Drying key
Click the drying key for the first time, the product will be dried + air dried for 2.5 hours by default; Second click, drying + air drying for 3 hours; Third click, drying + air drying for 3.5; Fourth click, drying + air drying for 4 hours; Fifth click, drying + air drying function is off and cycle in turn.
3. Disinfection key
Click the disinfection key, the product will start the ultraviolet disinfection mode, default 30 minutes.
4. Smart key
Click the smart key, the product will select the drying + air drying time intelligently according to the indoor temperature, and automatically enters the ultraviolet disinfection mode after the drying + air drying.

配网说明（WIFI版）
Networking instructions(WiFi version)

- 1、配网前准备设备：毛巾机、WiFi路由器、手机；
 - 2、确保手机连接WiFi路由器的2.4GHz网络（目前只支持2.4GHz网络，不支持5GHz网络）；
 - 3、在APP Store等应用商店搜索“云智能”APP或者扫描毛巾机上的“配网二维码”，下载并安装APP，按提示注册账号密码；
 - 4、长按毛巾机上的“智能”键3秒，毛巾机上WiFi指示灯持续闪烁，毛巾机进入配网模式；
 - 5、登录“云智能”APP，扫描毛巾机上的“配网二维码”，按提示操作；若干秒之后，提示联网成功，尽情享受远程控制带来的便捷和乐趣吧！
- 1.Pre distribution equipment: towel machine, WiFi router, mobile phone;
2.Ensure that the mobile phone is connected to the 2.4GHz network of WiFi router (currently only 2.4GHz network is supported, not 5GHz network);
3.Search "yunzhineng" app in app store or scan "QR code" on towel machine, download and install app, then open app and register account password as prompted,
4.Long press the "intelligent" key on the towel machine for 3 seconds, the WiFi indicator will flash continuously, and the towel machine networking mode;
5.Log in to "yunzhineng" app to scan the "QR code" on the towel machine, and operate according to the prompts; after a few seconds, it indicates that the networking is successful. Enjoy the convenience and fun of remote control!

Attention

- 产品安装高度应距离地面1米或以上，室内使用，避免水淋；
 - 长期不使用产品时请关闭电源，拔下插头；
 - 产品整体不可直接用自来水清洗，只可用湿毛巾擦拭，清洗前需拔掉插头；
 - 严禁拆卸或更换本产品的任何附件，否则本公司将不承担由此产生的一切可能后果；
 - 若发生故障，应立即拔掉电源插头断电，切勿将有缺陷的产品置于工作状态。
- 1.The installation height of the product shall be 1 meter or more from the ground. It shall be used indoors to avoid water drenching;
2. Please turn off the power and unplug the plug when you do not use the product for a long time;
3. The whole product can not be washed directly with water, only can be wiped with wet towel, and the plug should be pulled out before cleaning;
4. It is strictly prohibited to dismantle or replace any accessories of the product, otherwise the company will not bear all possible consequences arising therefrom;
5. In case of failure, immediately unplug the power plug and cut off the power supply. Do not put the defective product in the working state.
