


Below 30MHz Test Setup



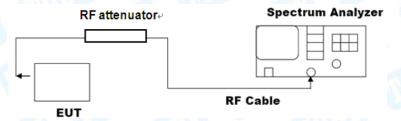
Below 1000MHz Test Setup
