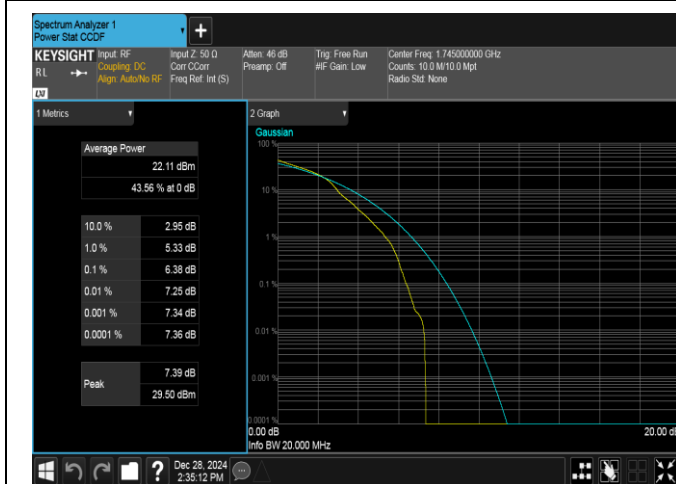
Band4-20MHz-16QAM-20050-100RB#0-PASS



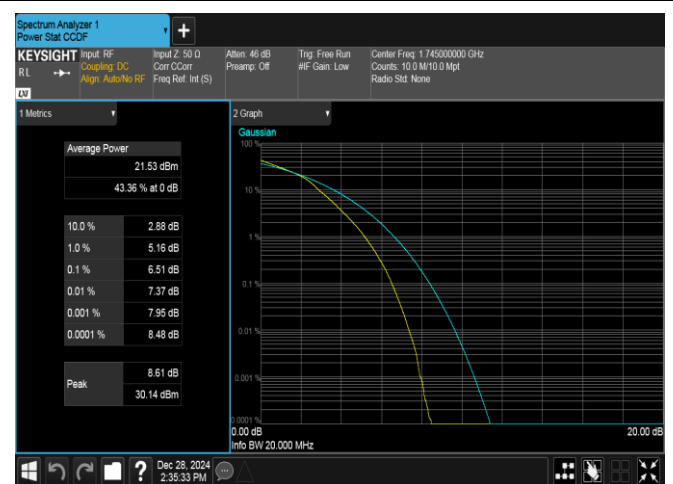

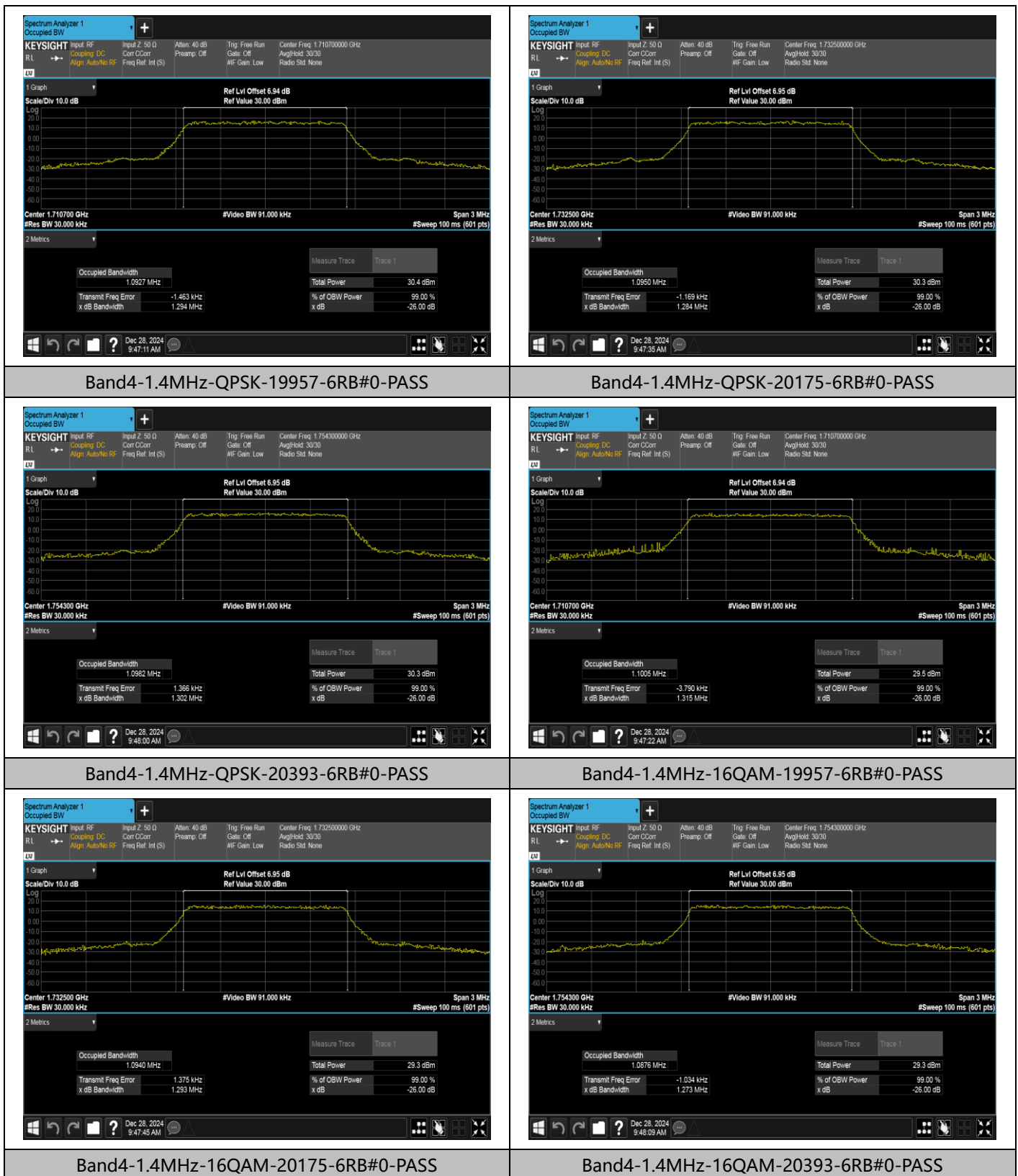
