Band5-1.4MHz-16QAM-20407-1RB#0-Range2:1000~10000MHz

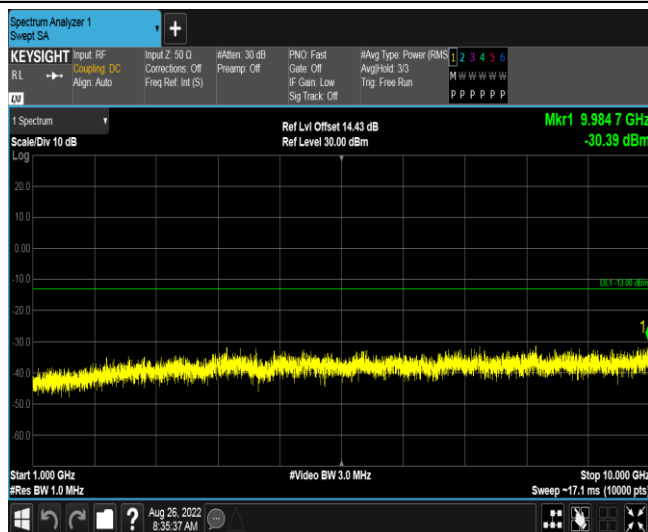
