Band7-10MHz-QPSK-20800-1RB#0-Range1:30~1000MHz

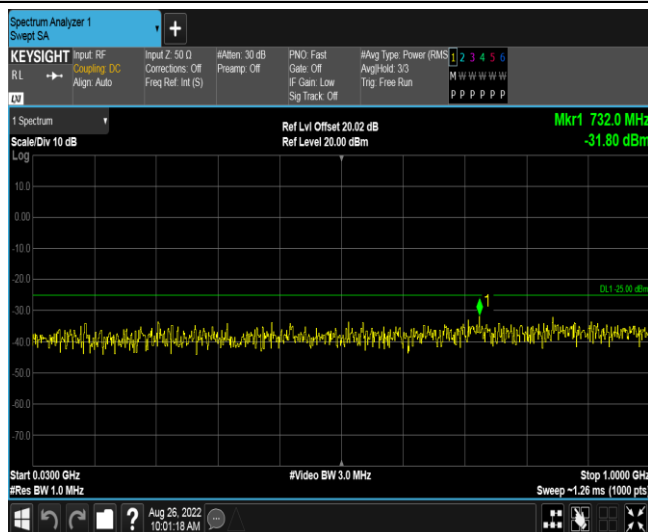
