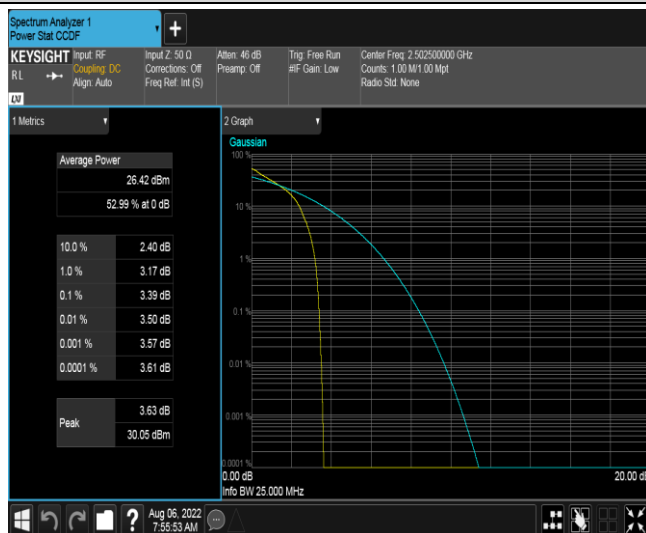

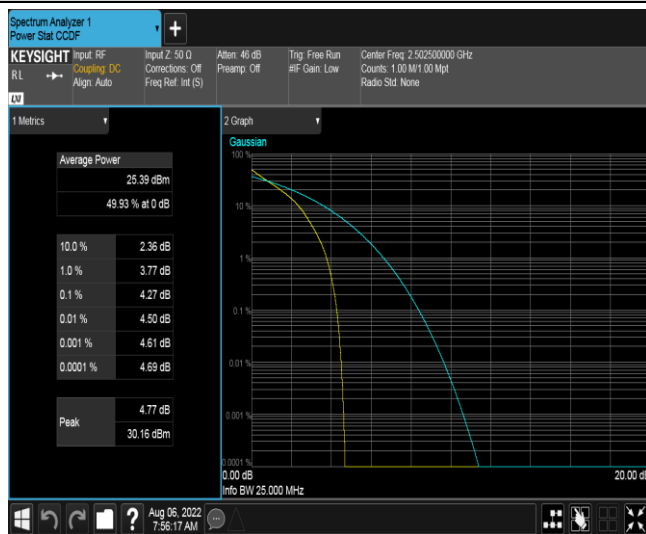

Band7-5MHz-QPSK-20775-25RB#0



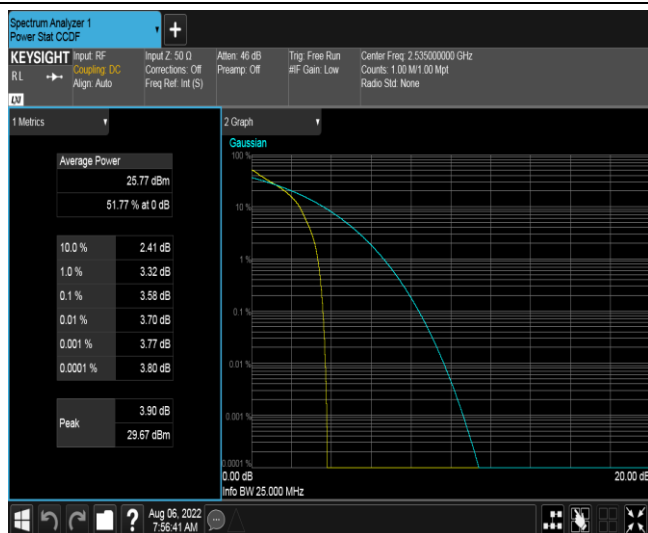

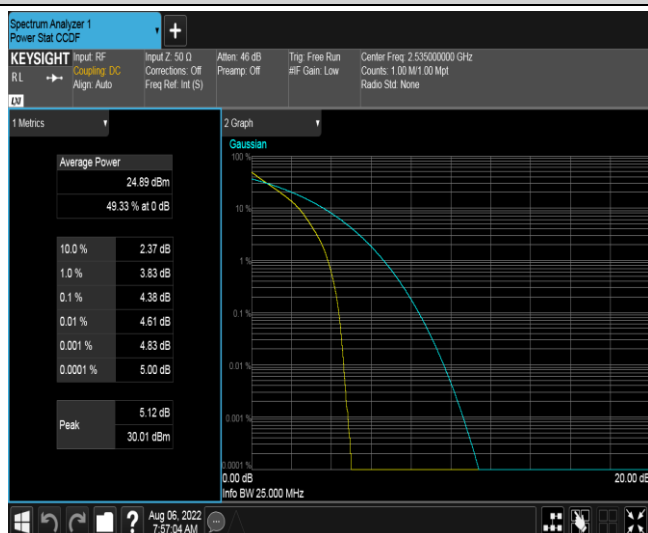

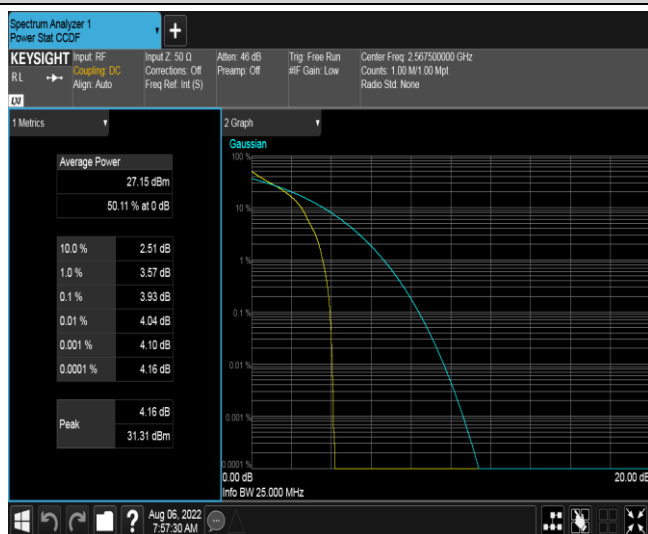

Band7-5MHz-QPSK-21100-25RB#0

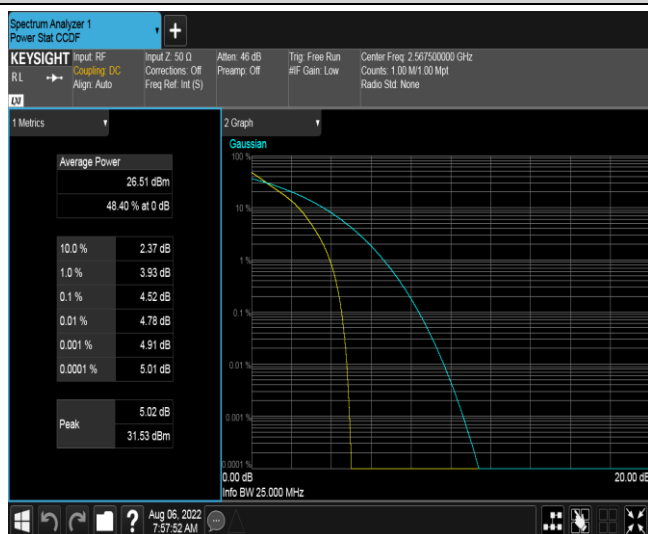


Band7-5MHz-QPSK-21425-1RB#0

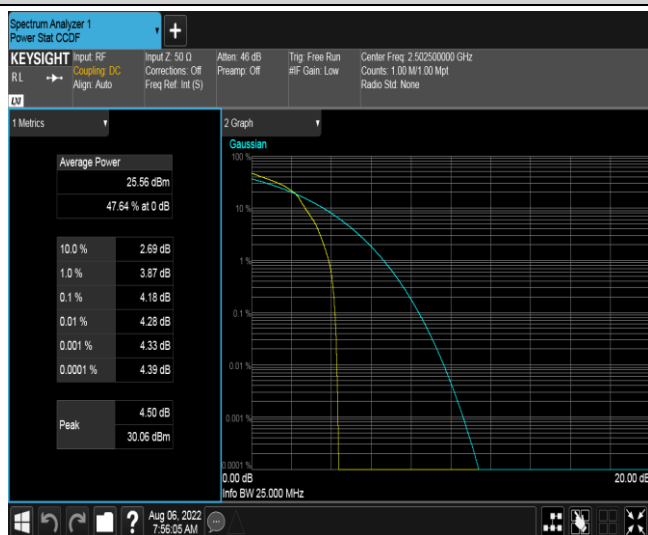

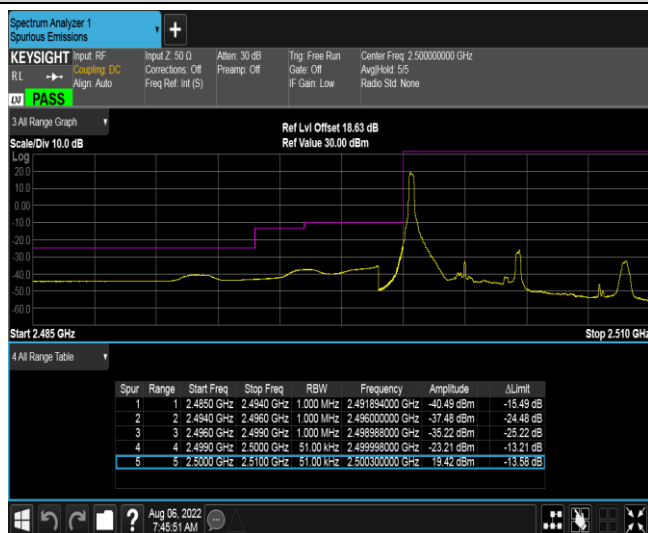

Band7-5MHz-QPSK-20775-25RB#0



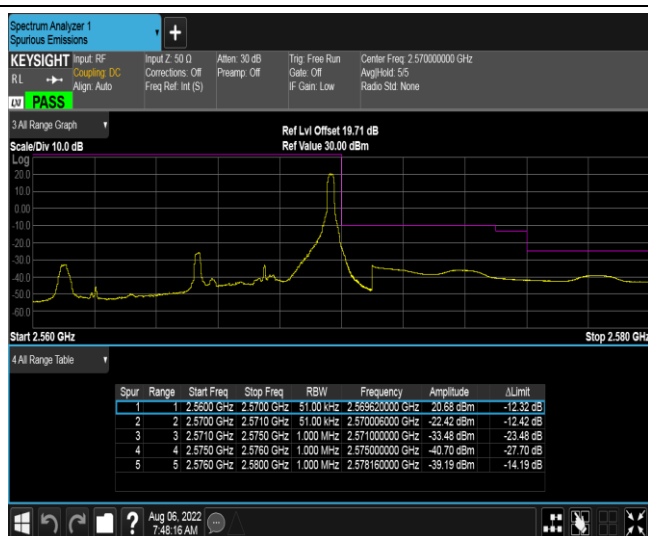

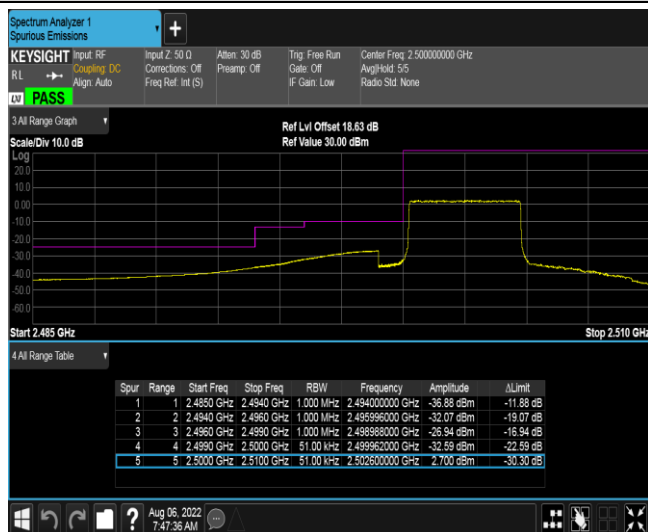


Band7-5MHz-16QAM-20775-1RB#0

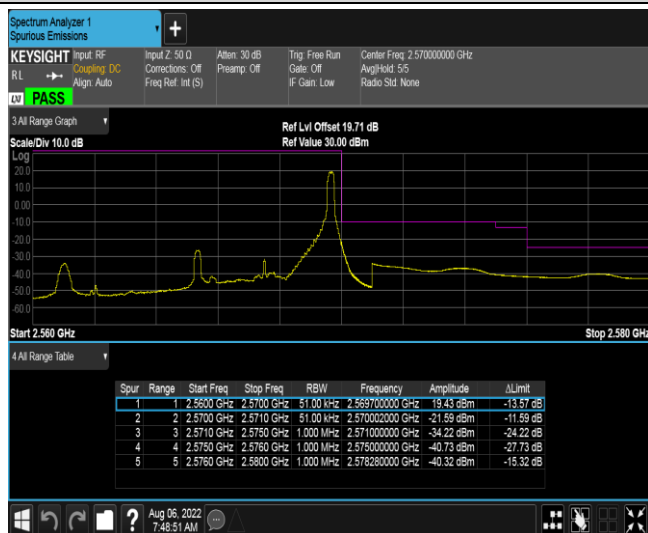
