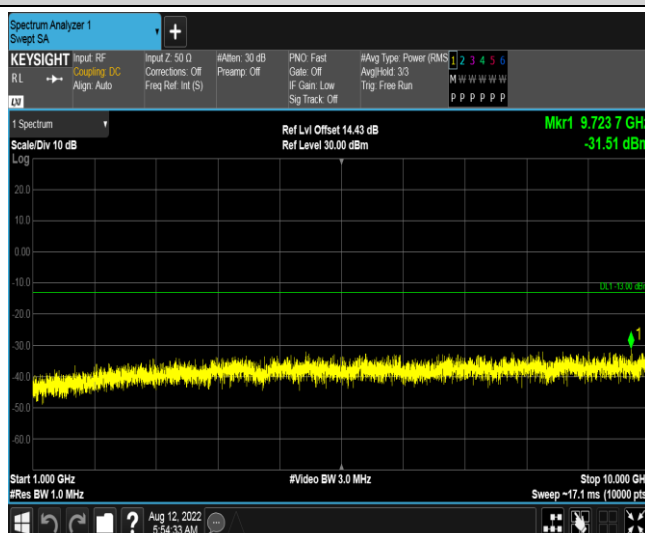

Band26-1.4MHz-QPSK-26797-1RB#0-Range2:1000~10000MHz



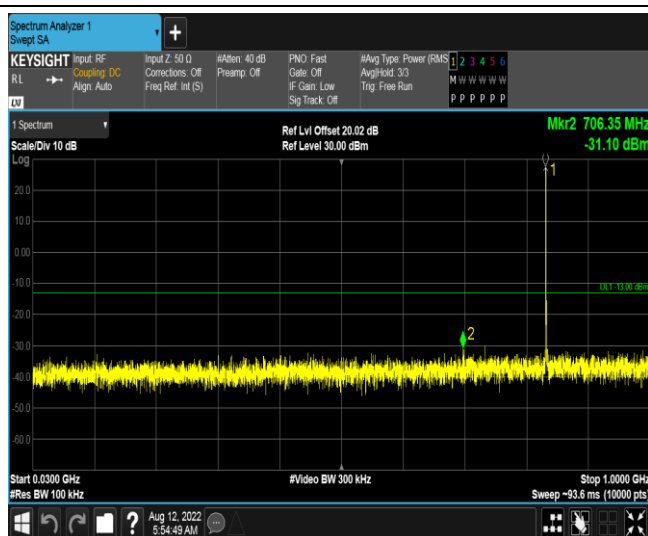

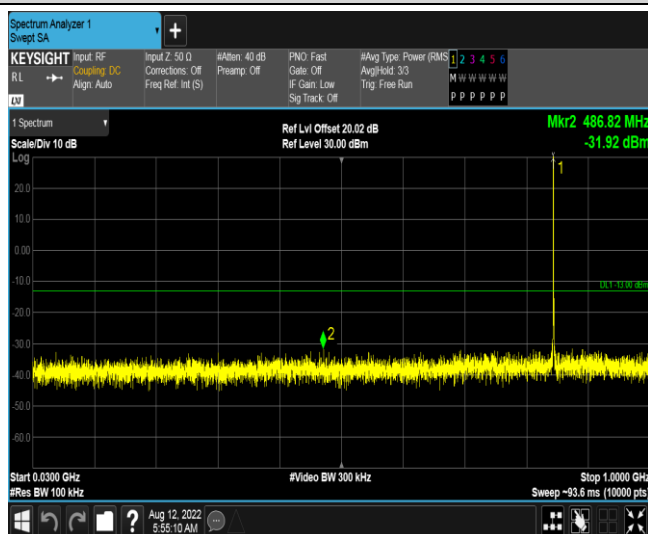

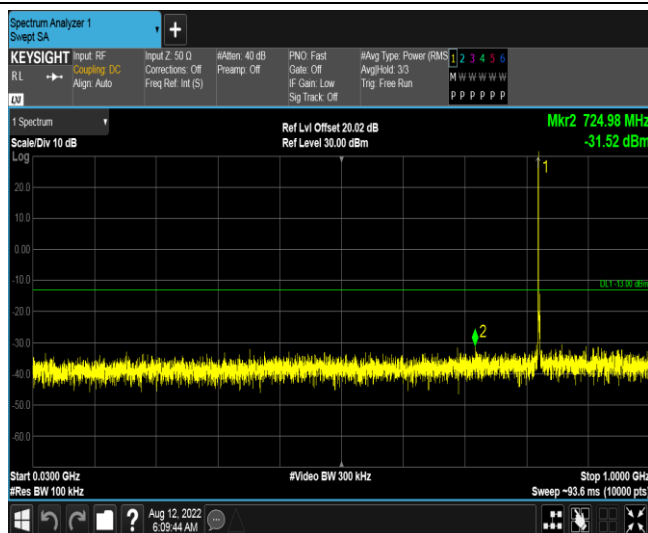
