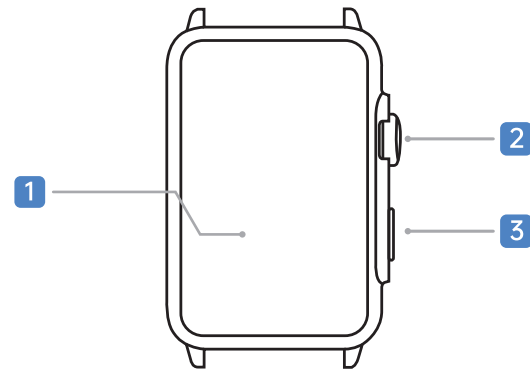


## Product Introduction

## App Download

- 1. You can search for "FITCLOUDPRO" APP in App Store / Google play / App Store / Baidu Assistant to download.
- 2. Open the watch APP download interface, use the scan function, scan to download or scan the QR code attached to download.



Note: After successful download and installation, please follow the interface prompts to register and login for better experience and use of the product.

## Connect

Pair with the watch using the "FITCLOUDPRO" app on your phone.

Connection operation mode: open APP > "Add Device" > Select the bracelet type, and agree to the matching request, you can connect successfully.

Note:  
1. In order to successfully connect the bracelet to the mobile phone, you need to enable the Bluetooth of the mobile phone.  
2. In order to get more accurate weather information, you need to allow the app to access your location.  
3. Please allow the bracelet to receive the information of the phone, otherwise the bracelet will not be able to push the message of the phone.

## Firmware Upgrade

The APP will prompt a new firmware version, and the user can enter the APP interface and select firmware upgrade.

Upgrade Notes:  
1. The upgrade operation can only be performed when the battery of the watch reaches more than 60%.  
2. During the upgrade process, the mobile phone interface will prompt the upgrade progress bar, please do not do any operation on the watch, wait until the mobile phone prompts that the upgrade is successful, and the watch automatically restarts before operating the watch.

## Waterproof Instructions

Waterproof grade: IP67

The waterproof properties of this product are not permanent and may be weakened over time. It can be used for short periods of time, such as hand washing and rain, but does not support hot showers, diving, diving, and surfing. Watch on seawater, acidic and alkaline solutions, chemical reagents and other corrosive liquid does not have waterproof effect.

Supplement: It is not recommended to wear it in a hot bath. Water vapor generated when washing hot water. Its molecular radius is small, and it is easy to seep into the gap of the watch shell. When the temperature drops, it gradually condenses into water drops, thus damaging the circuit board of the watch and damaging the watch.
