# Introduction

Thank you for purchasing the Vivitar Essential Vlogging Kit, item VIVVLTR50KIT. Start or enhance your vlogging experience with this multi-piece set. Please read this manual carefully before setting up and using the ring light.

11. Do not use this product outside.

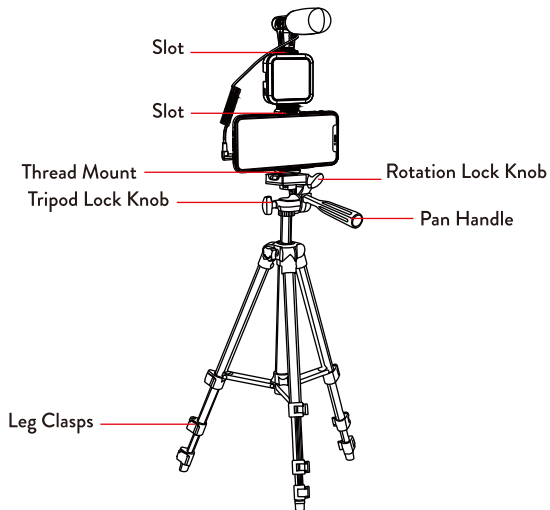

# Ring Light Set-Up



# Tripod Set-Up

1. Expand the legs of the tripod, placing it on a flat surface. Turn the tripod's lock knob clockwise to lock the legs into place.
2. Extend the leg's length by unclasping the three clips on each leg. Once extended, close the clips so the legs are locked into place.
3. Attach the included phone cradle onto the tripod's thread mount.

## Attachments:

1. To use the light, insert three AAA batteries into the battery compartment. Twist the gear upward and slide it into the slot on top of the phone cradle. To use, press the power button on the back.
2. To use the boom mic, insert one AAA battery into the compartment. Twist the gear upward then slide it into the slot on top of the light.
3. To use the included GoPro mount, screw it onto the tripod's thread mount.

# Using the Wireless Remote

1. Push the power switch on the top of the remote On.
2. On your phone, go into the Settings app and in the Bluetooth page. Make sure Bluetooth is On before connecting to the available device that corresponds with the product.
3. Bluetooth pairing Name: AB Shutter3
4. Once connected, press the shutter button on the remote to take pictures wirelessly.

## WARNING
