## Common questions and solutions about eye massager

1. The sound is heavy in massaging?

Answer: The pressing and contracting of the air bag is a process of repeatedly charging and deflating the air bag by the pump. In the process of charging and deflating, the sound of rapid going in and out of the air bag is normal.

2. After massaging, your eyes were blurred?

Answer: When closing eyes to massage for a long time, eye muscles are relaxed, it needs to adapt to the light when opening eyes. If you start the hot compress, eye blood flow will speed up, becoming blind, this is a normal phenomenon and can be alleviated in a short time.

3. The massager doesn't fit the face perfectly?

Answer: The proper gap is to reserve space to inflate the air for the balloon. If the fit is too tight, the balloon will compress the eye after inflated, which will make eyeball uncomfortable.

#### 4. How to clean the flannel liner?

Answer: It's advised to wipe thoroughly after spurt wet paper towel hind with the medical alcohol. Wipe clean and stay for 10-15 minutes. Use it till the alcohol is completely evaporated.

#### 5. How long and how often should it be used?

Answer: it is advised to use 1-2 times a day and 15 minutes each time. Appropriate time and frequency can massage the eyes in full while also avoiding revised effect of the excessive long-term massage eyes acid.

## Key operation

1. Speaker port
2. On-off key
3. Slide touch function mode to switch key
4. Charging interface/mark outlet
5. Retractile buckle



## Product function

Please remove your contact lens, hair clip and hair accessories to avoid discomfort before use. Do not operate the product when your hands are wet.

Preparation before use:

Start: Long press switch for 2 seconds and it will start.

Shutdown: In the state of power on, long press the switch key for 2 seconds, or send voice command “please shutdown” and it will shut down.

Restore factory settings: long press “switch key” to connect USB interface for power, continue long press for 10s to restore the strength adjustment, volume adjustment and the factory default settings.

## Warning sign

Power indication: When the power is lower, the red light of the switch key will flash; The red light will flash when the voice prompt that power is

lower and charging; The white light is always on when the power is full. In the process of charging, the product cannot work. Charging time is 2-3 hours.

## Use method

Mode switching: Right hand slide to the right back (or left front) side, the function mode will switch

**Mode 1: Standard eye massage mode (air pressure + hot compress + music + timing)**

Open the air bag for massaging, hot compress, play the music, start the 15-minute for timing massage. This model is the standard massage model, which is suitable for daily eye massage.

**Mode 2: Enhanced eye massage mode (air compress+ vibration + hot compress+ music +timing).**

Switch to Mode 2, start the airbag massage, vibration massage, hot compress, play music, start 15 minutes timing massage. This model is suitable for long-time work, study, driving and other eye fatigue when the eye massage care.

**Mode 3: hot compress eye massage mode (hot compress+ music +timing)**

Switch to Mode 3, turn on the heat compress, play the music, and start the 15-minute timing massage. This model is suitable for light eye massage during the intermission of work, study, driving and so on.

**Mode 4: Sleep eye massage mode (hot compress + sleeping music +timing)**

Switch to Mode 4, turn on the heat compress, play sleep music, and start a 15-minute timing massage. This model is suitable for eye massage at the night rest, travel rest, relax before the nigh sleeping.

**Mode 5: Massage eye massage mode (air pressure+ timing)**

Switch to Mode 5, open the airbag massage and start the 15-minute timing massage. This model is suitable for light eye massage during the intermission of work, study, driving and so on.

**Mode 6: Acupoint eye care mode (vibration +pressure +hot compress+ timing)**

Switch to Mode 6 and start the acupoint massage function hot compress and start the 15-minute timing massage. This model is suitable for light eye massage during the intermission of work, study, driving and so on.

**Strength adjustment:** Press the switch key 2 times in a short way continuously, you will hear the voice prompt “you have entered the strength adjustment mode”. Right hand slides to switch the function mode toward the right (or the left front) side, massage strength changes from Gear1-5, the greater the number is, the greater the strength will be. Stop operation for 10 seconds and then exit strength adjustment mode.

**Volume adjustment:** press the switch key 3 times continuously in a short way, and you will hear the voice prompt “you entered the volume adjustment mode”. Right hand slides the function mode switch key toward the right (or left front) side, volume change from Gear 1-5, the greater the number is, the greater the volume will be. Stop operation for 10 seconds and then exit volume adjustment mode.

**Bluetooth connection:** Open your phone or computer Bluetooth to search for Bluetooth device. You can find Bluetooth device “Intelligent AI

Eye Massager”; Click to complete the pairing and you’ ll be able to play music via Bluetooth.

## Fault repair

If the failure happens during operation, please perform the following checks. If the failure cannot be eliminated or the product is still not ideally operated, please cut off the power to professional and technical personnel for maintenance. Please do not disassemble this product!

## Steps on battery dismantling
