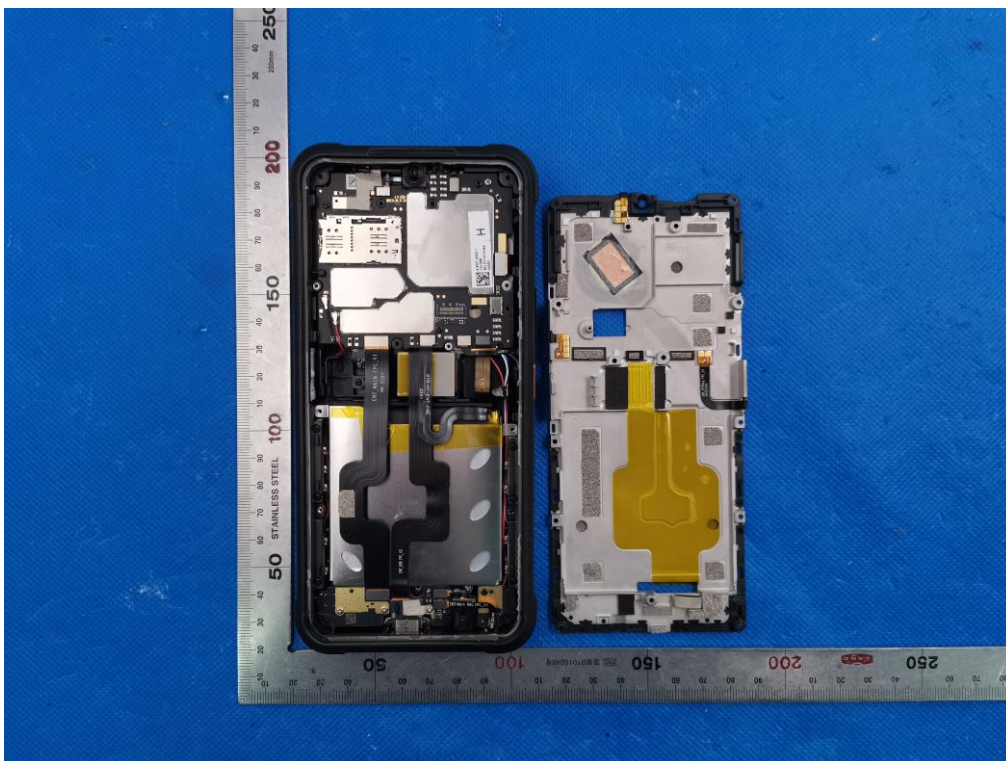

OPEN VIEW OF EUT(FIGURE 1)

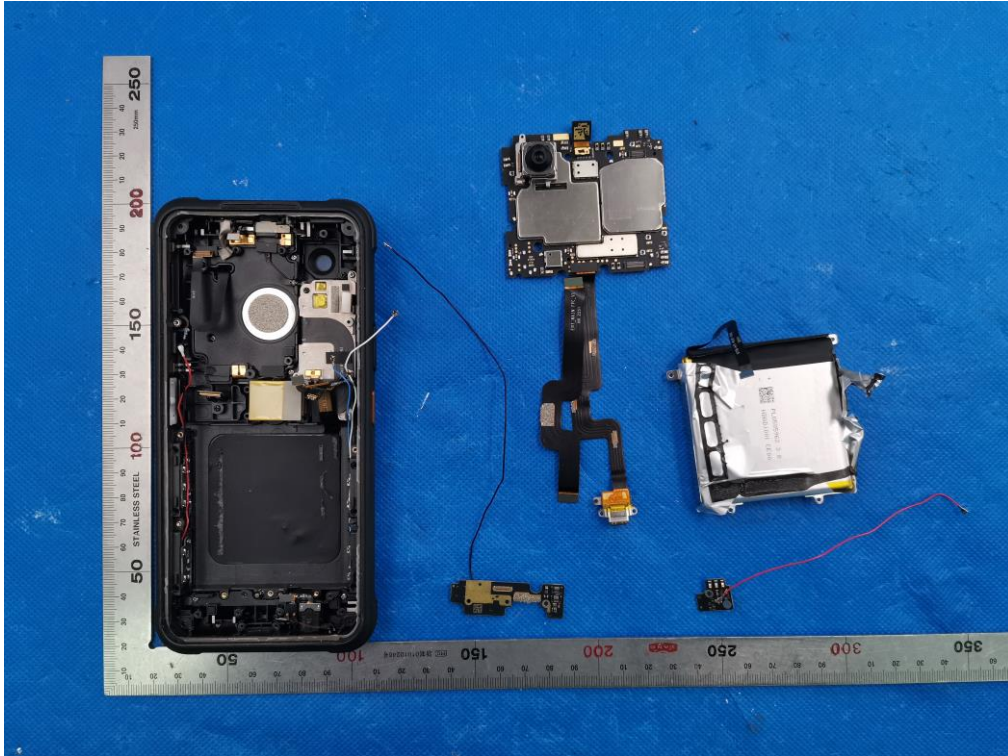


OPEN VIEW OF EUT(FIGURE 2)

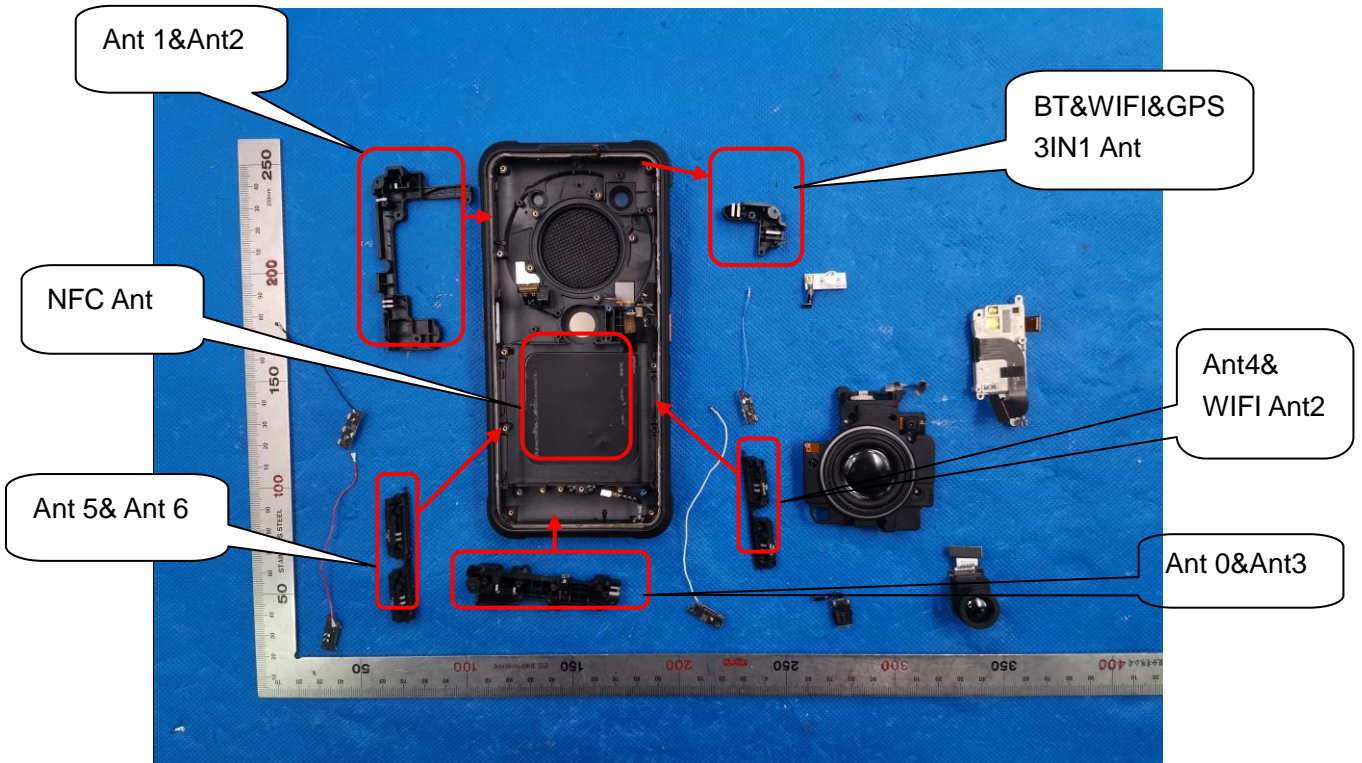

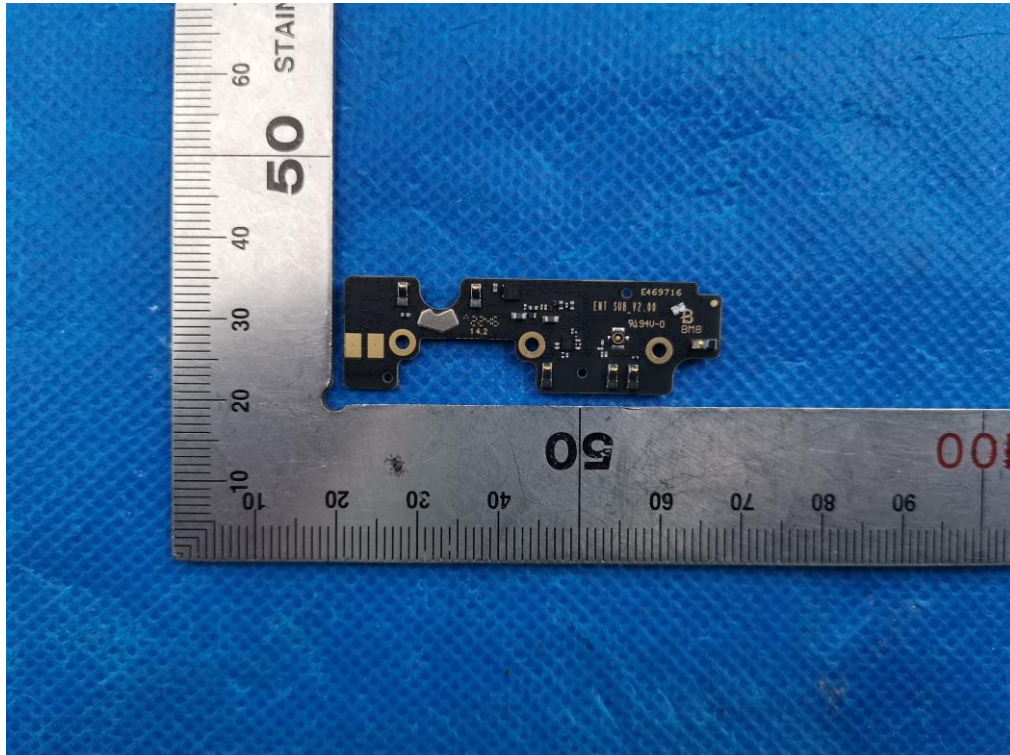

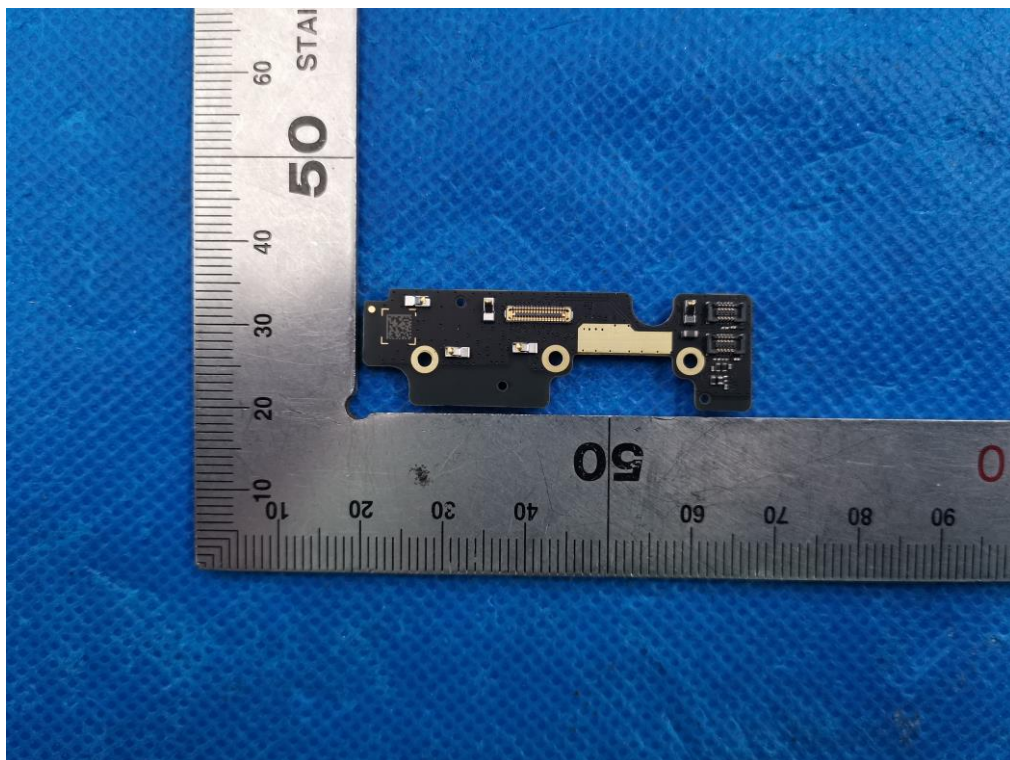

INTERNAL VIEW OF EUT(FIGURE 1)

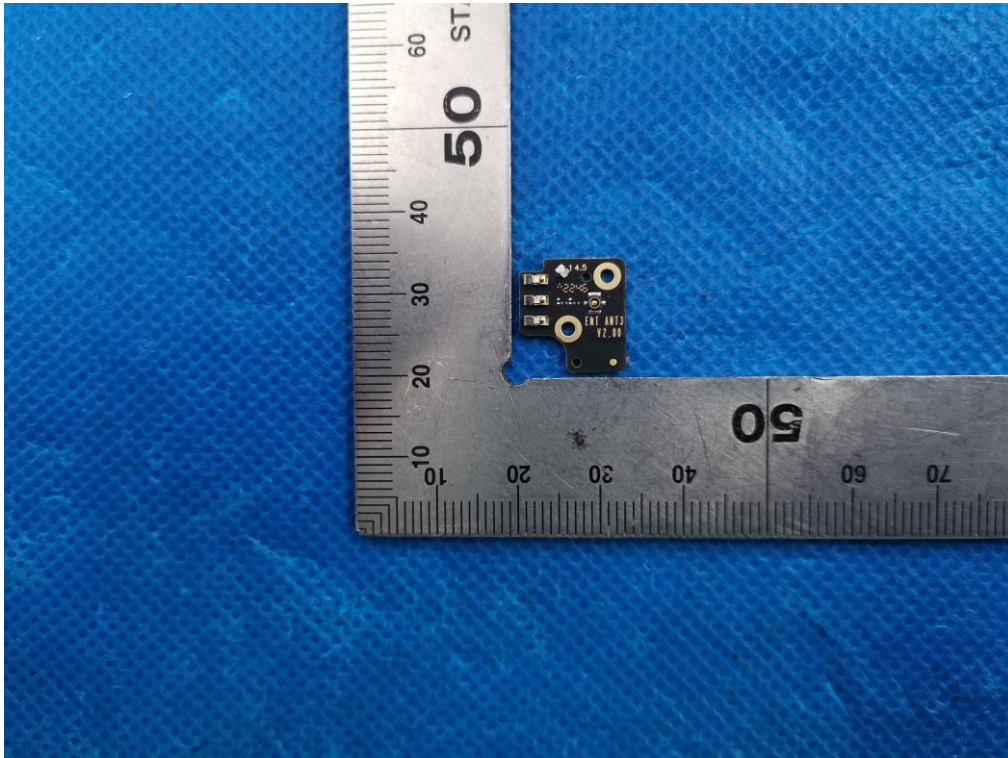


INTERNAL VIEW OF EUT(FIGURE 2)

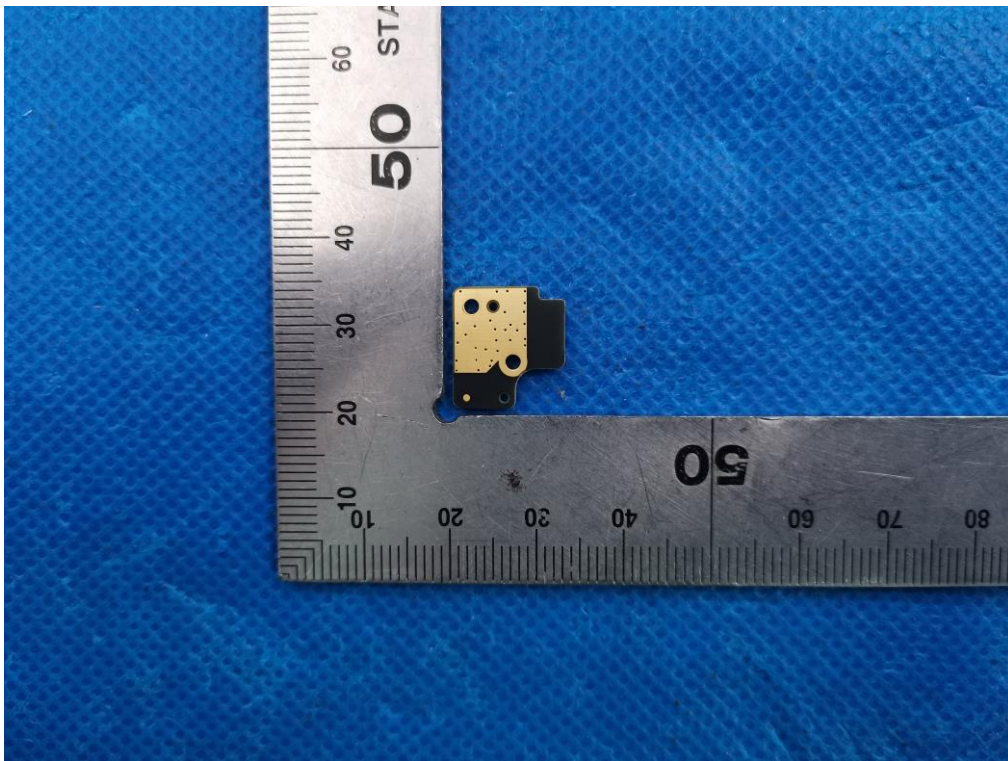

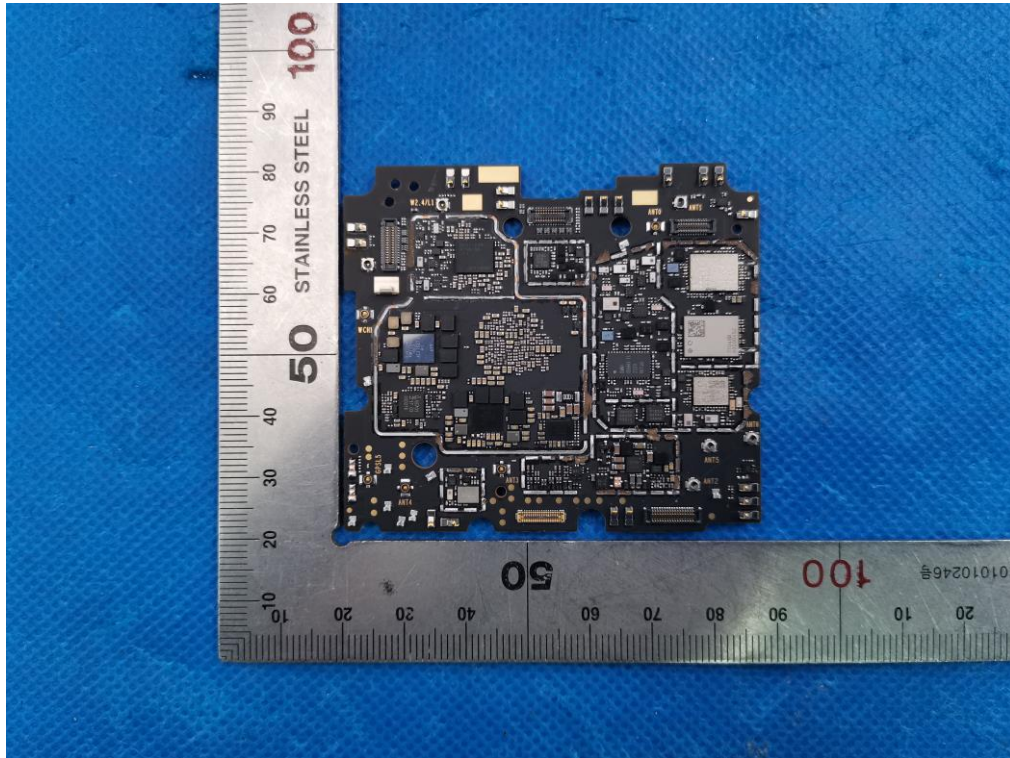

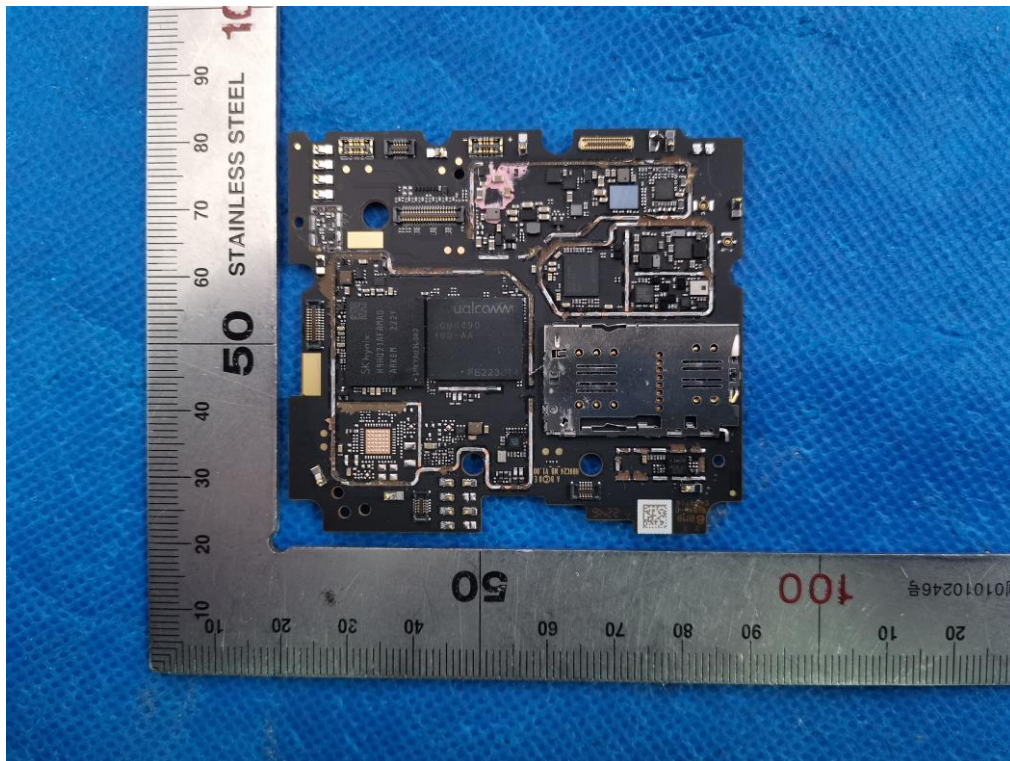

INTERNAL VIEW OF EUT(FIGURE 5)

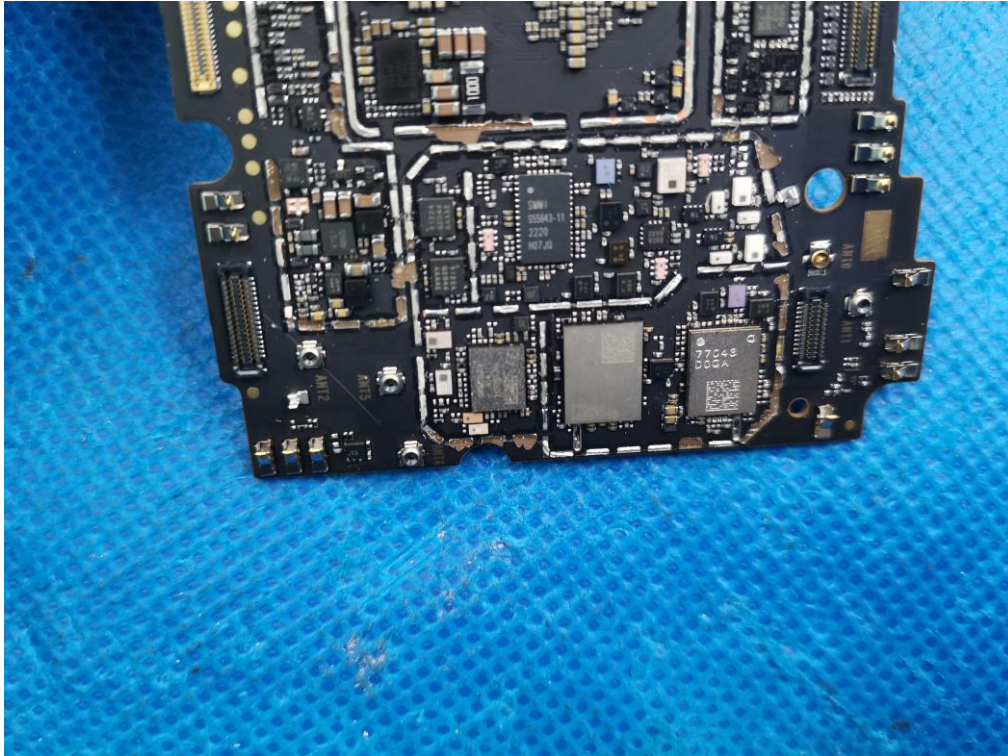
