For peak power test:

1. Connect EUT RF output port to the Spectrum Analyzer through an RF attenuator
2.  $RBW \geq DTS$  bandwidth
3.  $VBW \geq 3 * RBW$ .
4.  $SPAN \geq VBW$ .
5. Sweep: Auto.
6. Detector function: Peak.
7. Trace: Max hold.

Allow trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. The indicated level is the peak output power, after any corrections for external attenuators and cables.

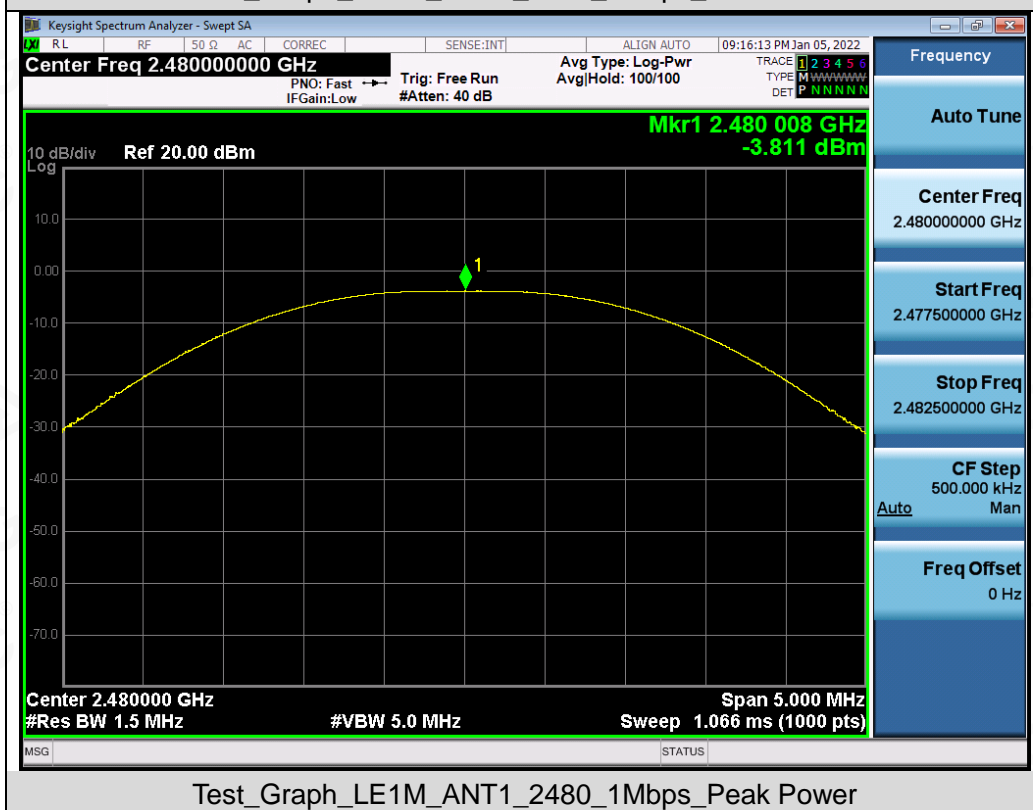
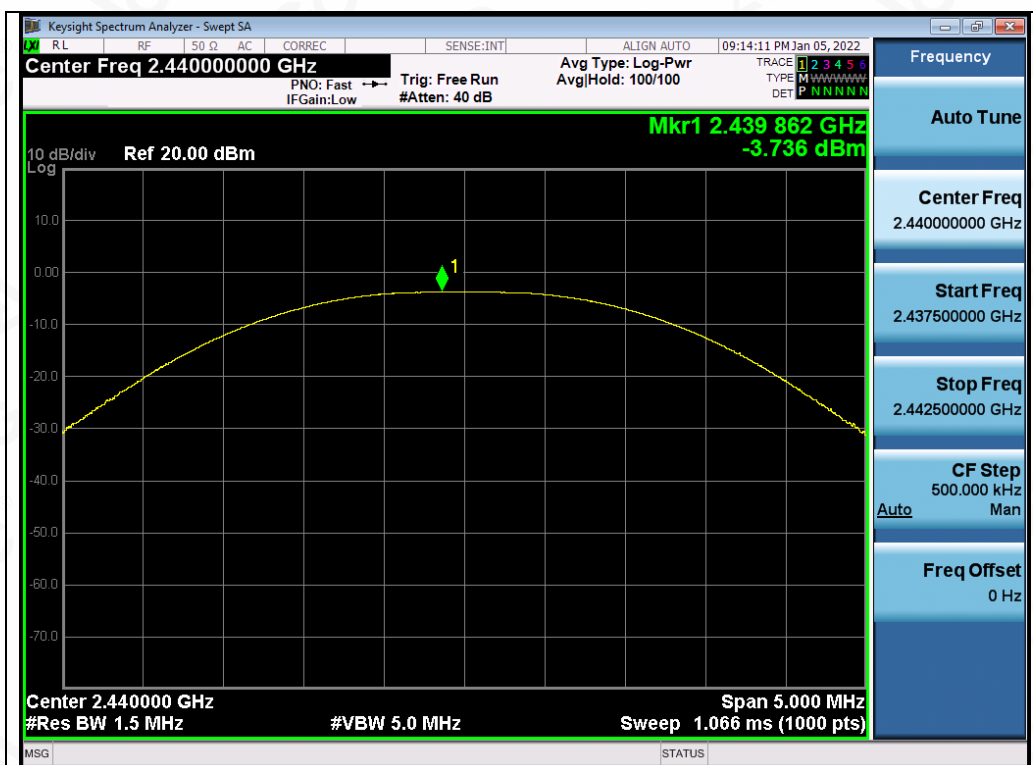
### Test Graphs of Conducted Output Power

Test\_Graph\_LE2M\_ANT1\_2402\_2Mbps\_Peak Power

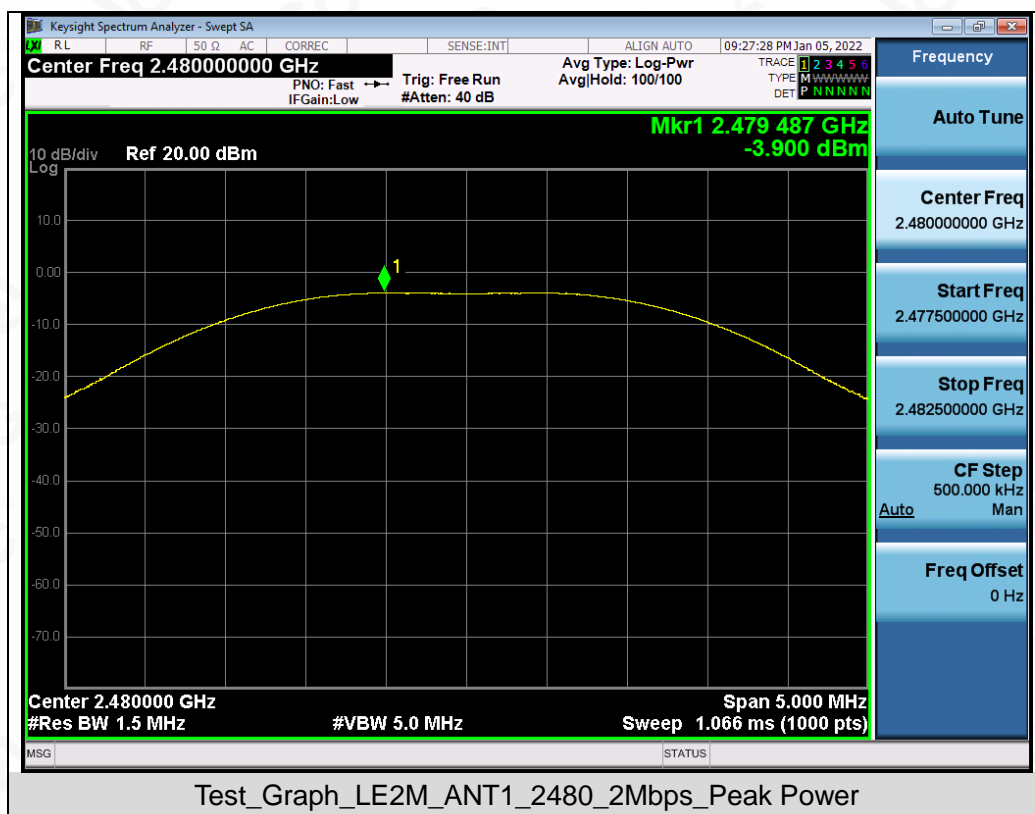


Test\_Graph\_LE2M\_ANT1\_2440\_2Mbps\_Peak Power

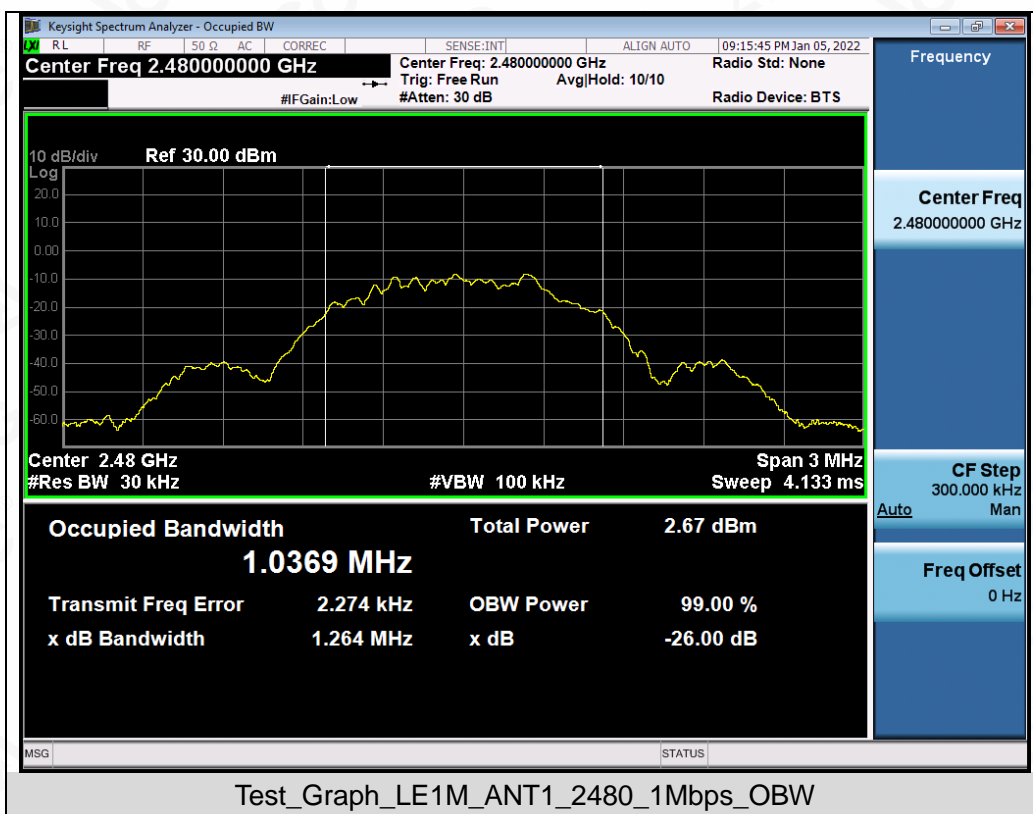

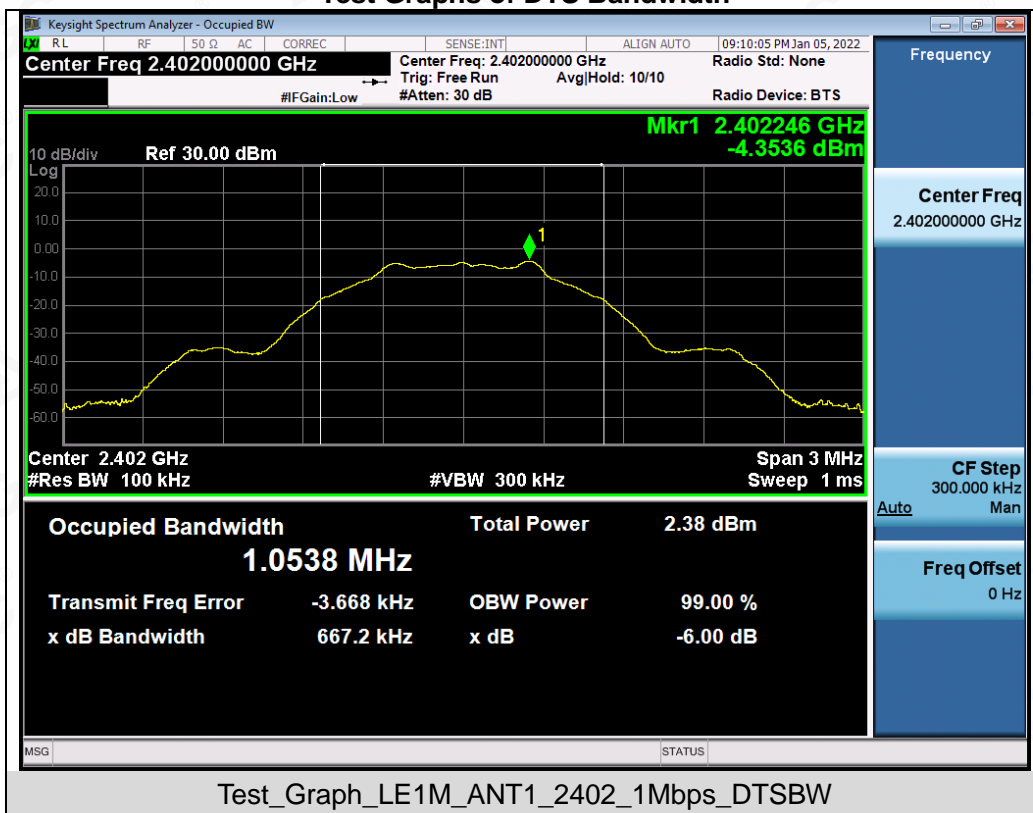

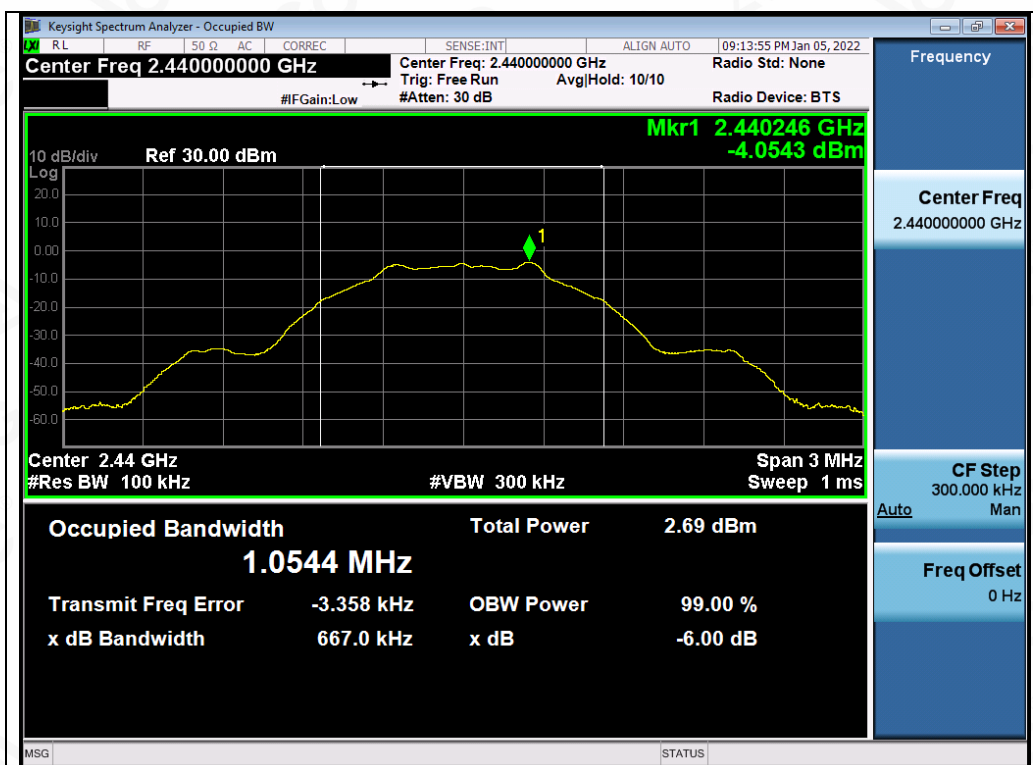
Test Graphs of DTS Bandwidth



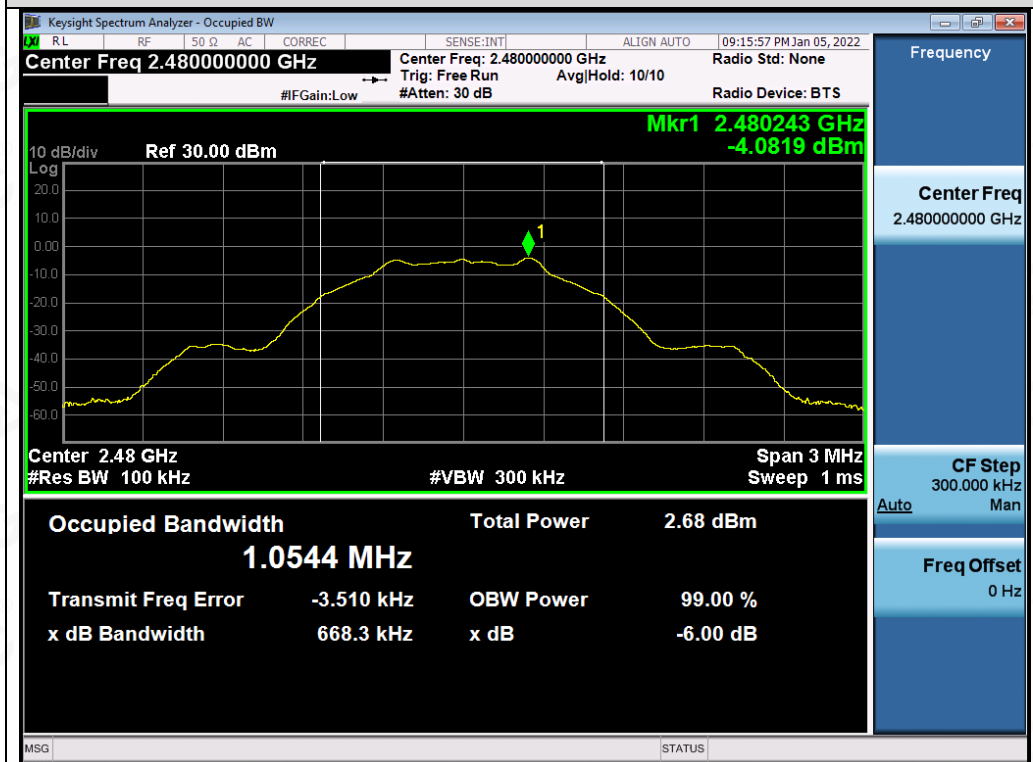

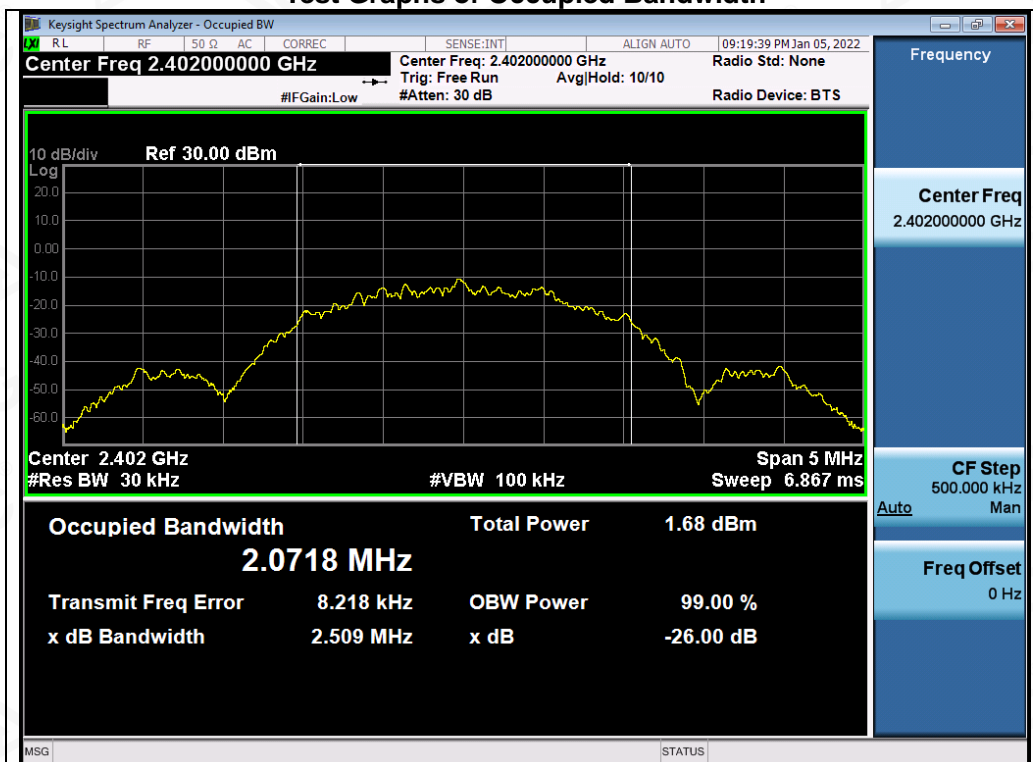

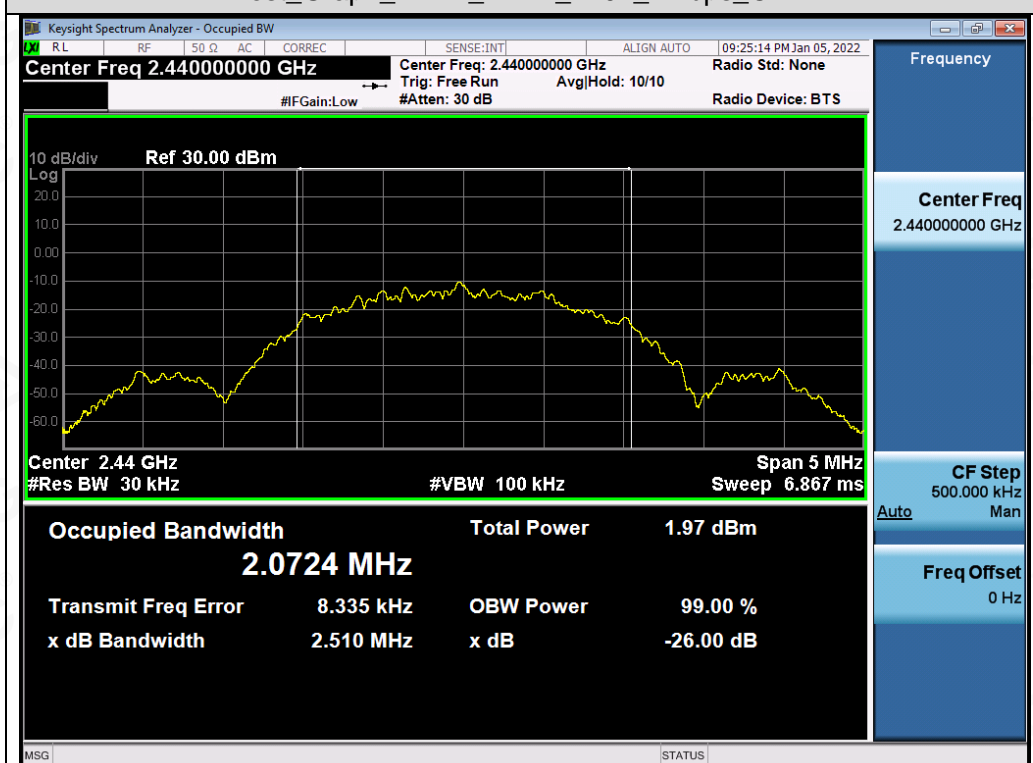




### Test Graphs of Occupied Bandwidth

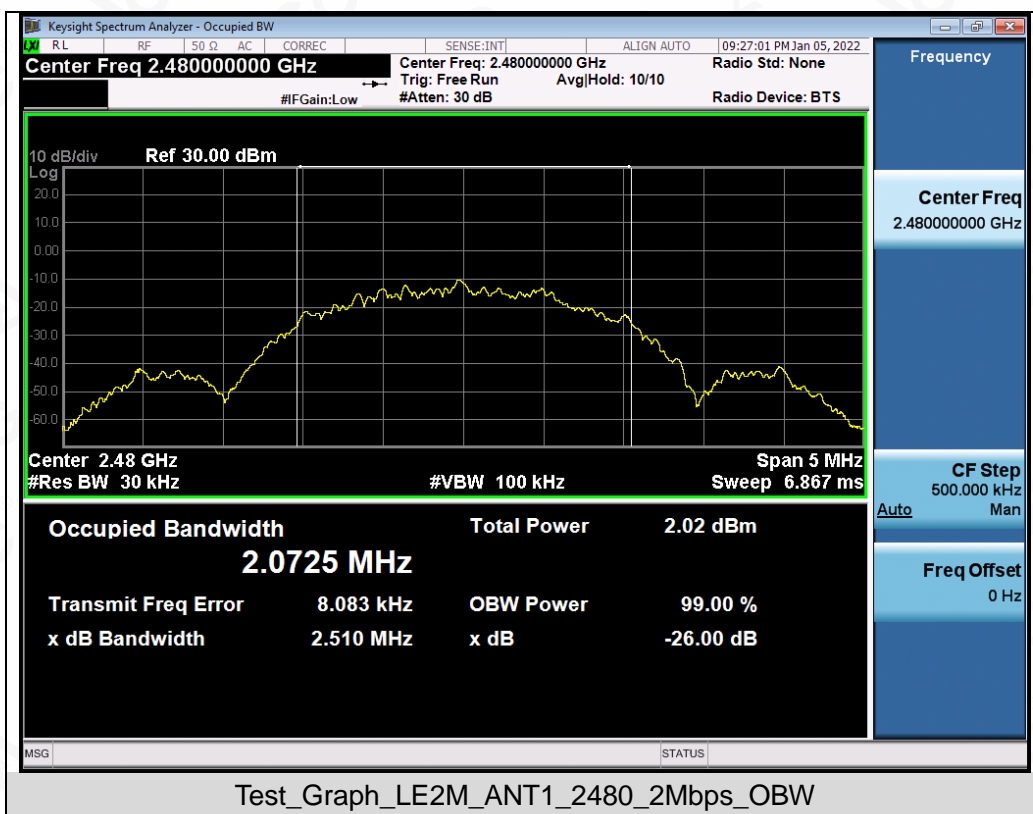

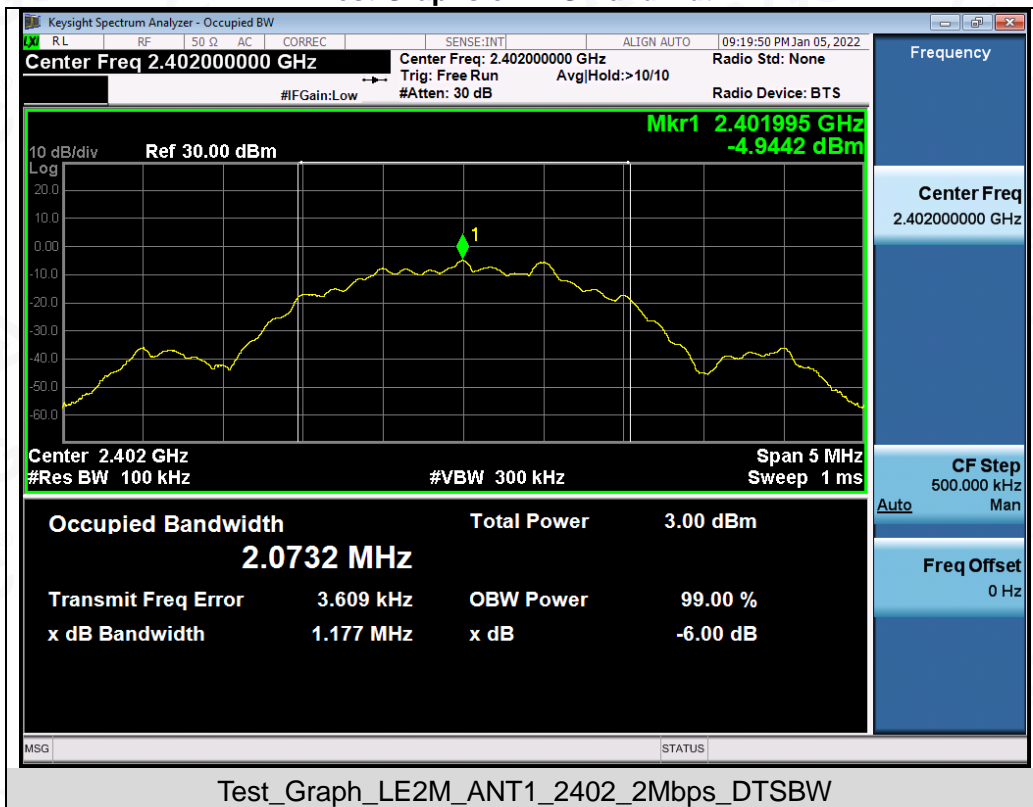

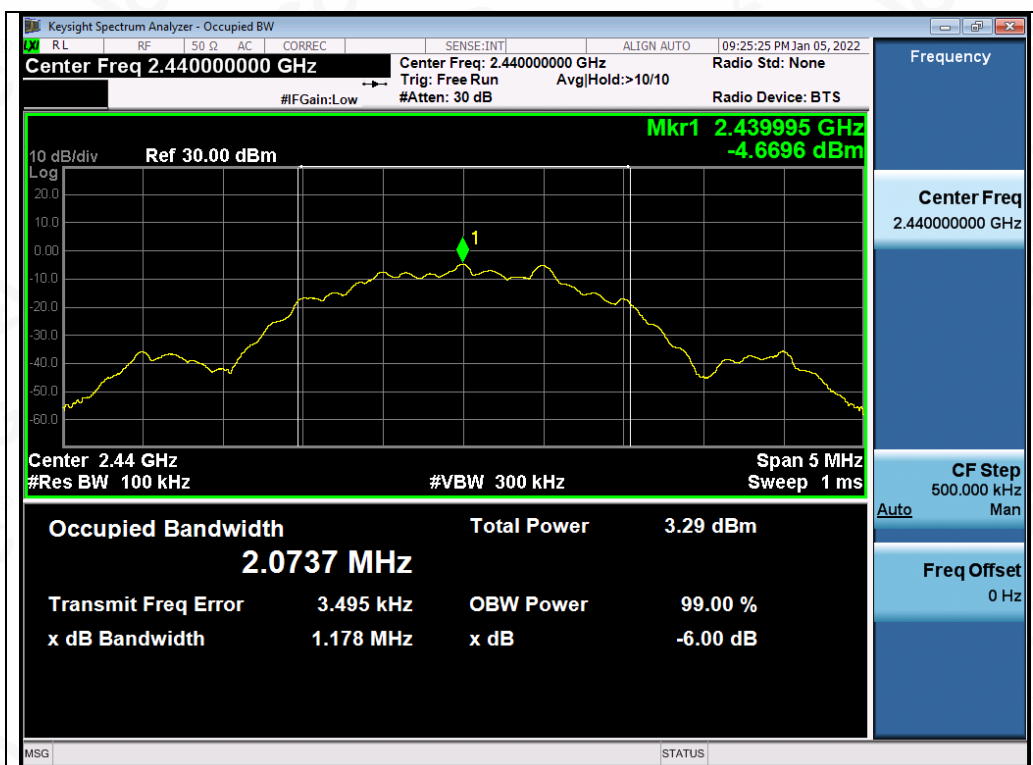
### Test Graphs of DTS Bandwidth



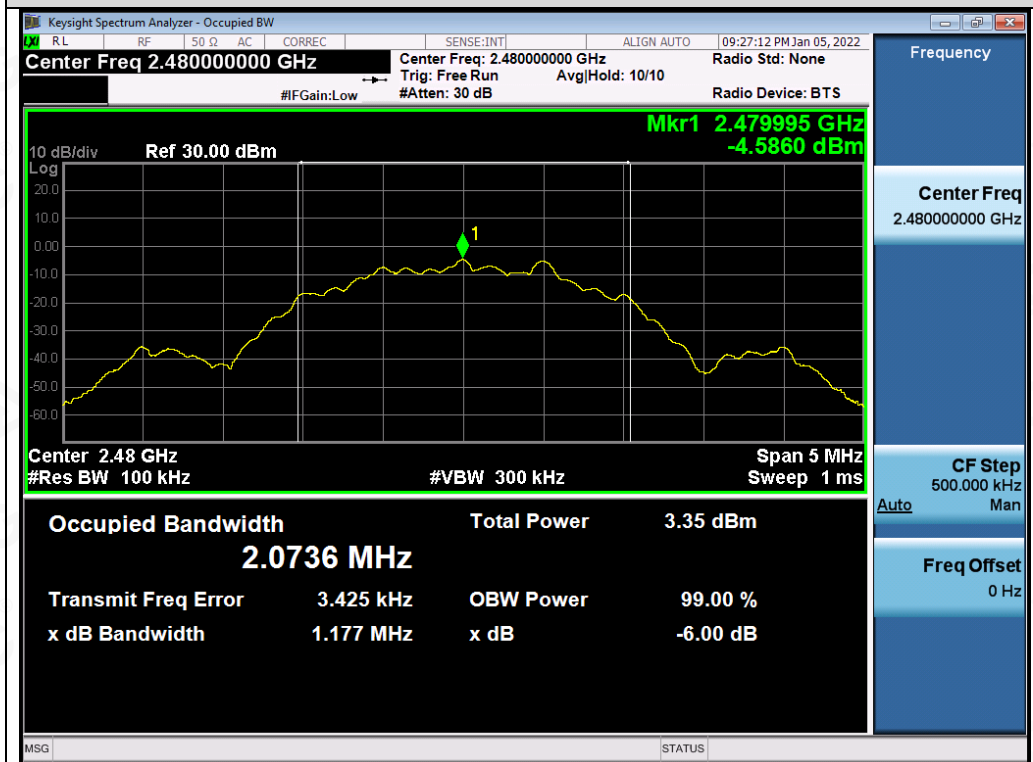

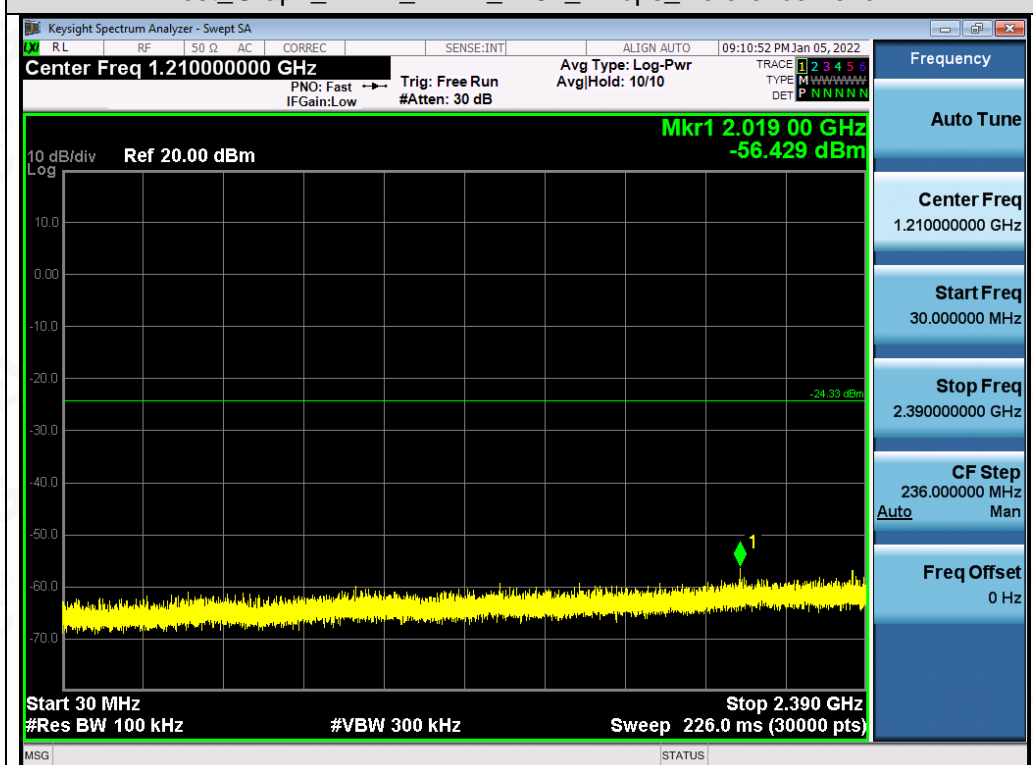




### Test Graphs of Spurious Emissions in Non-Restricted Frequency Bands-1M

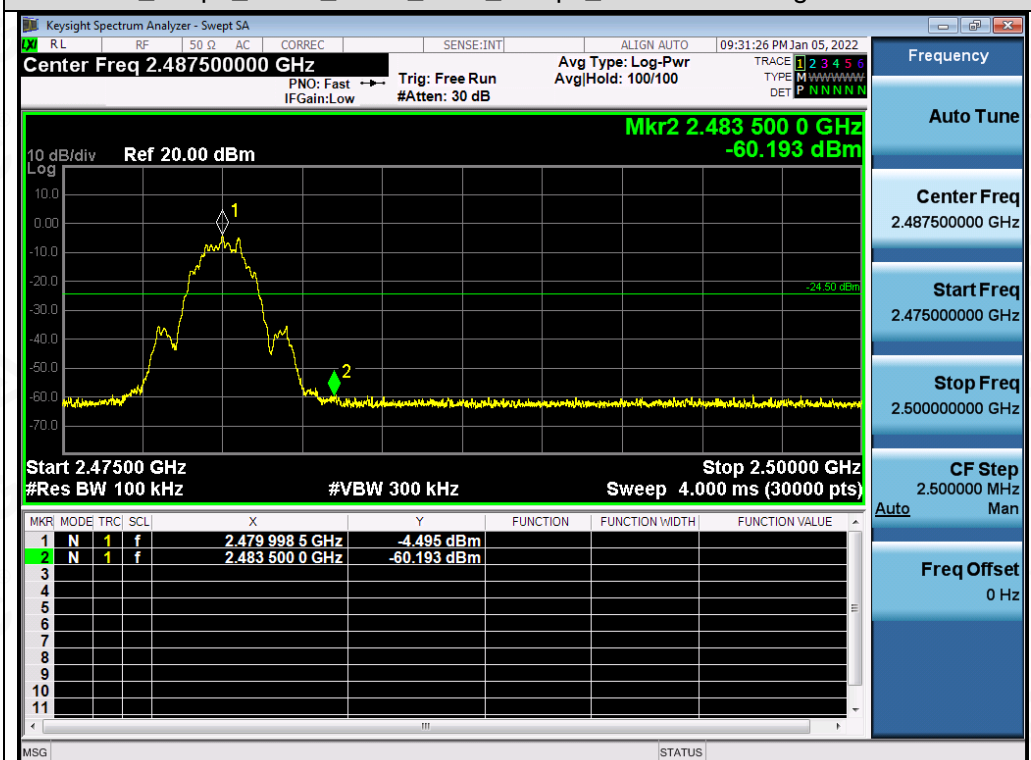




### Test Graphs of Band Edge Emissions in Non-Restricted Frequency Bands-2M
