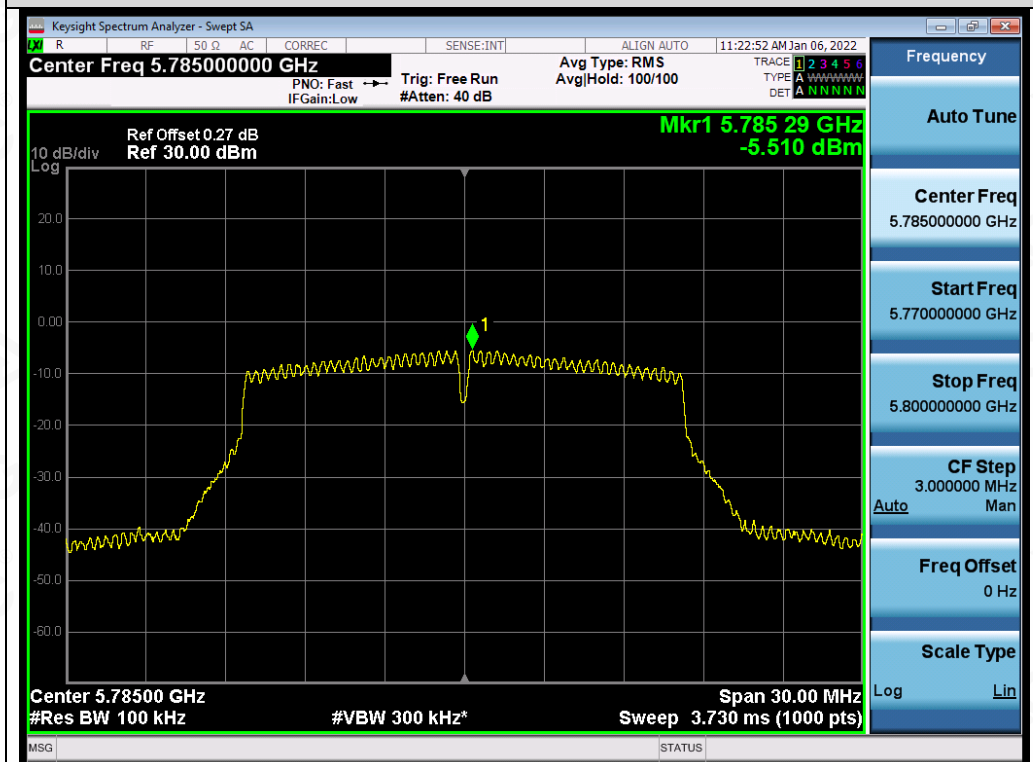

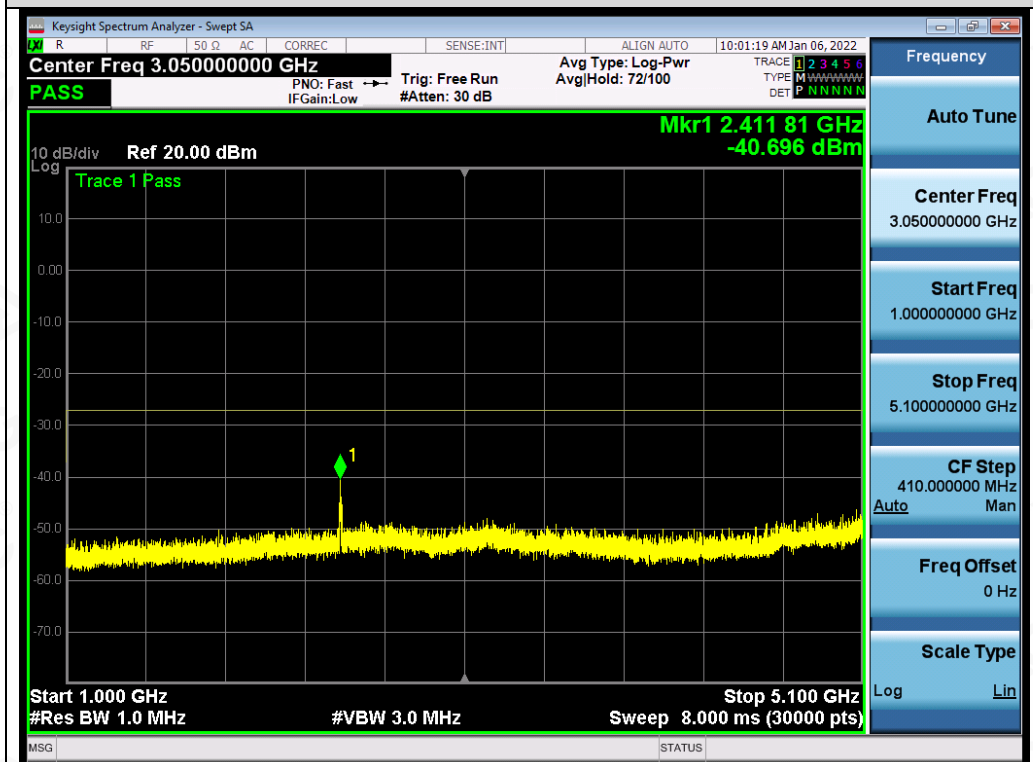

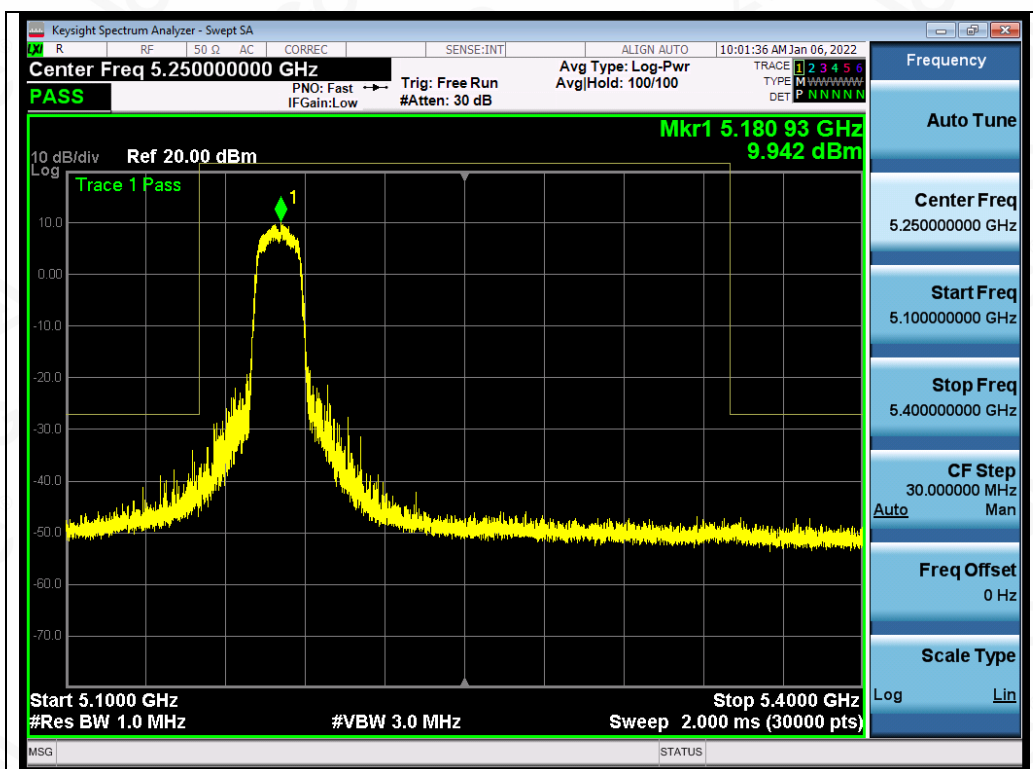

Test_Graph_802.11a_ANT1_5180_6Mbps_Frequency Band 3

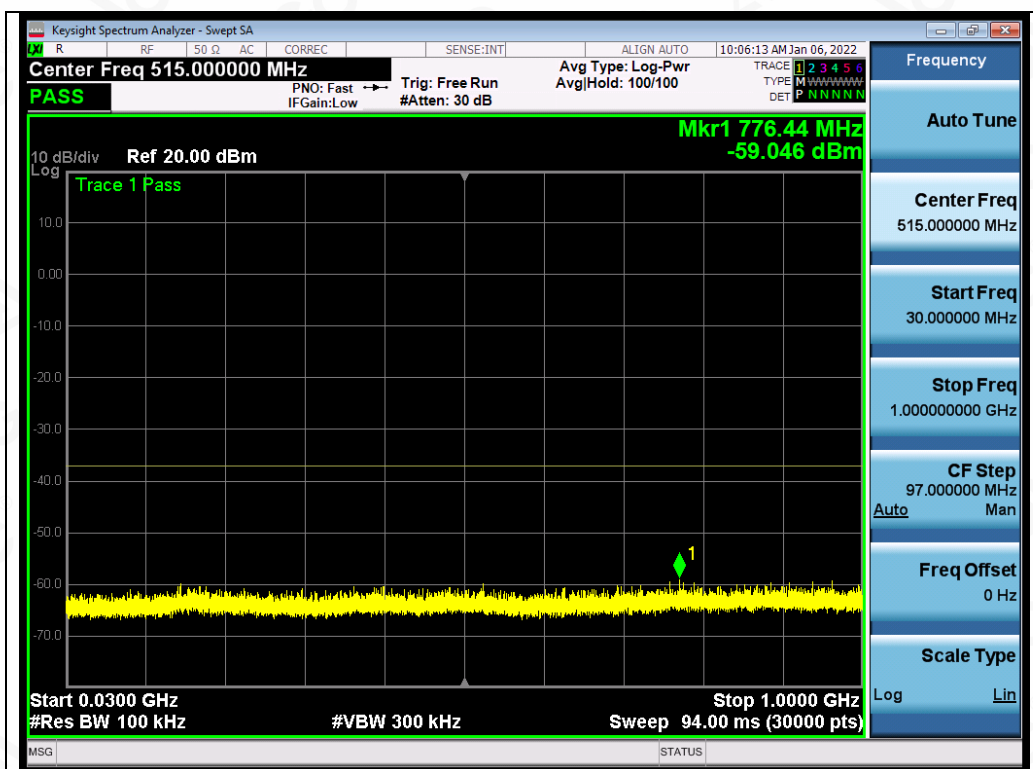

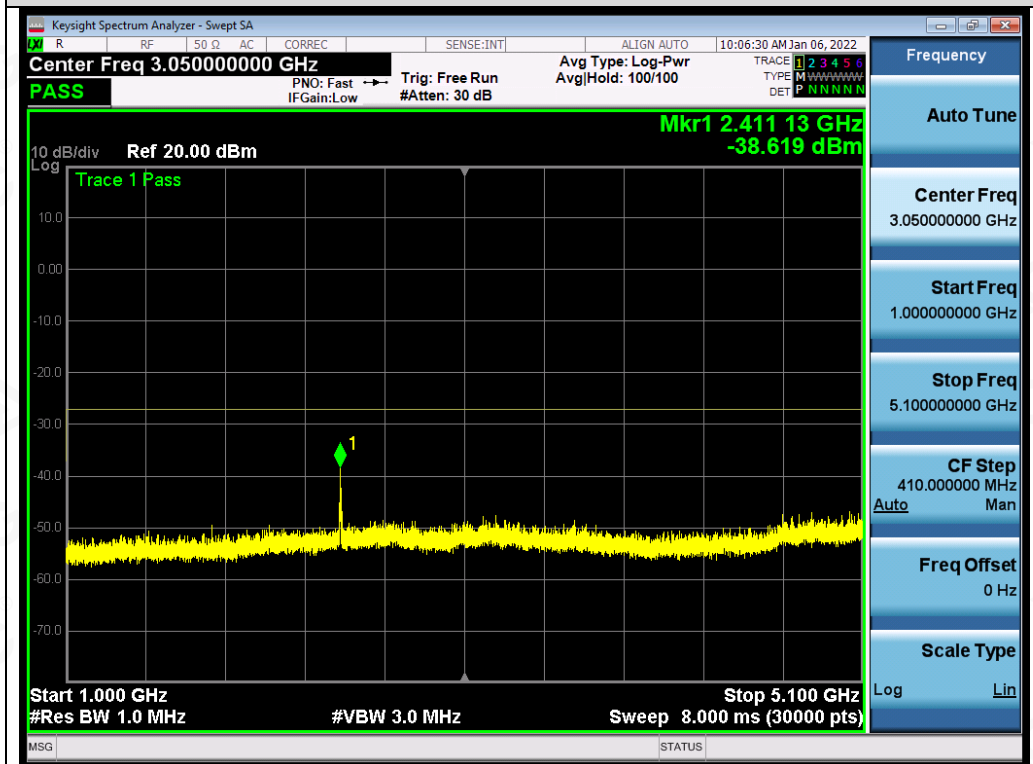

Test_Graph_802.11a_ANT1_5240_6Mbps_Frequency Band 1

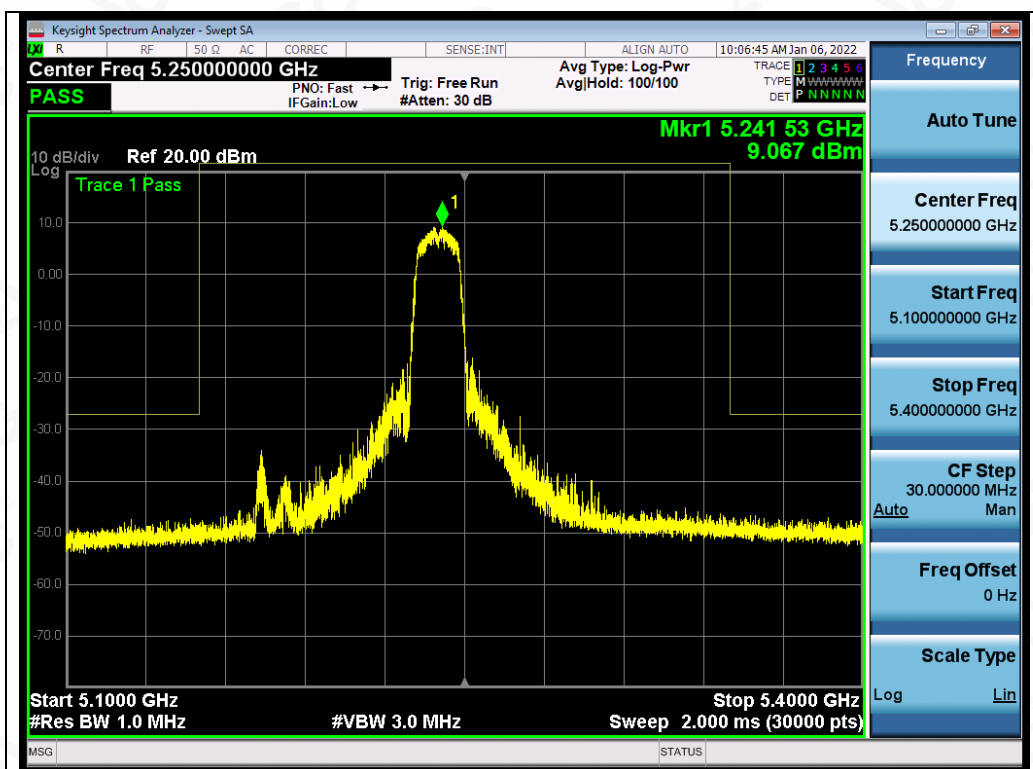

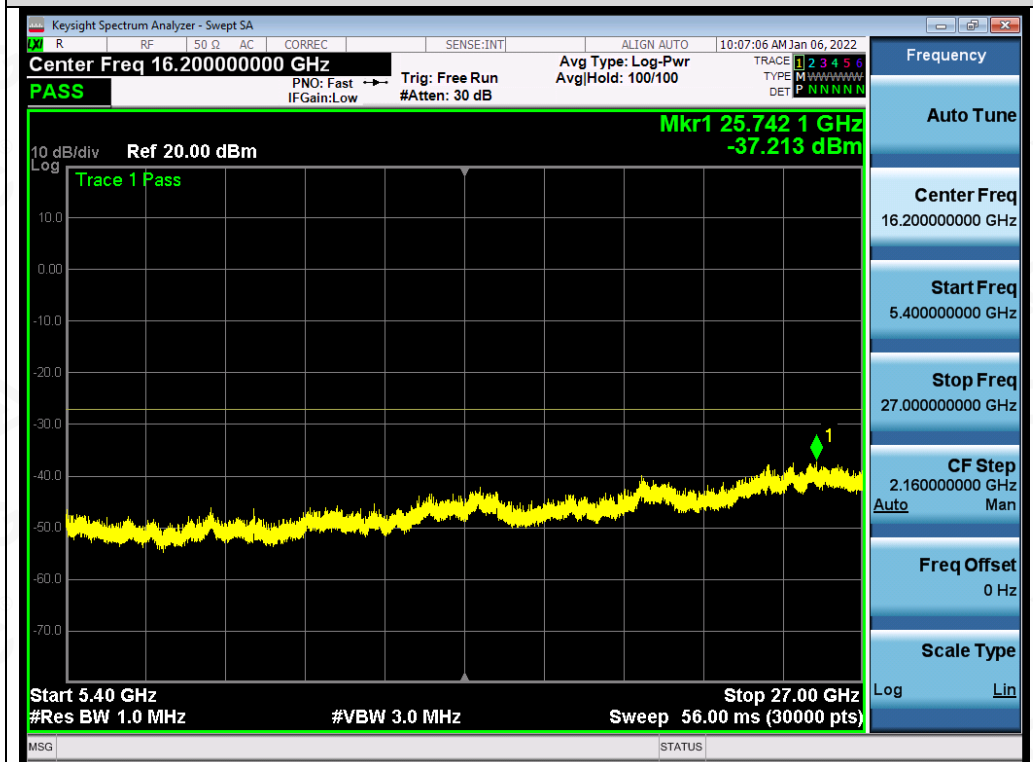

Test_Graph_802.11a_ANT1_5240_6Mbps_Frequency Band 3

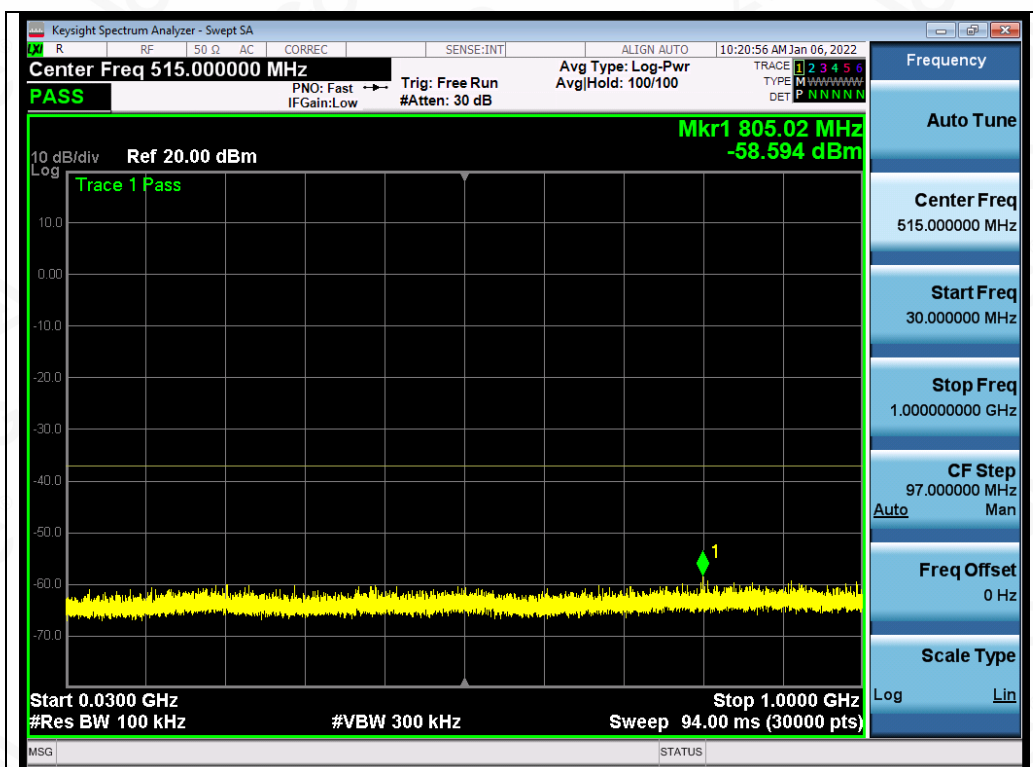

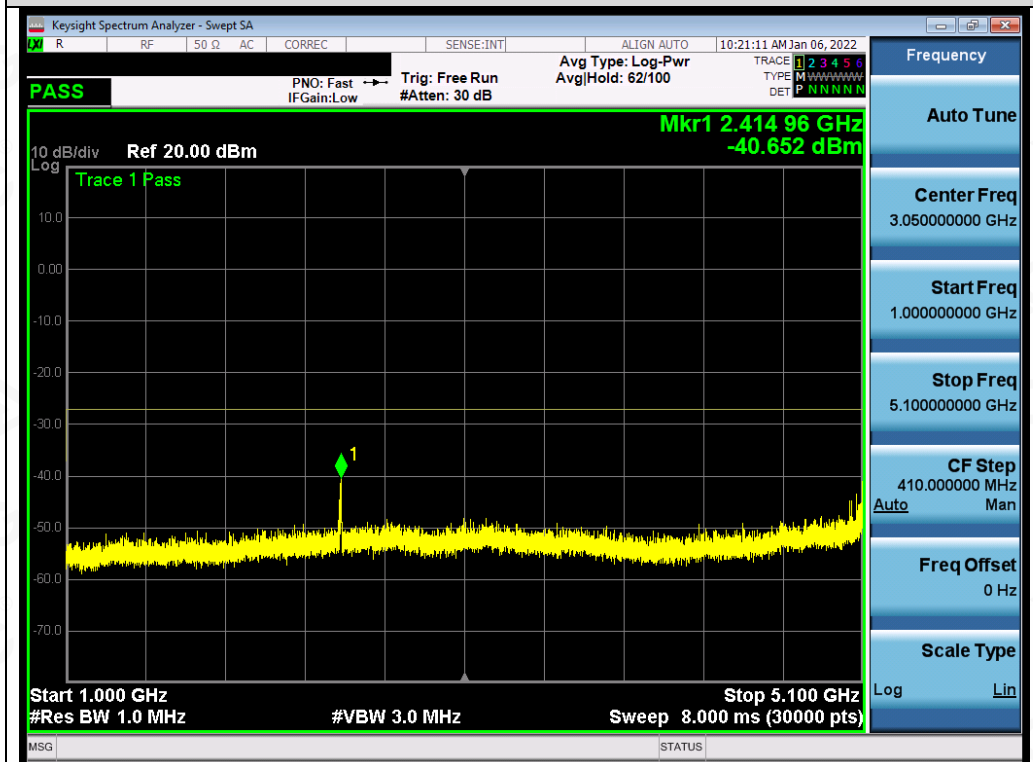

Test_Graph_802.11n40_ANT1_5190_MCS0_Frequency Band 1

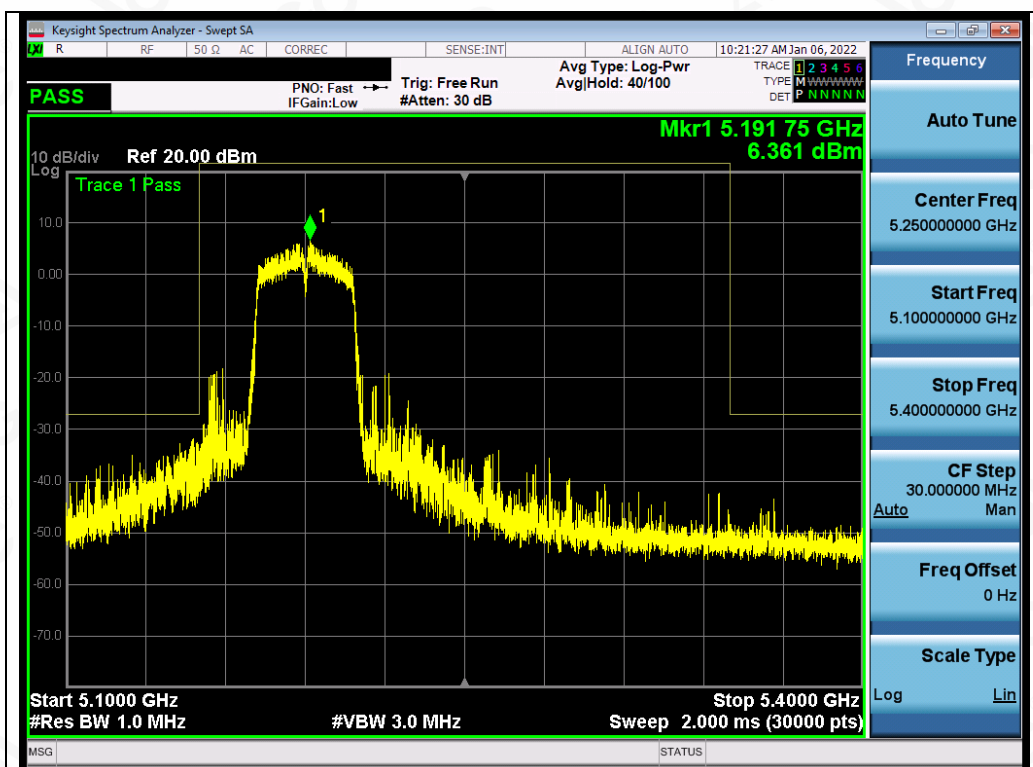
