Band2-20MHz-16QAM-18700-100RB#0

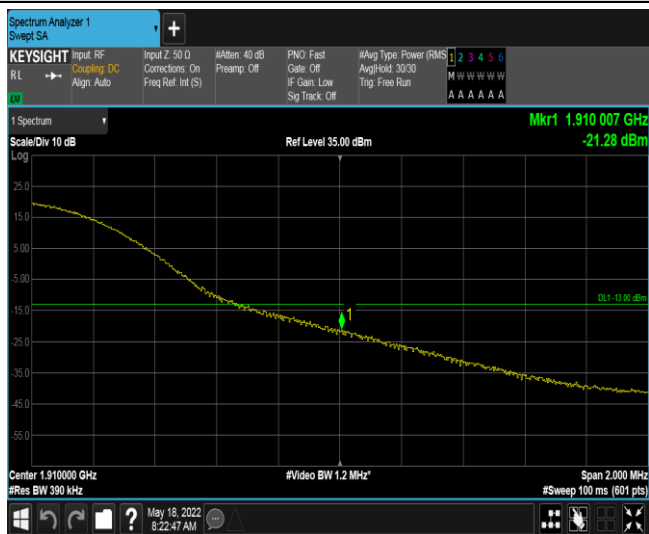


Band2-20MHz-16QAM-19100-1RB#0

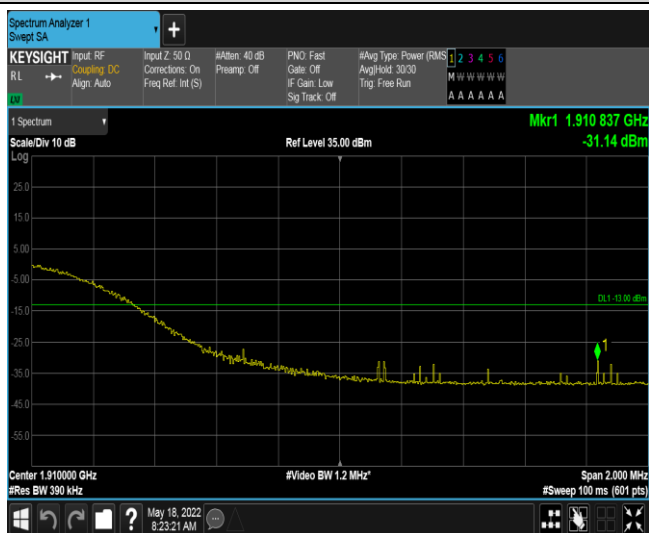
