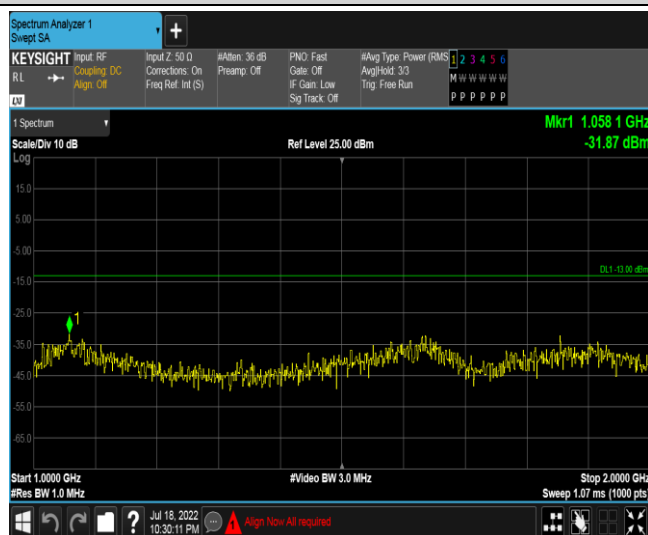

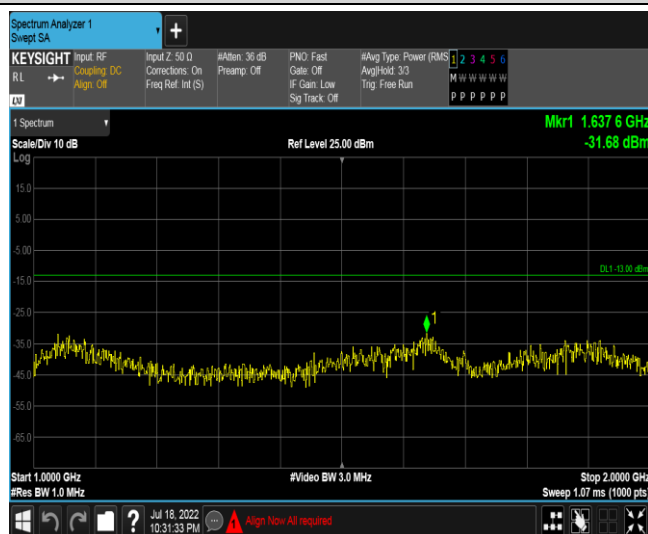

Band18-10MHz-QPSK-23900-1RB#0-Range1:30~1000MHz

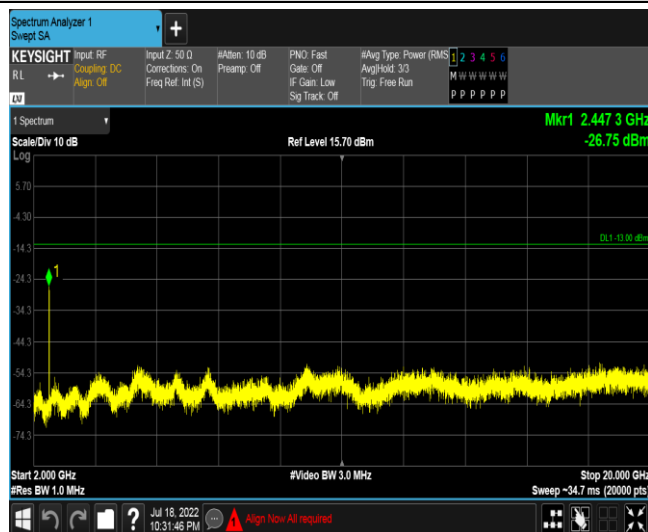
