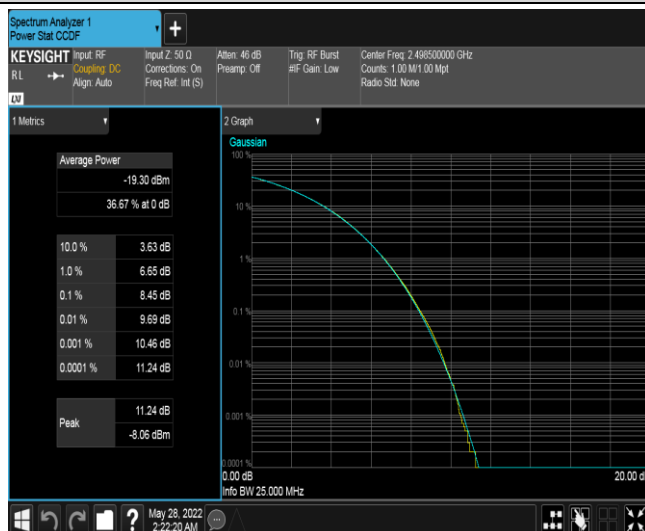

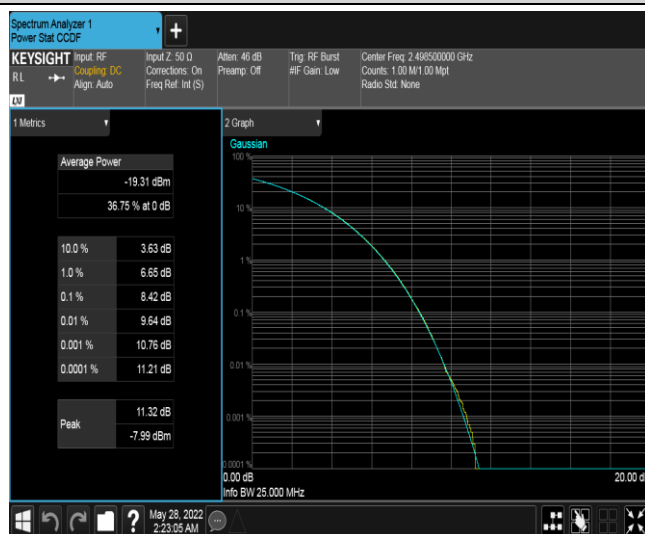

Band41-5MHz-QPSK-39675-25RB#0



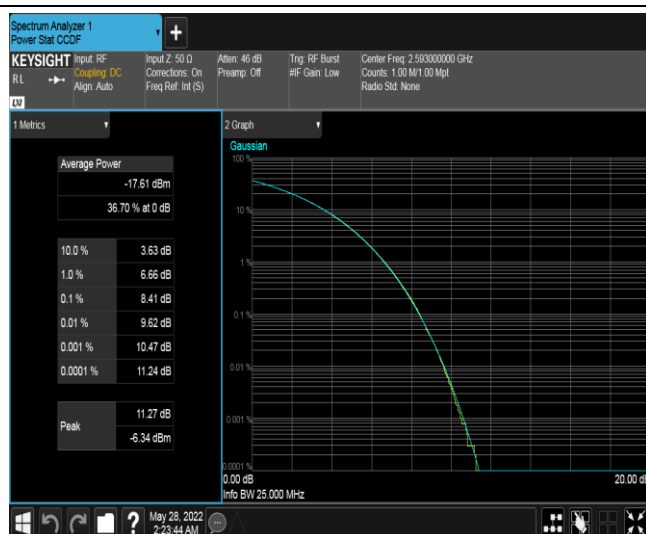

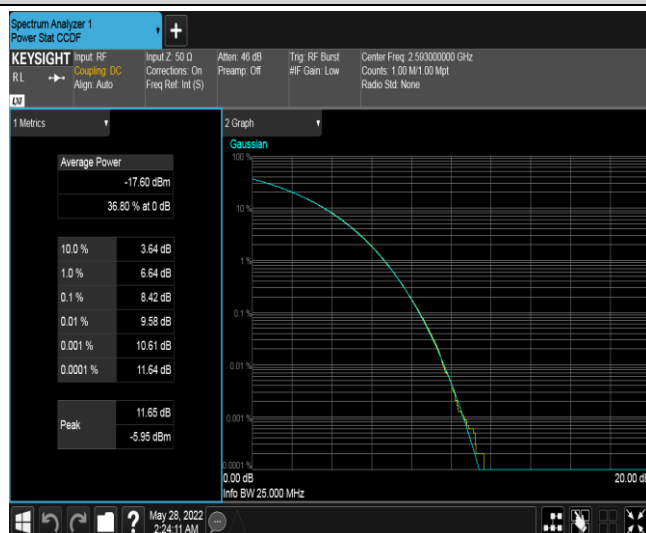

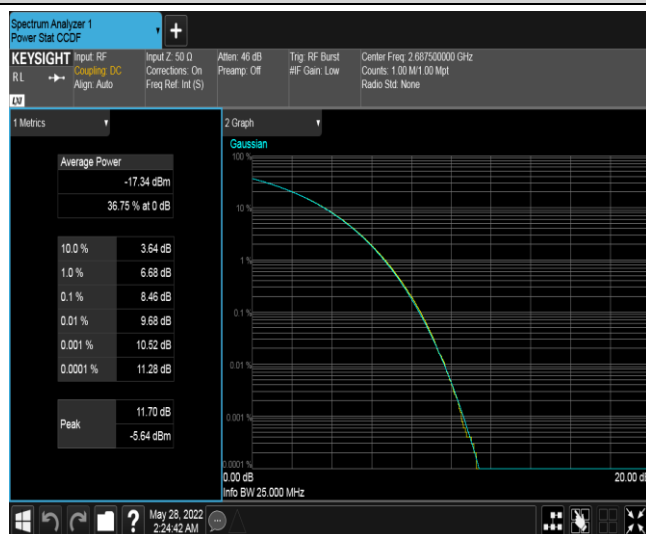

Band41-5MHz-QPSK-40620-25RB#0

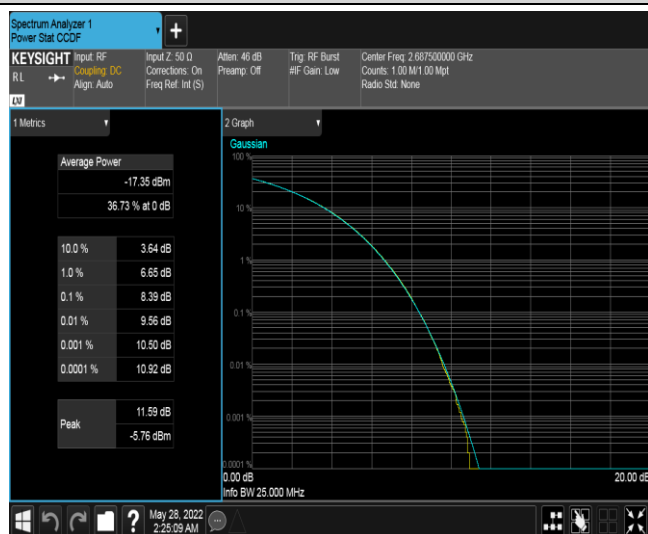
