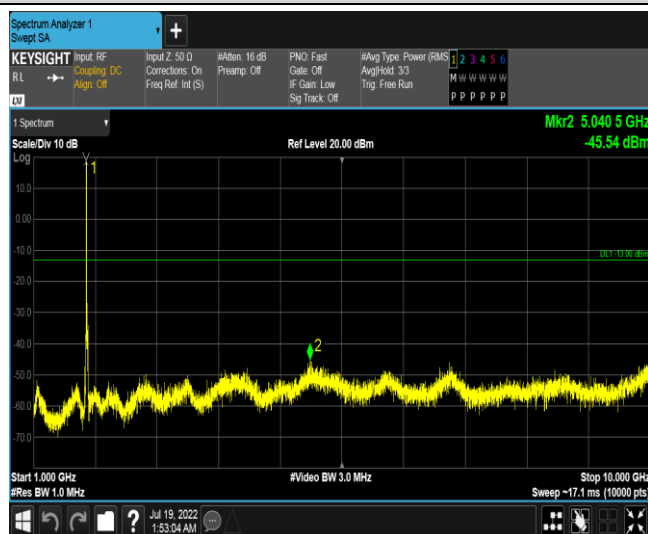

Band66-20MHz-16QAM-132072-1RB#0-Range1:30~1000MHz

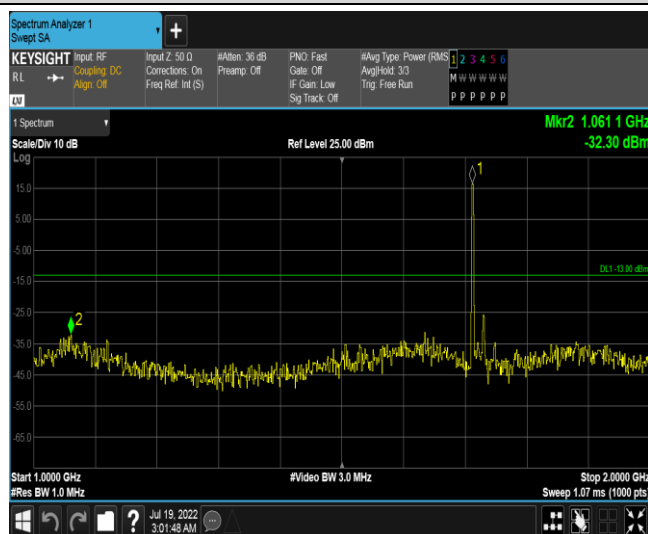


Band66-20MHz-16QAM-132072-1RB#0-Range5:1000~10000MHz

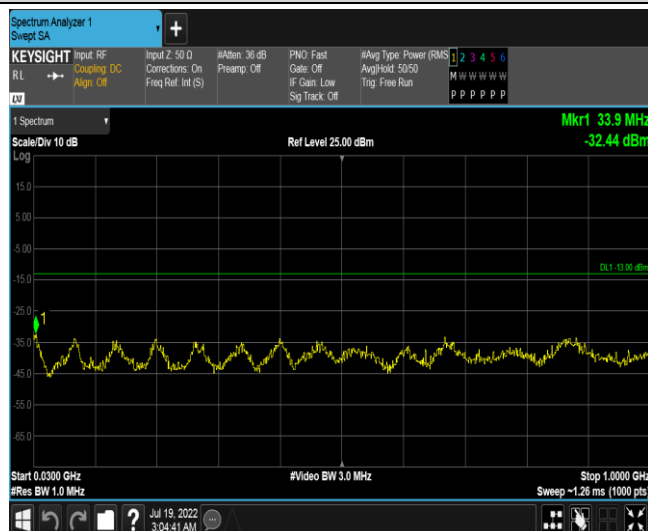

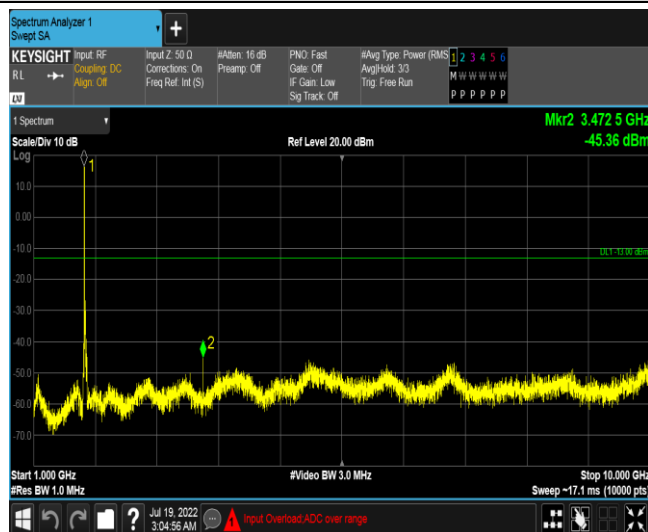

Band66-20MHz-16QAM-132322-1RB#0-Range4:30~1000MHz

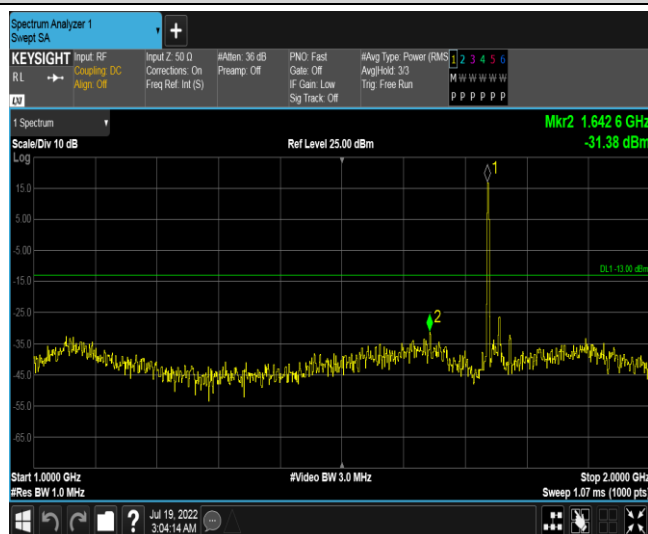


Band66-20MHz-16QAM-132322-1RB#0-Range5:1000~10000MHz

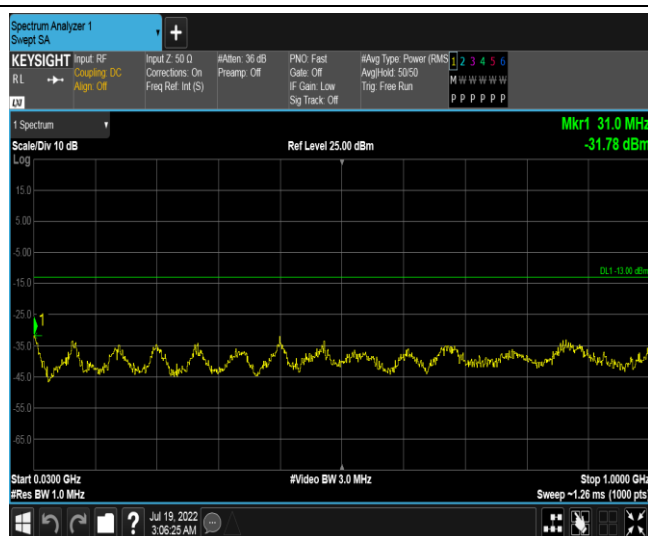

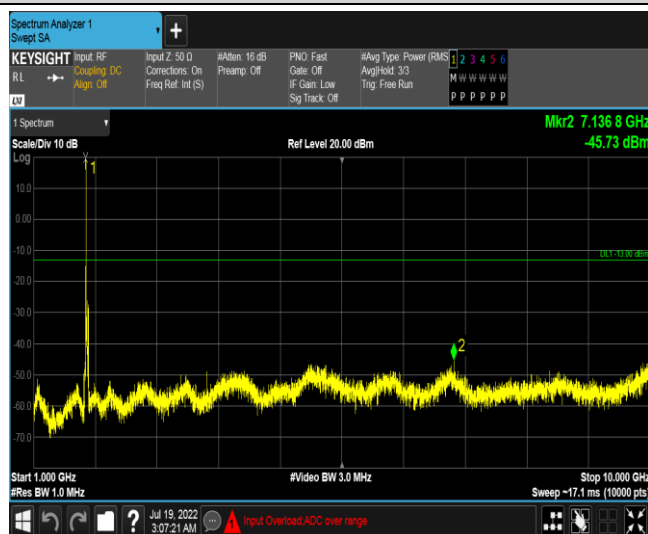

Band66-20MHz-16QAM-132572-1RB#0-Range4:30~1000MHz

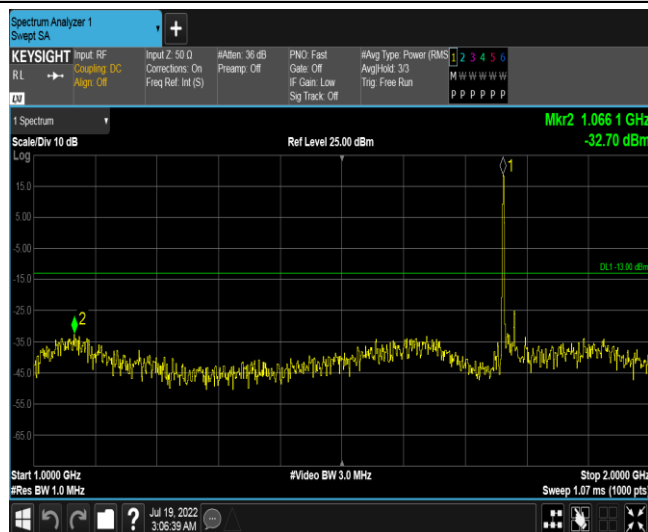


Band66-20MHz-16QAM-132572-1RB#0-Range5:1000~10000MHz
