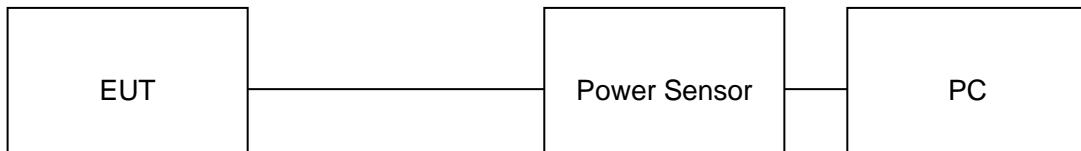

Test_Graph_802.11a_ANT1_5180_6Mbps_OBW










