For the band 5.725-5.85GHz, the maximum conducted output power over the frequency bands of operation shall not exceed 1W. RSS-247 Issue 2: Frequency band 5150-5250 MHz: For other devices, the maximum e.i.r.p. shall not exceed 200 mW or $10 + 10 \log_{10} B$, dBm, whichever power is less. B is the 99% emission bandwidth in megahertz. The e.i.r.p. spectral density shall not exceed 10 dBm in any 1.0 MHz band. (ii) If the transmitter does not transmit continuously, measure the duty cycle, x, of the transmitter output signal as described in section B). (iii) Measure the average power of the transmitter. This measurement is an average over both the on and off periods of the transmitter.
