




- On iOS, enter the APP store and search for "Guliguli" to download

Distribution network


- APP turns on Bluetooth and WiFi

- Click "Next" according to the instructions of the APP (WiFi and Bluetooth must be kept on)




- Enter the WiFi password (5G frequency band is not supported) and click "Confirm"



Q: How to use snack feeding device?

A: You can open the snack box through the recessed position on the back of the robot, put your pet's favorite food into the snack box, and then close it to lock the snack box.



User prompt

- 1: Do not use the robot while charging;
- 2: Before opening the mobile app, make sure that both Bluetooth and WiFi are turned on;
- 3: When the robot judges that the brightness of the environment is dark, the night vision mode will automatically turn on and the video will also enter the night mode.
