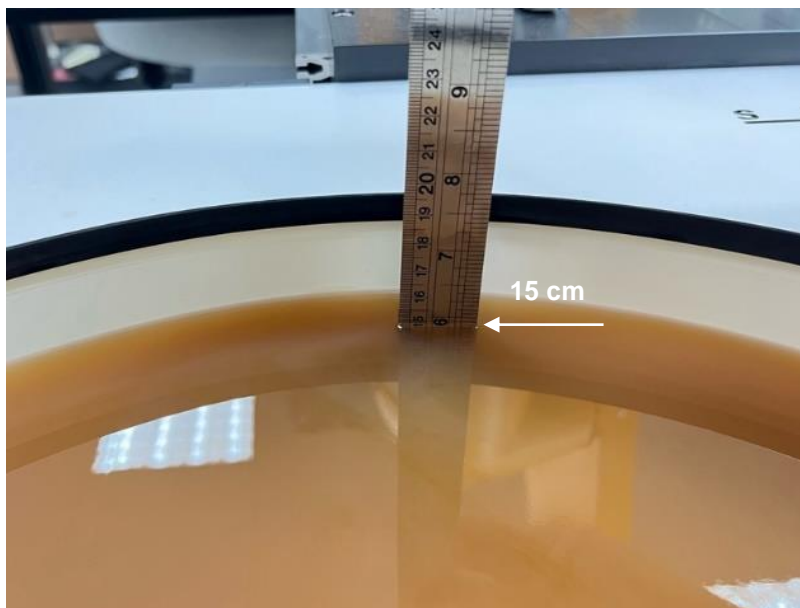


Fig.2 Photograph of the tissue simulant fluid liquid depth

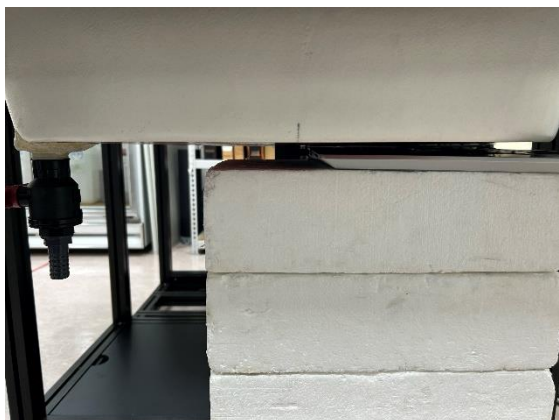

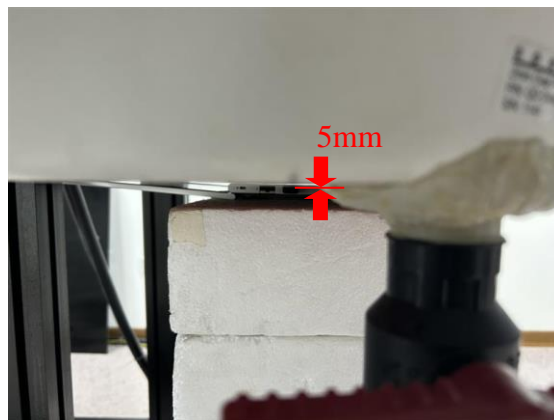

Body - distance between flat phantom and EUT is 5 mm



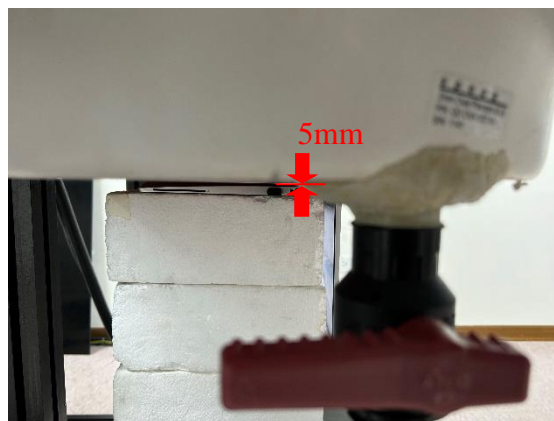

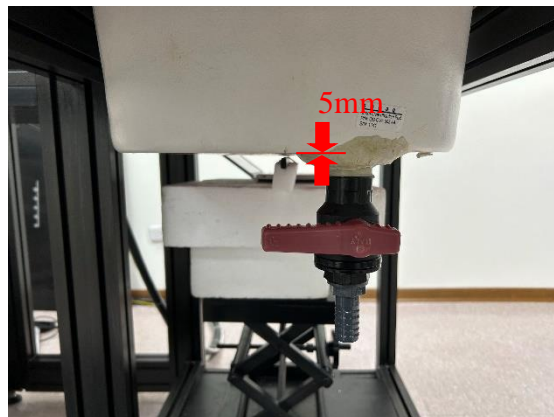

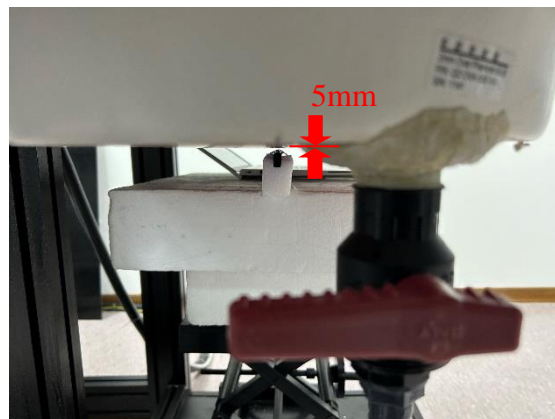
Photograph 7. Body, Right Edge, 5mm

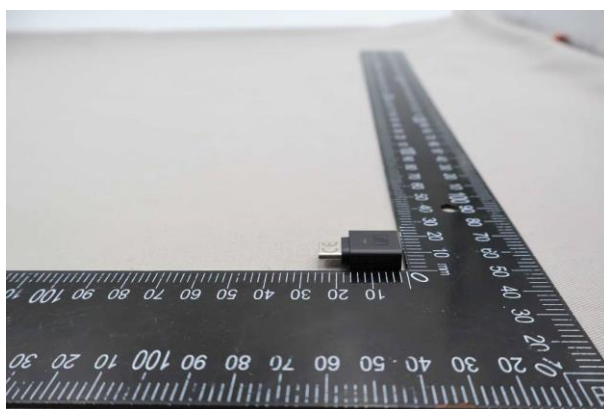

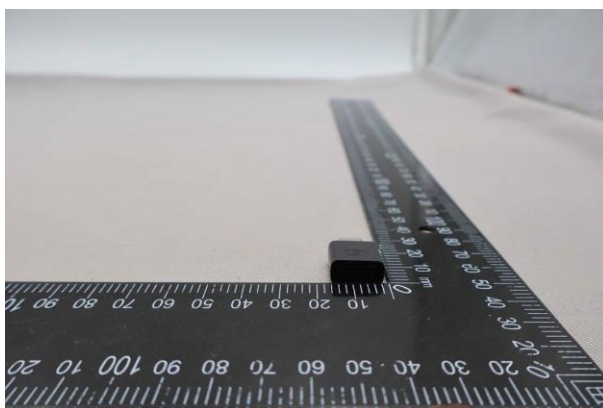

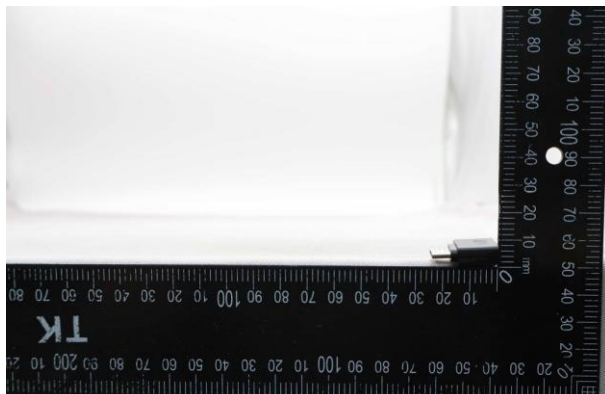

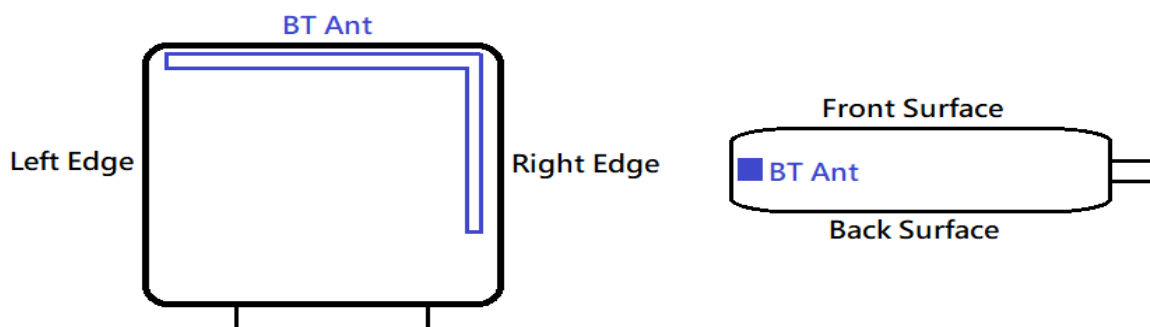
