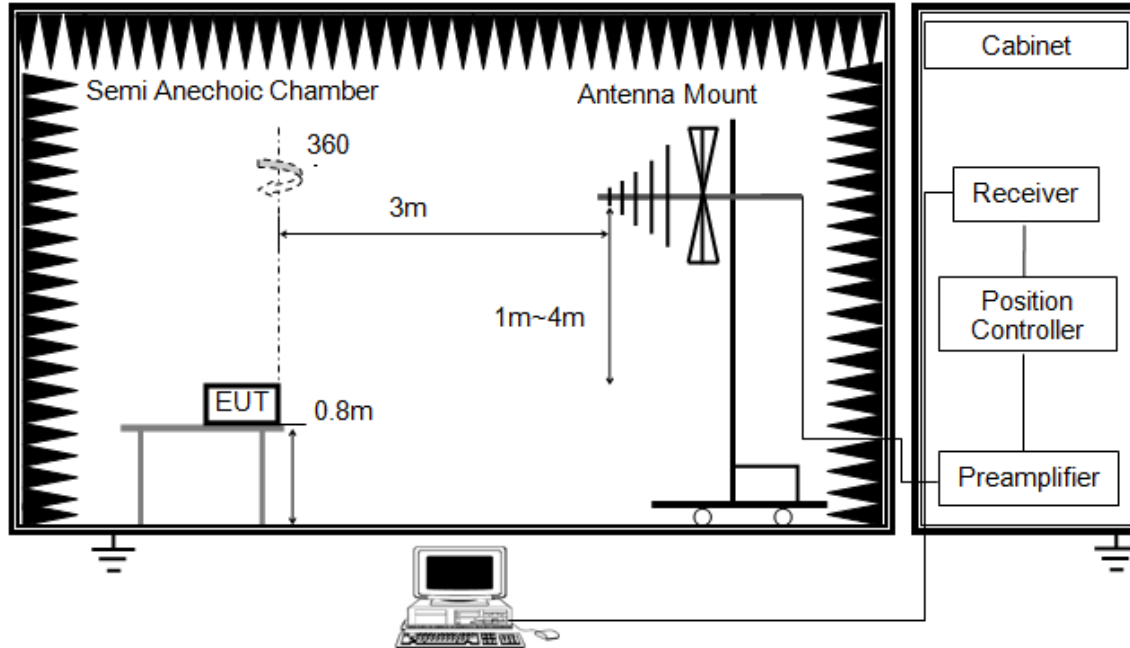

8. The limits in CFR 47, Part 15, Subpart C, paragraph 15.209 (a), are identical to those in RSS-GEN Section 8.9, Table 6, since the measurements are performed in terms of magnetic field strength and converted to electric field strength levels (as reported in the table) using the free space impedance of 377  $\Omega$ . For example, the measurement frequency X kHz resulted in a level of Y dBuV/m, which is equivalent to  $Y-51.5 = Z$  dBuA/m, which has the same margin, W dB, to the corresponding RSS-GEN Table 6 limit as it has to be 15.209(a) limit.

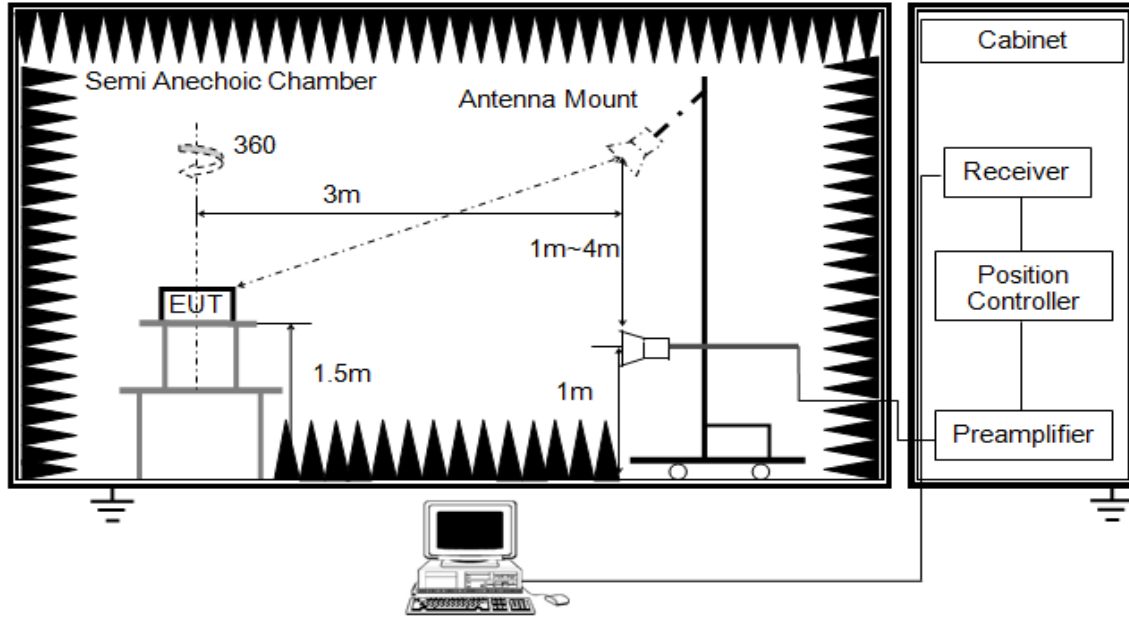

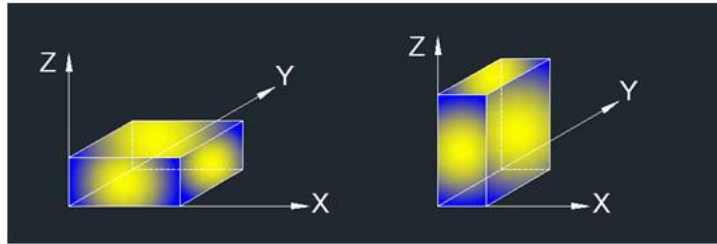
