

APP Mode

This APP program requires that the minimum systems of your phones is Andriod 4.3 or iOS8.0. No limit for mobile phone configuration. You can download APP by scanning QR codes on iOS or Android systems. Use Apps with scanning function such as browser to scan the QR code.

Please Open the LED string Lights control APP on the phone, and one or multiple LED string Lights can be connected through Bluetooth, and multiple LED string Lights can be set and controlled.

When your device can't connect the lights automatically, follow the steps below:

Method1: Click 'My Devices' to refresh (on the top left corner), then it shows 'connected successfully.'

Method2: If the first step fails, you need to exit the App and close its 'process' in the background completely, then open again.

Method3: If the all steps fail, you need to exit the App and close its 'process' in the background completely, turn off the bluetooth, then turn on the bluetooth, and open the App again.



Remote Control Instructions



- Input: 100-240V, 50/60Hz
- Output: 5V, 1A
- Power: 14W
- Total Light string length: 49ft
- Waterproof level: IP65
- Light color: RGB 12 colors, warm white/white.
- Multi mode: loop, meteor, jump, flash, auto etc.
- Display different colors: display 3 colors, 7 colors or 12 colors at the same time.
- Remote control: Use the IR remote control to freely turn on/off or control the light string!
- Adjustable brightness: adjustable brightness 50% or 75%
- Sync to music: Built-in high-sensitivity microphone, it will automatically adjust the spectrum of lights and colors according to the ambient sound.
