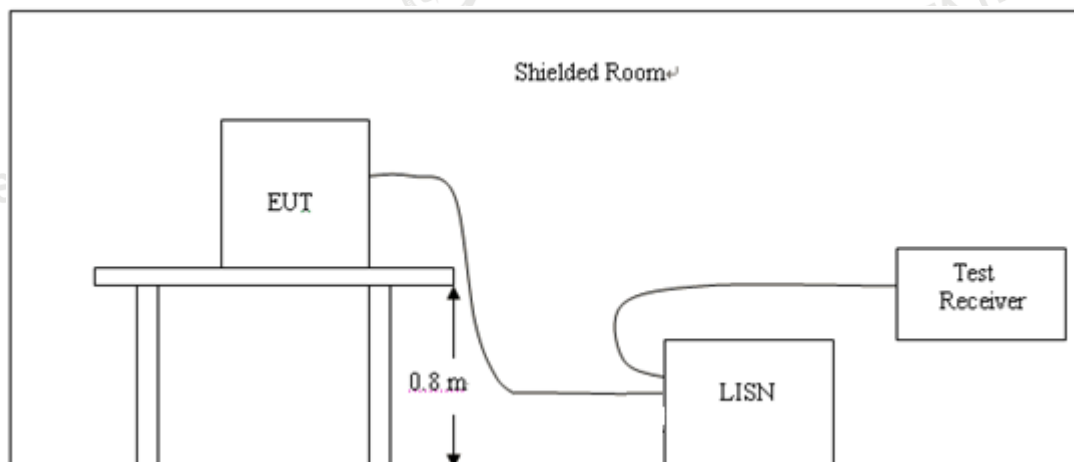

## 4 TEST CONDITIONS AND RESULTS

### 4.1 AC Power Conducted Emission

#### TEST CONFIGURATION



#### TEST PROCEDURE

- 1, The equipment was set up as per the test configuration to simulate typical actual usage per the user's manual. The EUT is a tabletop system, a wooden table with a height of 0.8 meters is used and is placed on the ground plane as per ANSI C63.10.
- 2, Support equipment, if needed, was placed as per ANSI C63.10.
- 3, All I/O cables were positioned to simulate typical actual usage as per ANSI C63.10.
- 4, If a EUT received DC power from the USB Port of Notebook PC, the PC's adapter received power through a Line Impedance Stabilization Network (LISN) which supplied power source and was grounded to the ground plane.
- 5, All support equipments received AC power from a second LISN, if any.
- 6, The EUT test program was started. Emissions were measured on each current carrying line of the EUT using a spectrum Analyzer / Receiver connected to the LISN powering the EUT. The LISN has two monitoring points: Line 1 (Hot Side) and Line 2 (Neutral Side). Two scans were taken: one with Line 1 connected to Analyzer / Receiver and Line 2 connected to a 50 ohm load; the second scan had Line 1 connected to a 50 ohm load and Line 2 connected to the Analyzer / Receiver.
- 7, Analyzer / Receiver scanned from 150 KHZ to 30MHz for emissions in each of the test modes.

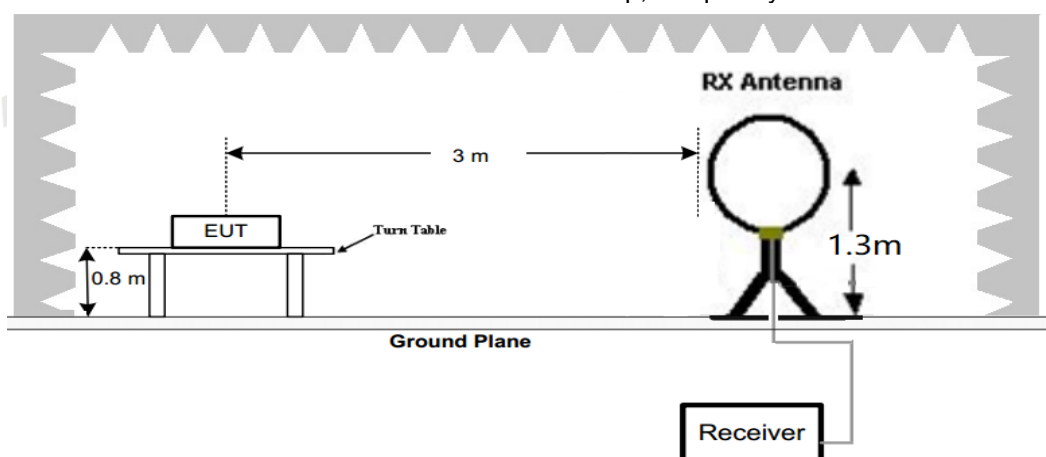

- Below 1GHz measurement the EUT is placed on a turntable which is 0.8m above ground plane.
- Maximum procedure was performed by raising the receiving antenna from 1m to 4m and rotating the turntable from 0°C to 360°C to acquire the highest emissions from EUT
- And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- Repeat above procedures until all frequency measurements have been completed.
- Radiated emission test frequency band from 9KHz to 1000MHz.
