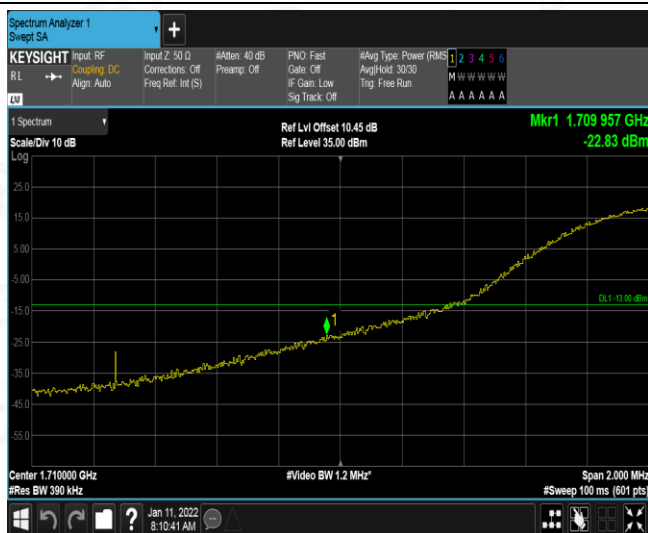

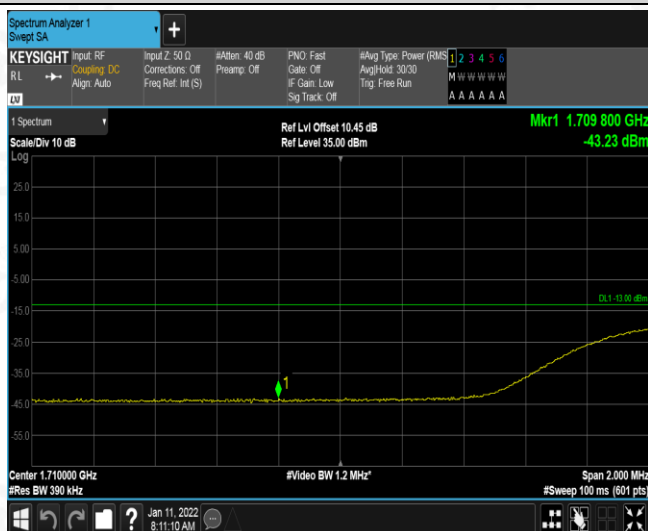

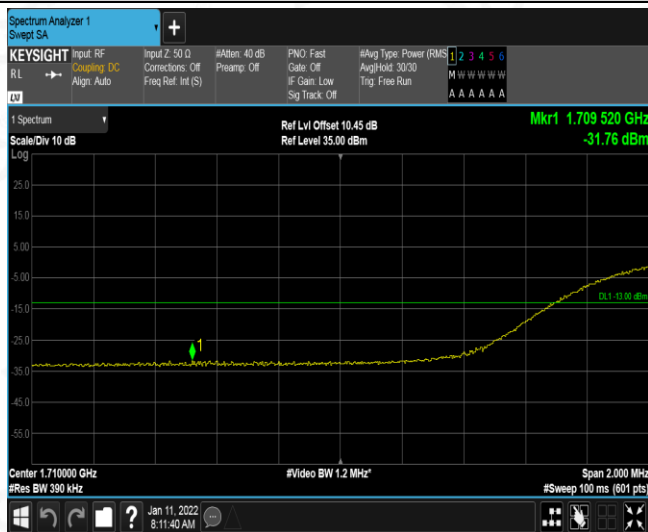




Band4-20MHz-16QAM-20050-100RB#0



Band4-20MHz-16QAM-20300-1RB#0

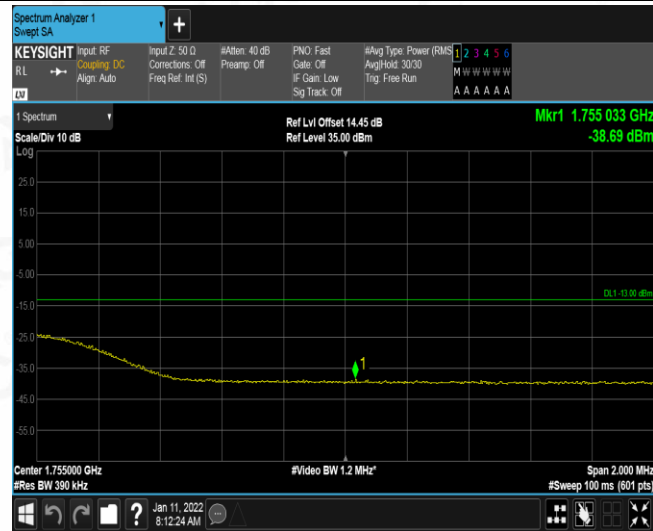
