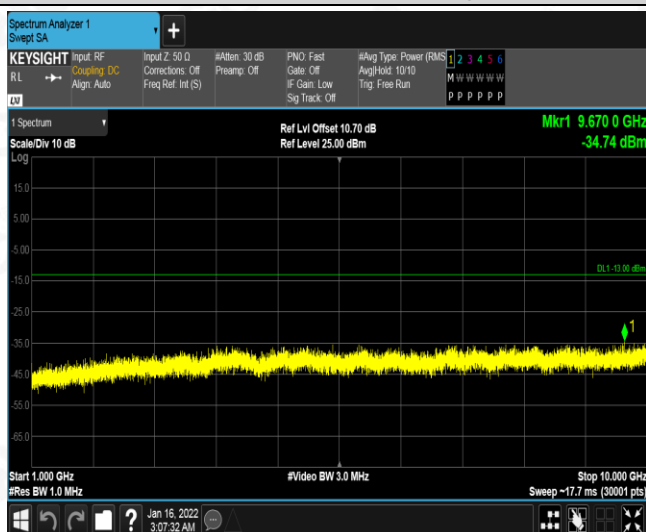




**Band12-1.4MHz-QPSK-23173-1RB#0-Range1:30~1000MHz**



**Band12-1.4MHz-QPSK-23173-1RB#0-Range2:1000~10000MHz**

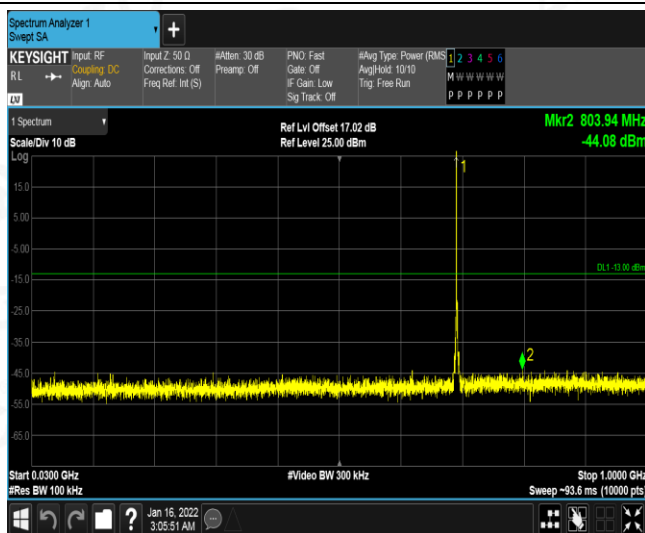

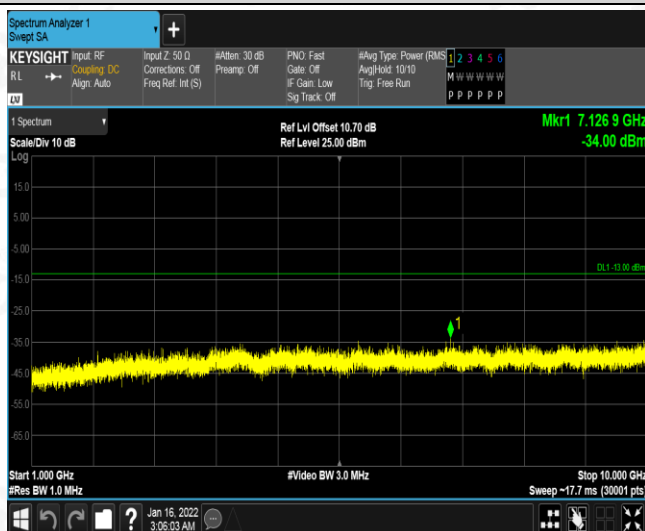

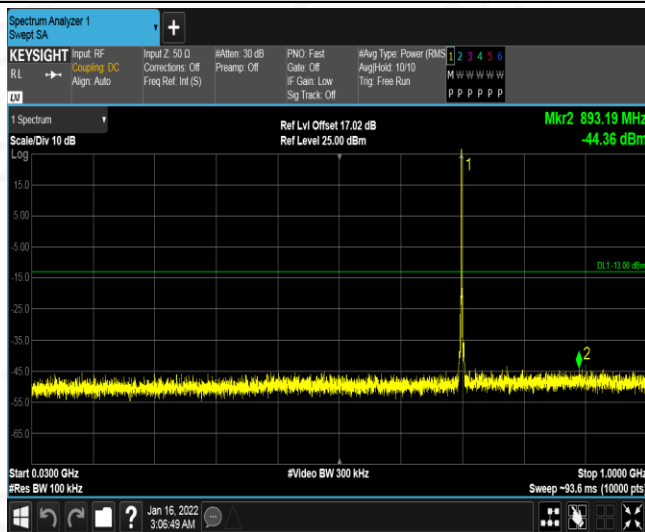




Band12-1.4MHz-16QAM-23017-1RB#0-Range2:1000~10000MHz

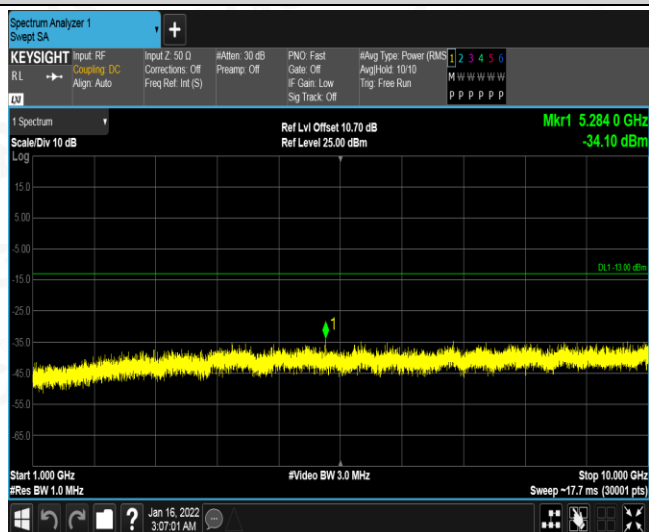

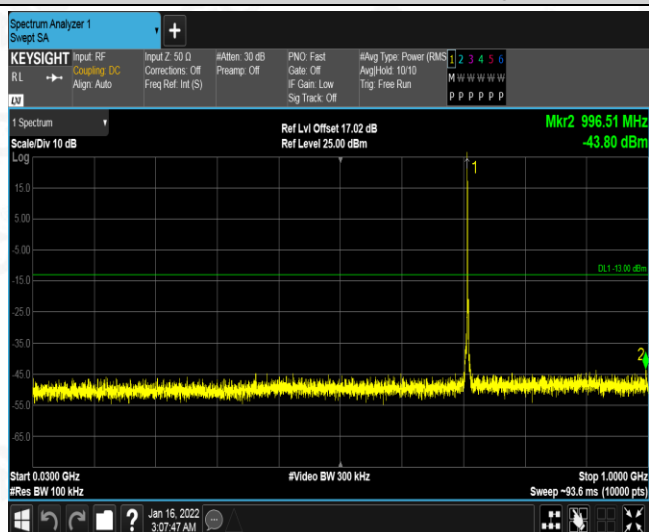
