Band5-5MHz-16QAM-20425-25RB#0






Band5-1.4MHz-QPSK-20525-1RB#0-Range2:1000~10000MHz



Band5-3MHz-QPSK-20415-1RB#0-Range1:30~1000MHz




Band5-3MHz-QPSK-20415-1RB#0-Range2:1000~10000MHz






Band5-3MHz-16QAM-20635-1RB#0-Range2:1000~10000MHz


