# How to get started.

1. Remove device from box. Use the enclosed USB cord to charge your device before using.

2. Download the UVCeed™ app on the Apple App store or Google Play.



3. Once your device is charged, attach it to the back of your phone:

**MagSafe Phones:** The UVCeed™ sanitizing device will click onto the back of MagSafe phones or cases.

**All other Phones:** Use the adhesive metal plate adapter included inside the box to attach the device to your phone or case.



4. Open the UVCeed™ app. Turn on your Bluetooth and the app will detect the sanitizing device in seconds; simply follow the on-screen instructions to operate.

5. Point your phone at any surface and press and hold the "Press and Hold" button at the bottom of your screen. You disinfect what your camera sees.

6. Move your phone side-to-side to scan the surface. You will see large circles in shades of blue that indicate the level of sanitization; the darkest blue indicates that 99.9% of germs, bacteria and viruses (including SARS-Covid 19) are gone. Watch in real-time as the germs disappear.

## Other important information:

- The device has a battery life of 24+ hours. Use the enclosed USB cord to recharge.
- The device gets smarter over time and recognizes objects you've already scanned during your session. It will tell you that a surface is already safely sanitized.
- UVCeed™ smart technology pauses its UV light rays when it detects humans, cats and dogs, to ensure their safety.
