1.1 DESCRIPTION

The wireless camera is used in video-nystagmoscopy/video-nystagmography masks for the study and analysis of eye and head movements. It is designed for use by otorhinolaryngologists, neurologists, ophthalmologists, and physiotherapists.

To use the equipment properly, we advise you to read the following information carefully.

The mask is made up of one goggle plus one or two wireless cameras.

The wireless camera is used either as

- with compatible video-nystagmoscopy Synapsys software;
- with compatible video-nystagmography Synapsys software.



1.2 SAFETY - CONDITION OF USE

1.2.1 Precautions

• To use this device properly, you must carefully read all this documentation, the instructions, and labels.

1.2.2 Warnings

- All peripherals (PC, printer, computer, etc) used with this device should conform to the IEC 60950-1 standard.
- The device should not be used in extreme humidity.
- The device should not be used in the presence of any explosive or flammable gas.
- Switch the device off before any cleaning is carried out.
- CAUTION: All modification of the equipment is expressly forbidden.
- To avoid accidents, the user should take care not to put the patient in contact with any equipment other than the ones provided by Synapsys and to ensure that all other electrical equipment, (monitors, power supply box, ...) are positioned beyond the patient's reach.

• **WARNING:** Remove the battery if the wireless camera is likely to remain unused for a period of time.

1.2.3 Contraindications

- To preserve optimum video image quality, the patient should not wear any corrective spectacles.
- The user must never be in contact simultaneously with the patient and with an electrical appliance.
- If the device or one of its components is damaged, do not use the system until it is repaired by a specialist trained by Synapsys.
- The device or one of its components may only be installed, updated, and repaired by a specialist trained by Synapsys.
- Only use the batteries designed for the wireless camera and buy your replacement batteries from the manufacturer. See Appendix 3: "Safety information & handling recommendations for the wireless camera charger & batteries".
- If water should be splashed on the wireless camera, the user must stop the examination, remove the battery from the camera unit and wipe it dry. The examination may only continue once the wireless camera is dry.
- Synapsys recommends cleaning or changing the parts in contact with the patient to use. (See Chap 3. MAINTENANCE).

1.2.4 FCC use restrictions and warnings

1.3 SYSTEM COMPOSITION

Your system will include the following components:

- 1 Flex or Xpress goggles;
- 1 WNS camera unit;
- 1 Eve occlude:
- 2 batteries;
- 1 battery charger (with supply box and cable);
- 1 Wi-Fi access point;
- 1 USB cable for service purpose;
- 1 USB Wi-Fi interface.

The wireless camera can be customized in terms of the goggle mask, i.e. Flex or Xpress goggles.

1.3.1 About the components

Wireless camera device

The wireless camera device is a mask fitted with one infrared camera units. It is worn by the patient and ensures light-tightness for "closed field" testing. It is used for vestibular testing and rehabilitation. This mask has infrared

LEDs for illumination as well as LEDs visible to the patient as visual fixation targets.

With the integrated motion sensor (i.e., gyroscope and accelerometer), the wireless camera also provides information about the patient's head movements.

Battery pack

A battery inserted in the camera block provides power to the device making it a stand-alone system.

Wireless communication

To communicate with the camera units, you must have a WI-FI-capable (card or USB adaptor) computer.

1.4 MINIMUM COMPUTER REQUIREMENTS

To use the wireless camera, your computer must have at least one 5 GHz Wi-Fi network connection.


The other technical specifications and requirements for your computer system will depend on the software you wish to use. Please refer to the corresponding Synapsys software User Manual.

2.USE OF THE PRODUCT

To use your wireless camera:

- Start the access point;
- Start the camera unit;
- Connect the computer to the wireless camera network via Wi-Fi;
- Put the mask on the patient's head;
- Launch the chosen Synapsys software.

2.1 STARTING THE SYSTEM





- Connect the access point to mains using the provided power adapter;
- The access point is ready when the power and the 5G LED indicators flash.

Start the camera

Start the camera once the access point is ready.

Start-up is automatic upon inserting the battery into the camera unit. You will need to wait a few seconds for the wireless camera system to be ready for use.





The camera is ready when its front left LED pulses with color green and right LED is off.

The front LED indicators of the camera unit show its status as reported in the table below.

2.2 NETWORK CONNECTION

 Connect your computer to the Wi-Fi network "SYN_Wireless_Camera_Access_Point"; Enter the default password "01234567" to establish the Wi-Fi connection.

Particular situations:

If you are using multiple wireless camera systems (i.e., with several access points) in a perimeter of 100 meters, please connect your computer to the corresponding network.

Please contact our support service to set up your systems according to your situation and needs.

Note: The network connection used to communicate with your camera is a point-to-point private connection between your computer and the camera transmitter, it will not provide any connection between you and a third-party network or the public Internet.

2.3 PUT THE MASK ON THE PATIENT'S HEAD

To avoid any stress of traction and torsion when putting on the mask, it is recommended to proceed as follows:

- Attach the camera to the mask;
- Insert the battery to start the camera;
- Loosen the Velcro strap;
- Position the mask comfortably over the patient's eyes;
- Stand behind the patient, take the strap buckles and tighten the strap slightly to ensure a good fit of the mask.

Once the eye to be filmed has been chosen, the camera and occluder should be placed on the goggles with battery entry pointing upwards. If this is not the case, rotate the camera.



At the end of the test session, remove the wireless camera mask from the patient's head before removing the battery from the camera.

2.4 USE WITH SYNAPSYS SOFTWARE

Once the connection with your wireless camera system is established, you will have access to the video signals, sensor measurements, and various functionalities within the chosen Synapsys software.

For the use of the wireless camera system with your software, please refer to the corresponding user manual.

2.5 USING BATTERY PACKS

Make sure your batteries are charged before use.

The charging state of the battery is indicated by the charger, and the charge level is indicated in the Synapsys software.

The charger indicates the state of charge of each battery inserted in it by an individual indicator light:

- Fixed light: the battery is fully charged.
- Flashing light: the battery is charging.



Please refer to Appendix 3 for the detailed use instruction and safety information of the charger.

Please refer to the user manual of the corresponding software to locate the display of the battery level.

3.MAINTENANCE

3.1 CAMERA

No maintenance is required for the camera unit. The camera lens can be repeatedly cleaned like a normal camera, i.e., with a soft cloth or a small special brush.

Warning: Do not clean the lens with liquids or aerosol.

3.2 HYGIENE FOAM

After each exam, it is necessary to check the cleanliness of the surface which was in contact with the patient. We strongly recommend that you have spare foams available to ensure optimal cleanliness. It is possible to clean the surface of the foams with disinfecting wipes for example.

Warning: Before cleaning, remove the camera unit from the mask.

Particular attention:

- Do not put the camera unit in contact with water;
- Do not expose the product to the sun for a long time;
- Do not put your fingers on the lens;
- Do not clean the mask with chemical products;
- Do not twist the mask.

4.TROUBLESHOOTING

In case of problems, please check:

- That your computer/device is turned on and connected to the correct Wi-Fi network.
- That there is no firewall or security program preventing data exchange over the Wi-Fi network.
- That your battery is charged.

Other common problems which may occur:

- The Synapsys wireless camera network does not appear: reduce the distance to the transmitter and refresh the list of wireless networks on your computer. WNS is designed to operate over an obstacle-free distance of 10 m.
- No image:
 - Check that the batteries are charged.
 - Make sure the camera is powered correctly (i.e., battery well inserted) and that the infrared LEDs of your camera are not turned off (i.e., the scene is still illuminated when filming in darkness).
 - Verify there is no other computer connected to the same camera.

If the problem persists, please contact your dealer.

5.RESPONSIBILITIES

The manufacturer will be responsible for the results on the safety, reliability, and performance of the product only if it is used according to the instructions in this manual.

6.WARRANTY

This product is under warranty for two years, including the technical spare parts (excluding batteries) and labor cost under the condition that this product has been used in compliance with the notice. The consuming spare parts (i.e, hygiene foam and elastic bands) must be replaced regularly and are not under warranty.

The warranty is excluded in the following cases:

- Dismantlement or modification of the product without authorization of the manufacturer;
- Cleaning the mask with chemical products;
- Connection to a control system other than those distributed by Synapsys;
- Introduction of liquid or conductive particles into the camera unit.

APPENDIX 1: foam change procedure

The replacement of the foams can be easily done by following the instruction below. The care taken in this operation will ensure a good tightness of your VNS mask.

1. Removing the old foams

The glue used for the VNS foams is water-soluble. It is therefore sufficient to immerse the mask in lukewarm water for 15 minutes before removing the old foam.

<u>WARNING</u>: It is imperative to remove the camera unit from the mask before this operation!


2. Positioning new foams

Make sure that the mask is clean and dry, and locate the right and left eyepieces of the mask, as well as the corresponding foams. The foams will be glued in 2 steps: one side and the other.

Step	Picture	Description
1		Peel off half of the adhesive on the foam to facilitate its positioning on the mask
2		Apply in a first step on the external part
3		Remove the remaining adhesive and apply the foam along the contour by pressing on the front part of the foam

4	00	You should obtain a uniform result. Repeat the same steps for the second side Note: The foam must not protrude inside (see 3. Positioning check)
5	8	If the foam is misplaced, you could take it off and reposition it.

Reminder about batteries

Lithium batteries provide a high energy density which is often combined with a high-rate capability. Due to excellent performance properties, Lithium batteries contain a certain safety risk. If short-circuited, heat and sometimes sparks may be generated. Mistreatment outside of the recommended limits can cause gas generation, leakage, and fire.

Synapsys will take **no responsibility** for any accident when the cell is used under **other conditions than those described in this document**.

General Recommendations

- At the first use, let discharge completely your batteries for sustainable recharging. For this, please use the batteries installed in your product until it stops.
- To avoid premature weakening, let you use them till the complete discharging. After, please charge them, and once recharged, please take off them from the charger.

Before leaving your office, please remind yourself to unplug the charger and to remove all batteries from the charger compartments.

Safety Rules

The cell shall be charged within the range of specified temperatures: **0** +**30°C** maximum. If the battery is charged or stored at a temperature out of the **specified** range, **leakage**, **heat generation**, or **other damages** may occur. Please **use only use the specified charger and batteries** as shown in the next pages.

Repeated charging and discharging at high and low temperatures may cause degradation of cell performance even within the specified temperature range.

Caution: The battery used in this device may present a fire or chemical burn hazard if mistreated. Do not disassemble, heat above 100°C (212°F), or incinerate.

Replace your batteries only with Synapsys batteries provided for your device.

Recharge your batteries only using the charger provided by Synapsys.

Never disassemble the cells. Disassembling cells may cause an internal short circuit in the cell, which could further cause gassing, fire, or other issues.

An electrolyte that leaks out from the cells is harmful to the human body. If the electrolyte comes into contact with the skin, eyes, or other parts of the body, the electrolyte shall be flushed immediately with fresh water. Seek medical advice from a physician.

Never short circuit the cells. It causes the generation of very high currents resulting in heating of the cells, which may cause electrolyte **leakage**, **gassing**, **or fire**.




Cells with a smell of electrolyte or leakage shall be kept away from the fire to avoid **ignition**.


Dispose of used battery promptly according to current collection arrangements in your country. Keep away from children.



A3.2 INSERTION & REMOVAL OF THE BATTERY








REMOVAL

- 1. To remove the battery, pull the top forwards towards the charge status indicator so that it is clear of the hook on the battery retaining clip. Lift the battery out of the charge compartment.
- 2. Pull the top of the battery forwards and lift the battery out of the compartment.

A3.3. CONNECTING THE POWER SUPPLY

Plug the power supply into the socket on the back of the battery charger. Use an appropriate main lead to connect the power supply to the mains. It is recommended that when the charger is not in use that the power supply is turned off and disconnected from the mains. When the charger is powered the blue indicator on the front of the charger lights.

A3.4. MAINTENANCE & TROUBLESHOOTING

For trouble-free service observe the following precautions when using the Battery Charger:

- Do not store or use the 1136 Battery Charger in any location that is dusty, damp, or wet.
- Do not attempt to use any other power supply than the recommended ones.
- Do not attempt to charge other types of batteries.
