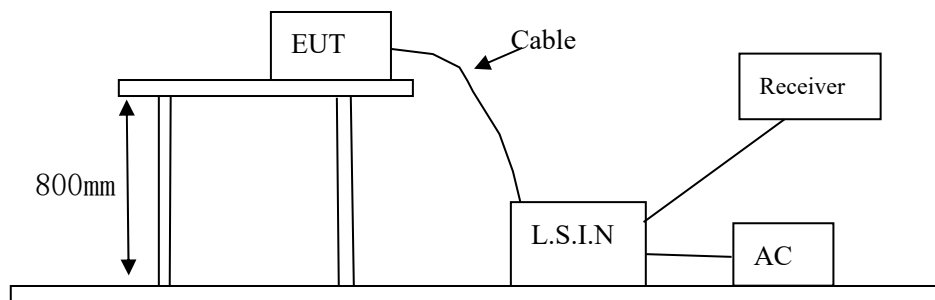

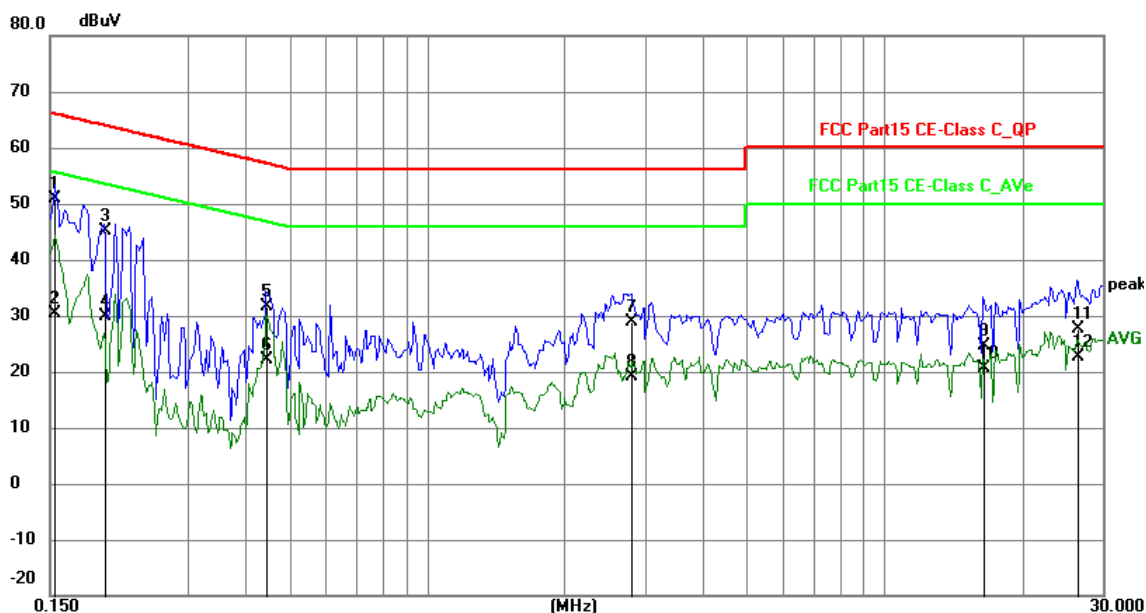

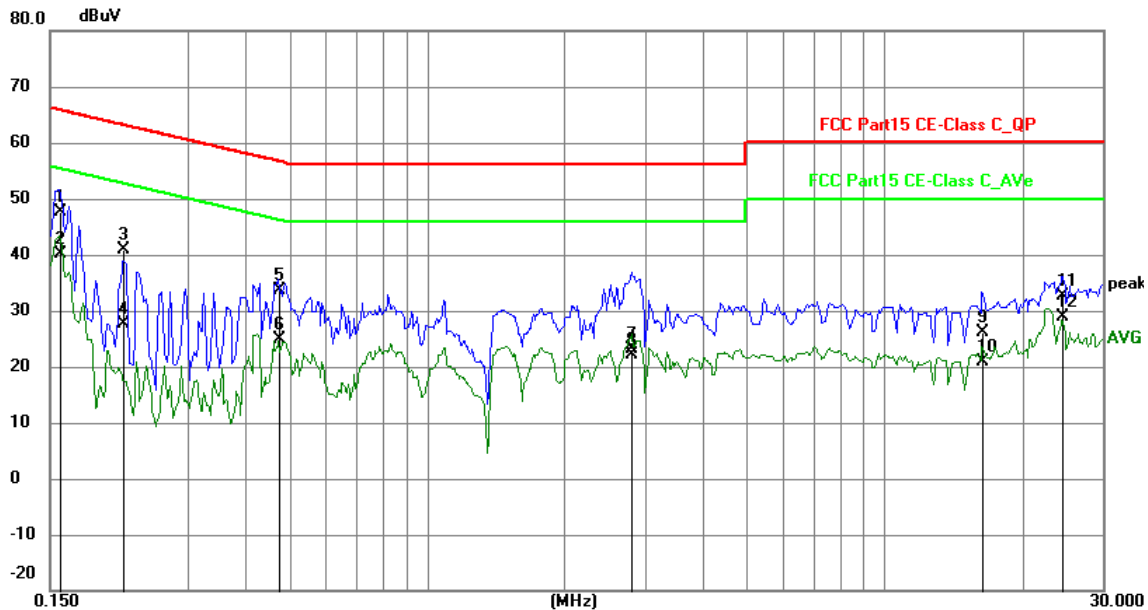

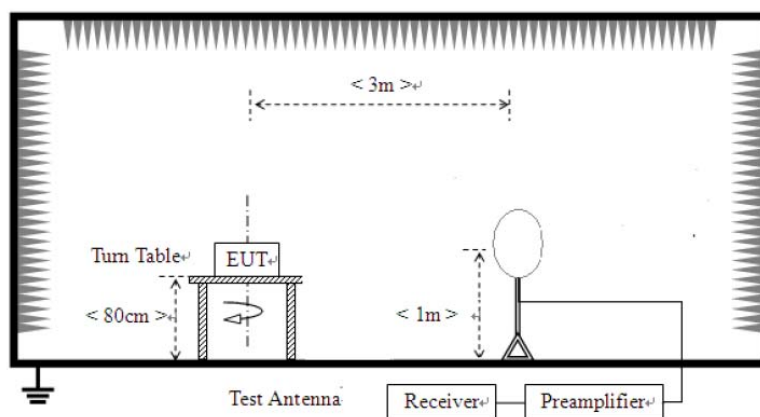
6 Radiated Emission Test

For radiated emissions from 9kHz to 30MHz



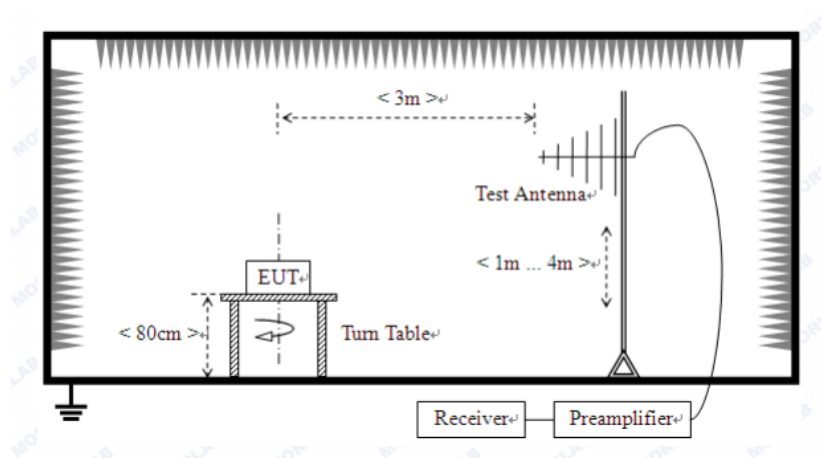
