

HARDWARE INSTRUCTION




FRONT

- Bluetooth Paring: Blue light flashes frequently
- Charging: Red light on while charging
- Fully Charged: Blue light on while charging
- Light to find: Blue and red lights flash frequently
- Working: Blue light blinks when tracking requested on app.

(Press the center iconic tab to request tracking)

HARDWARE BACKINSTRUCTION



BACK

- Power on: Press the power button
- Power off: Press the power button 3 times
- Reset Device: Long press the power button for 10 second
- Note: PADDLE only works with the original SIM card; Do not open the sim card slot or take off the SIM card without permission, otherwise your warranty may be waived

CHARGING



Put the device on charger to charge. Red light is on while charging, light turn blue when device is fully charged.

Note: Battery standby time can last up to 20 days;
Standby time depends on data update frequency.
When Virtual Fence and History Track is on the standby time may only last up to 10 hours.

5 SMART COLLAR ATTACHMENT



Take the band and hook one side to device's anchor. Bond the device to a collar and hook the anchor
 on the other side to finish the attachment. Finally, put the smart collar on your pet.
 Note: You may attach the device to any suitable collar for your pet.



DEVICE ACTIVATION




Turn on the device and make sure blue light is flashing

Device will be automatically connected; if not, go to Bluetooth Setting on your phone and find "PADDLE"




WI-FI CONNECTION

- If you are not at home yet, skip now and set it later.



 Device away from Home WI-FI & Mobile phone signals.


4G Positioning:
Refresh manually by pushing the iconic tab.

Real-time location:

Hold the shown tab for real-time location; release pressing the tab the real-time tracking ends.

POSITIONING GUIDE





- Track History:
 The system record pet walk history. (Note: it only records the history route when pet walks alone with the main app users.)
- Please note:
 When this function is activated, battery will be highly consumed.
- Virtual Fence:
 This function actives real-time 4G tracking; battery will be highly consumed. Please note: Smart Collar standby time will only last for a few hours when this function is activated.


HEALTH MONITOR



- Fitness Status:
 - The device's sensor detects pet's active frequency and movement.
