Button Description

- ① Left Key ② Right Key ③ Scroll Wheel
④ DPI Switch [Long press for three seconds, Bluetooth pairing]
⑤ Bluetooth/OFF/2.4G ⑥ Type C Receiver

Function Description

- The No. 5 key is a dual-mode switch: Bluetooth/Off/2.4G three states. 2.4G mode-the green light next to the scroll wheel flashes; Bluetooth 5.0 mode-the blue light next to the scroll wheel flashes
- DPI free switching: 800-1200-1600, three-speed adjustment, fast response speed
- The red light next to the scroll wheel flashes when charging and goes out when fully charged

Note: The battery level is related to personal usage habits in actual use of the mouse
