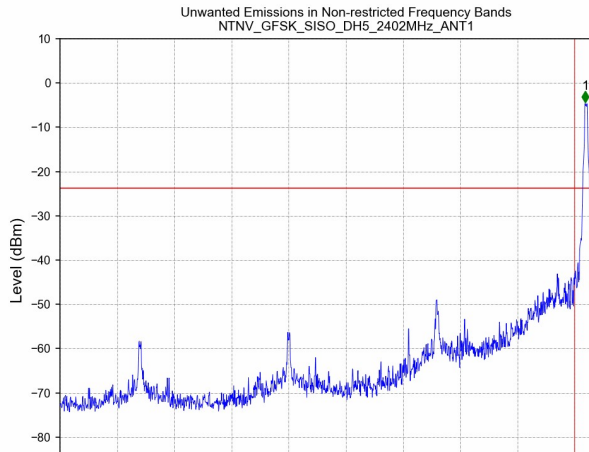

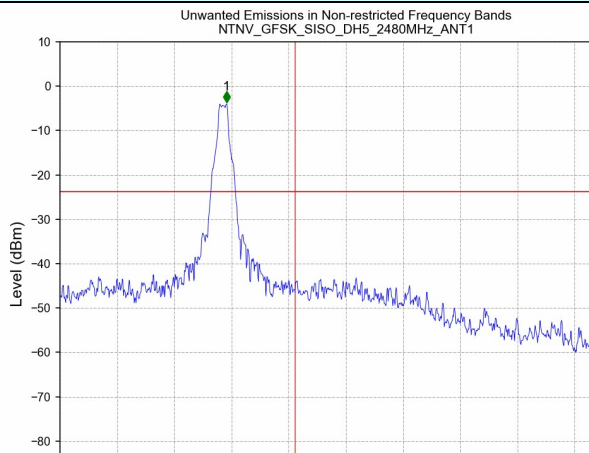


No-hopping mode

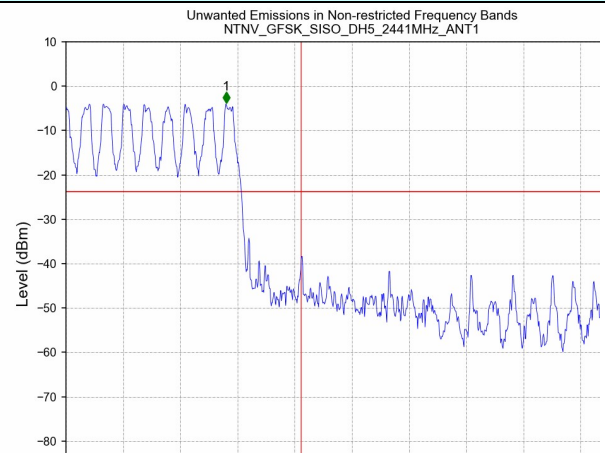


Hopping mode
