



## MeepMeep Pilot (MEEP01) User Guide

### Quickstart Guide

1. Grab a disc you can't live without. Using the included alcohol wipe, clean the center of the disc.
2. Activate your tracker by pulling the tab from the battery.
3. Download the free MeepMeep app from the Apple App Store or Google Play Store.
4. Follow the in-app prompts to pair your tracker.
5. Peel the adhesive backing and carefully place it on the center of the disc.
6. Press down **firmly** around the entire adhesive donut.

For best results, allow adhesive to bond to the disc for **24 - 72** hours before use.

While the MeepMeep Pilot is water resistant when properly attached to a disc, we can not guarantee performance after long exposure to water. Never expose the electronics to moisture before bonding with a disc. Repeated impact can damage MeepMeep's electronic components or durability of the protective case. These products contain batteries and are not for use in extremely hot or cold environments.

This product is only designed for use with CR2016 batteries. Do not replace the battery with incorrect types, and dispose of all batteries appropriately. Never ingest batteries as it can lead to severe harm. An unattached MeepMeep Pilot, and the CR2016 batteries the MeepMeep Pilots use, are choking hazards. Please keep out of reach of young children.

### MeepMeep Refund Policy

MeepMeep will refund or replace unused units that arrive defective within one year of purchase. As disc golf is a high-impact sport, we do not guarantee refunds or replacements on devices that have experienced physical damage.
