

## 5 Technical Requirements Specification

### 5.1 RF Exposure Evaluation

#### 5.1.1 Limit & Test Method

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}] \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

- $f(\text{GHz})$  is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>
- The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.2 Conclusion

The Max Conducted Peak Output Power is  $-2.97$  dBm on the highest channel  $2.402$  GHz  
 $-2.97$  dBm logarithmic terms convert to numeric result is nearly  $0.50$  mW

According to the formula. calculate the test exclusion thresholds:

$$\frac{[(\text{max. power of channel, including tune-up tolerance, mW}) / (\text{min. test separation distance, mm})] \cdot [\sqrt{f(\text{GHz})}]$$

General RF Exposure =  $(0.50 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.402 \text{ GHz}} = 0.156$  (1)

SAR requirement:

$S = 3.0$  (2)

$(1) < (2)$

So the SAR report is not required.
