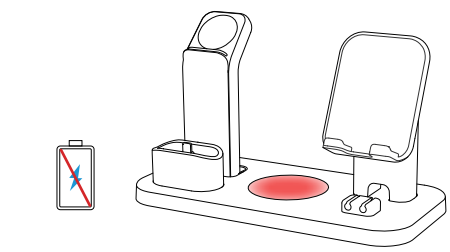


Reasons why the device doesn't work

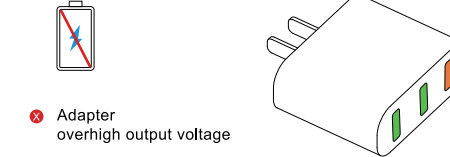
1. Covered by something (metal object)
