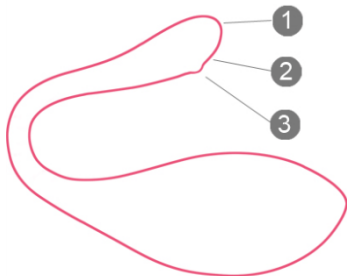

## Charging

Turn off the device before charging. The cable can be plugged into any USB port or USB/AC power adapter to start charging. It will take approximately 1.5 hours to fully charge.

Push the pin firmly, but slowly into the charging port. Stop pushing when you see the indicator light glow.

The Indicator light will stay on while charging. Once it fully charged the solid red light turn off. If you're unsure whether it's fully charged, you can view the battery indicator in the app.

## **Reminder**

Under no circumstances should you use Yami anally. We take no responsibility if used anally. Yami is not designed for anal use. It does not have a flared base and may be hard to remove when inserted anally. Not only is it dangerous, but anal use voids the warranty. If you are interested in an anal toy, you are recommended to shop for our anal plug products.

## **Warning**

DO NOT boil in water (the battery may explode or water could leak into the toy).

Keep away from extreme heat or cold.

Make sure your toy is recharged at least once every six months.

DO NOT use the toy while charging.

## Cleaning & Care

Clean your device before and after each use.

Clean with warm water and a mild soap (or a sex toy cleaner).

Dry thoroughly before storing.

## Lubricant

To avoid issues, **only use water-based lube**. DO NOT use silicone or oil-based lubricants.

Before insertion, generously apply lube to the product and yourself.

Water based lube may dry out, so you may need to reapply.

## FAQs

1. Toys cannot be searched in Enjox Remote app.

Please add and search for toys directly in Enjox Remote app. DO NOT search for toys and pairing in the Bluetooth settings of your phone.

2. Automatic disconnection after connecting the toy.

Please close the Enjox Remote app and reopen it.

3. Long-term unused, unable to turn on the power.

You need to charge it. We recommend charging at least every 6 months.
