




# Instructions



- **ON/OFF Key** -- long press for 1.5 second to turn on/off, then click the key to start vibrating and frequency conversion
- **Vibration Key** -- Click to turn on clitoral vibration, then click to toggle frequency
- A total of 10 frequencies

# Charging Instructions

Please use the provided charging cable for charging. Using a charger with mismatched parameters may affect the battery life or cause damage to the product.



- When the product is charging, the product of indicator light flashes. When it is fully charged, the indicator light is always on.
- This product has built-in current protection. When charging, the product automatically enters the protection state and the product is unavailable. When fully charged, the product will automatically resume use.

# Cleaning Instructions



- The surface of the product is soft and smooth, made of medical-safe silicone, **100% waterproof**, and can be washed directly in water.
- Please keep the product clean after using, do not use corrosive cleaners for cleaning.
